### Local Government Capital Projects Loan Program

#### *Application Notice*

The Department of Community and Economic Development (DCED) announces the opening of the application period of funding for the Local Government Capital Projects Loan Program for State Fiscal Year 1996-97. Loan applications will be accepted at the Center for Local Government Services, Room 325 Forum Building, Harrisburg, PA 17120. Applications must be received on or before 4:30 p.m., December 13, 1996. No applications will be accepted after that time.

The purpose of the program is to provide low interest loans to municipalities with populations of 12,000 or less for the purchase of equipment and the purchase, construction, renovation or rehabilitation of municipal facilities. The program is intended to give small local governments, who find the cost of borrowing at conventional rates to be prohibitive, an opportunity to secure needed funds at an interest rate of 2.0% per annum. Repayment will be made over a period not to exceed 10 years or the useful life of the equipment or facilities, whichever is less.

Authority for the Local Government Capital Projects Loan Program is provided in Act 210 of 1990, the Local Government Capital Projects Loan Fund Act.

#### APPLICATIONS

The following parties have applied for an NPDES permit to discharge controlled wastewaters into the surface waters of this Commonwealth. Unless otherwise indicated on the basis of preliminary review and application of lawful standards and regulations the Department of Environmental Protection proposes to issue a permit to discharge, subject to certain effluent limitations and special conditions. These proposed determinations are tentative.

Where indicated, the EPA, Region III, Regional Administrator has waived the right to review or object to this proposed permit action under the waiver provision 40 CFR 123.6E.

Persons wishing to comment on the proposed permit are invited to submit a statement to the Field Office indicated as the office responsible, within 30 days from the date of this public notice. Comments received within this 30-day period will be considered in the formulation of the final determinations regarding this application. Responses should include the name, address and telephone number of the writer and a concise statement to inform the Field Office of the exact basis of a comment and the relevant facts upon which it is based. A public hearing may be held if the Field Office considers the public response significant.

Following the 30-day comment period, the Water Management Program Managers will make a final determination regarding the proposed permit. Notice of this determination will be published in the *Pennsylvania Bulletin* at which time this determination may be appealed to the Environmental Hearing Board.

The application and related documents, proposed effluent limitations and special conditions, comments received and other information are on file and may be inspected and arrangements made for copying at the Field Office indicated above the application.

S. § 6020.506).

#### 1. Site Location and Description

The site is located approximately 1,000 feet southwest of Victory Church Road and approximately 4,000 feet south of the intersection of Route 322 and Victory Church Road in Cranberry Township, Venango County, Pennsylvania. The site may be located on the United States Geological Survey Kennerdell 7.5 minute topographic map at 41° 21' 20" north latitude and 79° 46' 03" west longitude.

The site covers approximately 23 acres and includes a landfill formerly operated by A. C. Laing and Michael Laing, d/b/a Laing Demolition Contractors. The landfill covers approximately 4 acres within the site.

Also within the site are four areas with abandoned drums, an open-ended storage shed, an above ground petroleum storage tank, an abandoned trailer, an abandoned one-story house/office, and small areas containing municipal and demolition wastes. Surface water drains off the landfill into the Allegheny River approximately 4,000 feet southwest of the site.

The site property was purchased by Alex Campbell (A. C.) Laing and Patricia L. Laing in 1975. From April 14, 1975 to April 16, 1987, A. C. Laing, and his son, Michael Laing, doing business as "Laing Demolition Contractors," operated the landfill at the site under Department Solid Waste Permit No. 101000. On April 16, 1987, the Department issued an Order that suspended Solid Waste Permit #101000.

On May 18, 1987, a Department inspection of the landfill showed that 20 to 25 drums were located near the open-ended storage shed, and a total of 40 or more drums were located throughout the site. The Department requested that A. C. Laing identify the contents of the drums, in writing, to the Department, and provide a cleanup plan for the contaminated soil in the drum area near the entrance gate. A. C. Laing did not comply with the request.

After the Department's adoption on April 9, 1988, of new regulations pertaining to construction/demolition waste landfills, the Department sent numerous Notices of Violation to Laing Demolition Contractors to properly close the landfill. The landfill was never properly closed. A. C. Laing died on February 27, 1988, without a will, Patricia L. Laing died earlier. The site property is currently owned by the estate of A. C. Laing. On February 1, 1996, the Department filed a court order in the Venango County, Pennsylvania Recorder of Deeds Office noting the presence of hazardous substances at the site.

#### 2. Release and Threat of Release of Hazardous Substances

On August 26, 1992, Tetra Tech, Inc. conducted a Screening Site Inspection (SSI) of the site for the United States Environmental Protection Agency (EPA). Photographs in the SSI document show drums present at the site. The SSI document also noted that the site was heavily vegetated. Tetra Tech, Inc. sampled soil, surface water, sediment and home wells, but did not sample the drums.

The analysis of the soil samples from an area of puddled product near drums at the entrance gate, showed that the soil was contaminated with polychlorinated biphenyls (PCBs), toluene, xylenes, polynuclear aromatic hydrocarbons (PAHs) and pesticides. Another soil sample from the drum area near the open-ended storage shed showed that the soil was contaminated with benzo(a)pyrene, pesticides, PAHs and zinc. The chemicals listed above are "hazardous substances" as defined under section 103 of HSCA (35 P. S. § 6020.103).

On October 20, 1995, Department inspectors observed trespassers using the site for hunting. Direct contact with drum contents and contaminated soil is the greatest threat to trespassers. Also, the drums and containers present at the site are unsecured and improperly stored, and have the potential for a further release into the environment if vandalized.

On July 1, 1996, the Department analyzed the contents of the drums at the site and installed monitoring wells at the site. The drums contained hazardous wastes based on the ignitability of the contents and the leachable lead in the drum contents.

### 3. *Alternative Responses Considered*

The two main objectives of the prompt interim response action proposed for the site are: 1) to protect the public and environmental receptors from direct contact with site-related hazardous substances, and 2) to eliminate the ongoing release and threat of release of hazardous substances into the environment from containerized waste and contaminated soil at the site.

The Department considered four alternatives to the prompt interim response action at the site to meet those objectives:

- 1) No Action
- 2) Fence
- 3) Drum Removal
- 4) Drum and Soil Removal

In light of the objectives stated above, the Department evaluated each alternative to determine: the extent to which each alternative protects the public and the environment; the extent to which each alternative complies with or otherwise addresses the Land Recycling and Environmental Remediation Standards Act, the Solid Waste Management Act, the Clean Streams Law and other Applicable or Relevant and Appropriate Requirements (ARARs); the extent to which each alternative is feasible, effective, implementable and permanent; and the relative cost effectiveness of each alternative.

#### Alternative 1. No Action

A "No Action" alternative provides a baseline for comparison to other alternatives. Because no action would be implemented, any present or future risks to human health, safety or the environment would remain unchanged. No costs would be incurred under this response.

#### Alternative 2. Fence

This alternative would involve the installation of a fence around the drum areas to restrict access to containerized waste and contaminated soil at the site. The capital, operation and maintenance, and total present worth costs of this alternative would be \$49,674, \$77,720 and \$127,394, respectively.

#### Alternative 3. Drum Removal

This alternative would involve all the components of Alternative 2, above, and the testing, and if necessary, removal and offsite disposal of all containers with hazardous substances. Following waste removal, any empty containers will be crushed and consolidated for offsite disposal or recycle/reuse. The capital, operation and maintenance, and total present worth costs of this alternative are \$284,456, \$77,720 and \$362,176, respectively.

#### Alternative 4. Drum and Soil Removal

With the exception of the fence, this alternative would involve all of the components of Alternative 3, above, plus the testing, and if necessary, the removal and offsite disposal of contaminated soil from the drum areas. Because the site is located in a residential area, soil contaminated with hazardous substances above the Department's Statewide Health Standards for Soils (residential) would be removed. The capital, operation and maintenance, and total present worth costs of this alternative are \$294,105, \$0 and \$294,105, respectively.

### 4. *Comparison of Alternatives*

The Department believes that prompt action is necessary to protect the public health, safety and the environment from the risks associated with the containerized wastes abandoned at the site, the hazardous substances in site soil, and any hazardous substances that may have been disposed at the landfill. As noted in the facts, the notice of hazardous substances is already in the deed records. Action should not be delayed for the length of time that it would take to formally develop and close an administrative record for the action. The Department estimates that prompt action will cost less than \$2 million and take less than 1 year to complete. Accordingly, the Department proposes to conduct a prompt interim response action at the site under section 505(b) of HSCA (35 P. S. § 6020.505(b)).

Alternative 1 would be the least costly response alternative, but would provide no increased protection for the public and the environment. Alternative 2 would be less costly than Alternatives 3 or 4. Alternative 2 would reduce risks to the public by preventing direct contact with containerized waste and contaminated soil. However, Alternative 2 would not protect the environment and would not be cost effective over the long-term because the release and threat of release of hazardous substances would still exist at the site, those releases may exacerbate the problems associated with site contamination, and those releases may have to be addressed in the future.

Alternative 4 would be less costly than Alternative 3 because Alternative 3 includes the cost for a fence and fence replacement after 15 years. Although it is the most costly alternative, Alternative 3 would provide less protection to the public and the environment than Alternative 4, because Alternative 3 would allow more hazardous substances to remain onsite (for example, in contaminated area soils).

Alternative 4 would be the most cost-effective alternative over both the short and long-term, because it would protect the public and the environment from direct contact with hazardous substances in the containers and

contaminated soil at the site, and because it would eliminate the release and threat of release of hazardous substances into the environment from the containers of waste and contaminated soil.

#### 5. *Proposed Remedy*

Under section 505(b) of HSCA (35 P. S. § 6020.505(b)), the Department proposes to implement Alternative 4 as the prompt interim response at the site. Alternative 4 is proposed because it would, in the most cost effective manner, protect the public and the environment from direct contact with site-related hazardous substances and eliminate the release and threat of release of hazardous substances into the environment from the containers of wastes and contaminated soil.

Although Alternative 4 offers some protection to the public and the environment, it would not be a final remedial response under section 504 of HSCA. Therefore, Alternative 4 is not required to meet the ARARs that apply to final remedial responses. Nonetheless, Alternative 4 is consistent with any future remedial actions that would be expected to be undertaken based on site conditions. Alternative 4 addresses the identified ongoing threats to the public and the environment that require attention prior to the start of any potential future remedial action.

In addition to the prompt interim response action, the Department has installed monitoring wells and will be sampling groundwater to determine if hazardous substances are being released from the landfill to groundwater and surface water. Additional response action may be needed to achieve a complete, permanent and final cleanup for the site. The proposed prompt interim response protects the public health and environment; complies with or otherwise meets all ARARs relating to containerized waste and contaminated soil removal and disposal, but not ARARs relating to landfill closure; is feasible, implementable, permanent and effective to the maximum extent practicable; and is cost effective.

#### 6. *Public Access to The Administrative Record*

An Administrative Record, which contains more detailed information regarding the site, is available for public inspection. The Administrative Record can be examined from 8 a.m. to 4 p.m. at the Department's Northwest Regional Office at 230 Chestnut Street, Meadville, PA 16335. The public will have an opportunity to present oral comments regarding the proposed prompt interim response if the Department receives a request for a public hearing. If no person requests a public hearing, the hearing will not be held. **General Permit No. WMGR038.** Waste tire processing and/or beneficial use. The Department of Environmental Protection, Bureau of Land Recycling and Waste Management, has authorized, under General Permit No. WMGR038, processing and/or beneficial use of waste tires and/or tire-derived material. This is a Statewide general permit.

Under the terms and conditions of the general permit, persons who are approved to process and/or beneficially use waste tires and/or tire derived material will be required to meet, at a minimum, the following: compliance with The Clean Streams Law, compliance with the Solid Waste Management Act, conform with local safety and nuisance control requirements, conformance with isolation distances, maintain records and submit routine operation reports.

The Department is authorized under the Solid Waste Management Act (35 P. S. §§ 6018.101—6018.1003), and section 287.611 of the residual waste management regulations to issue general permits for any category of beneficial use or processing that results in beneficial use of residual waste on a regional or Statewide basis when the Department determines that such use does not harm or present a threat of harm to the health, safety or welfare of the public or the environment and the activity can be adequately regulated using standard conditions.

The Department has determined the following: waste whole tires and/or tire derived material (TDM); (1) can be used as fuel for cement production, steel production, power generation and other industrial operations; and (2) as feedstock for the production of crumb rubber which, in turn, may be used in such products as new tires, molded rubber products, carpets, flooring, "astroturf" underlay, extruded products, automotive brakes, asphalt modifier for roads and athletic surfaces, moisture retainer for turf development, railroad grade crossings and footwear; and the processing and beneficial use can be adequately regulated using general conditions.

Tire retreading operations will, in effect, be exempt as a "grandfathering" exclusion, provided the storage provisions outlined in these general permit conditions are not violated:

Persons requesting approval to operate under the terms of this general permit will be required to obtain a "Determination of Applicability" from the appropriate Regional Office for each site where tires and/or tire derived materials will be processed or beneficially used. The following minimum information will be required in order to obtain a Determination of Applicability.

- a. Name and address of the applicant.

b. Name and location of the generator of the tires and/or tire derived material being processed or beneficially used.

c. Number and title of the general permit.

d. A detailed site plan.

e. A detailed description of the operation.

f. Proof that the proposed processing and/or beneficial use is consistent with the general permit.

g. A signed statement accepting all conditions of the general permit.

h. Proof of municipal notification.

i. Proof of identification of interests.

j. Compliance history information.

k. An application fee designated by the Department.

l. Proof of right of applicant to enter property and perform activities.

m. A copy of the facilities PPC Plan.

n. An irrevocable written consent from the landowner giving the Department permission to enter the facility.

o. Evidence of comprehensive liability insurance in effect.

p. A written estimate of the maximum number of whole tires and shredded tires onsite for the next 12 months of operation and a copy of the bonding worksheets.

Comments may be used by the Bureau to assist in its investigation of the variance request. Comments will be accepted for 30 days following the publication of this notice. Section 702 of The Bituminous Coal Mine Act (52 P. S. §§ 701—702) provides a mechanism for operators to obtain variances from specific requirements of the act to accommodate the adoption of new machinery, equipment, tools, supplies, methods or processes.

Section 242(c) of The Bituminous Coal Mine Act requires that where belt conveyors are installed, main stoppings and regulators shall be so arranged as to reduce the quantity of air traveling in the belt conveyor entry to a minimum for effective ventilation and to provide an intake air split as an escapeway from the face area to the main air current.

Summary of the request: CONSOL Pennsylvania Coal Company requests permission to use a three entry gate road system for development of all future longwall panels at the Bailey Mine. The three entry system's ventilation plan calls for a belt entry with an intake air split traveling outby (away from the face).

### Voluntary Environmental Compliance Audit Policy

The Department of Environmental Protection (DEP) is announcing a final policy to encourage companies, local governments and individuals to find and fix environmental problems by conducting environmental compliance audits and other self-assessments under a Comprehensive Management System.

Under the policy, a company, local government or individual conducting an environmental compliance audit or other systematic self-assessment and taking action to promptly correct violations uncovered by the self-assessment would be entitled to a waiver from fines and penalties, if they disclose those violations to DEP. The Department previously published a notice in the *Pennsylvania Bulletin* on February 10, 1996 requesting comments on the proposed policy.

The policy would not apply to intentional violations or when significant environmental harm occurs or for repeat violations.

An environmental audit is a comprehensive, systematic, documented evaluation of whether a facility or company

meets environmental laws and regulations. It includes not only an evaluation, but regular reporting requirements and schedules for correcting problem areas uncovered by the audit. The policy also provides that DEP can approve procedures for use by small businesses to help assure continuous compliance.

The policy will also encourage the establishment of compliance management systems including those meeting the ISO 14000 environmental standards.

### Water Quality Certification Under Section 401 of the Federal Clean Water Act; Categorical Waiver from the Permit Requirements of the Dam Safety and Encroachments Act

The Department of Environmental Protection proposes to certify that certain abandoned mine reclamation activities conducted under the authority of the Surface Mining Control and Reclamation Act of 1977 et seq., which may result in a discharge of dredge or fill material into waters of the Commonwealth, and which comply with the following conditions, will meet the requirements of section 401 of the Federal Clean Water Act (CWA) (33 U.S.C.A. § 1341), and these restoration plans qualify for a waiver of permit requirements set forth at 25 Pa. Code § 105.12(a)(16), Dam Safety and Waterway Management rules and regulations under the Dam Safety and Encroachments Act (DSEA) (32 P. S. §§ 693.1—693.27).

Section 401(a) of the CWA (33 U.S.C.A. § 1341(a)), requires that any applicant for a Federal license or permit, which may result in a discharge to waters of the United States, must provide the licensing or permitting agency with a certification from the state in which the discharge will originate verifying that the discharge resulting from the construction or operation of the project will comply with sections 301—303, 306 and 307 of the CWA (33 U.S.C.A. §§ 1311—1313, 1316 and 1317) including applicable State water quality requirements. Section 7(a) of the DSEA (32 P. S. § 693.7) provides for the waiver of permit requirements by regulation, for any category of dam, water obstruction or encroachment which is determined to have an insignificant effect upon the safety and protection of life, health, property and the environment. The regulations, identifying which structures and activities are waived from the permit requirements of the DSEA, are set forth at 25 Pa. Code § 105.12(a).

The Division of Wetlands Protection has reviewed the environmental assessment procedure under the requirements of the National Environmental Policy Act of 1969 (NEPA), as required for restoration projects under Title 4

of the Surface Mining Control and Reclamation Act of 1977 et seq. and finds that procedure to be consistent with the environmental assessment requirements of 25 Pa. Code § 105.15. The procedure includes an environmental assessment of the following factors, which are also found in Chapter 105:

- State and Federal Threatened and Endangered Species
- Public Water Supply
- Water Quality Standards
- Scenic Rivers
- Wetlands
- Recreational Resource Value
- Historic and Cultural Resources
- Fish and Wildlife Resources
- Topography

This assessment process, along with the existing United States Fish and Wildlife Service Project Coordination Requirements required by Section 7 Consultation of the Endangered Species Act, provides an adequate measure of regulatory oversight without necessitating additional permit application and review actions. The Department therefore proposes to categorically waive under the provisions of section 105.12(a)(16), water obstruction and encroachment activities approved under Title 4 of the Surface Mining Control and Reclamation Act of 1977 et. seq. and which meet the following environmental parameters:

(a) The site contains less than 0.05 acre of vegetated wetlands as defined in the 1987 U. S. Army Corps of Engineers Wetland Delineation Manual, or

(b) the body of water or associated discharge from a body of water\* has a pH <5.0 or any one of the following elevated total metal levels:

- Aluminum >0.6 mg/l
- Iron >7.0 mg/l
- Manganese >4.0 mg/l

\*Body of water is defined as any natural or artificial lake, pond, reservoir, swamp, marsh or wetland.

Prior to commencing any activity set forth at 25 Pa. Code § 105.12(a)(16), the applicant must obtain all other necessary permits or approvals from the Department of Environmental Protection, including but not limited to those required by The Clean Streams Law (35 P. S. §§ 691.1—691.1001), the Dam Safety and Encroachments Act (32 P. S. §§ 693.1—693.27), the Solid Waste Management Act (35 P. S. §§ 6018.101—6018.1003), the Hazardous Sites Cleanup Act (35 P. S. §§ 6020.101—6020.1305) and the regulations promulgated thereunder including 25 Pa. Code chapters 91, 92, 93, 96, 102, 105 and 260—299.

For activities which impact wetlands, all delineations shall be conducted in accordance with Pennsylvania's procedures for wetland delineation. (The present procedure is published at 25 Pa. Code § 105.451.) On February 3, 1996, the Department adopted the Corps of Engineers Wetland Delineation Manual (Technical Report Y-87-1, 1987 Manual) with 6 March 1992 guidance as the methodology for delineating wetlands.

The exceptions to this waiver are those activities which require the construction, operation and maintenance of jurisdictional dams or projects located in floodways. Dams with drainage areas of greater than 100 acres, storage capacities of greater than 50 acre-feet, or with a maxi-

mum depth of water greater than 15 feet as measured by the upstream toe of the dam, require Dam Permits from the Department (see section 105.3). If the proposed project is located within a floodway, a separate individual permit may need to be secured from the Regional Soils and Waterways Section. Unless otherwise specified, the boundary of the floodway is as indicated on maps and flood insurance studies provided by FEMA. In an area where no FEMA maps or studies have defined the boundary of the 100-year frequency floodway, it is assumed, absent evidence to the contrary, that the floodway extends from the stream to 50 feet from the top of the bank of the stream.

The Department retains the discretion, on a case-by-case basis, to deny or revoke certification under section 401(a) of the CWA for structures and activities listed in 25 Pa. Code § 105.12(16) if the Department finds upon investigation or complaint, that a particular project is violating, or will violate section 401(a) of the CWA or State water quality requirements.

Projects which do not meet the above provisions will be individually reviewed by the Department for consideration of waiver applicability or necessary permit action. Activities not qualifying for this proposed categorical waiver will be processed through the normal public notice process required for 401 Water Quality Certification or Chapter 105 permit applications, whichever is appropriate. This proposed procedure and action are the result of a cooperative effort among Department of Environmental Protection, U. S. Army Corps of Engineers, U. S. Fish and Wildlife Service, Fish and Boat Commission, Game Commission, U. S. Office of Surface Mining, and U. S. Environmental Protection Agency.

The Department seeks comments on this proposed action. Comments must be submitted within 30 days from the date of this notice to Fran Koch, Division of Wetlands Protection, Bureau of Dams, Waterways and Wetlands, P. O. Box 8554, Harrisburg, PA 17105-8554, (717) 787-6827. Persons with a disability may use the AT&T Relay Service by calling (800) 654-5984 (TDD users) or (800) 654-5788 (voice users). Comments must be submitted in writing and contain the name, address and telephone number of the person commenting and a concise statement of comments, objections or suggestions on this proposal. No comments submitted by facsimile transmission will be accepted. The Department will consider all relevant and timely comments received.

Comments may be submitted electronically to the Department at RegComments@A1.dep.state.pa.us. A subject heading of the proposal must be included in each transmission. Comments submitted electronically must also be received by the Department within 30 days of the publication of this proposed statement of policy.

This proposal has been submitted to the U. S. Army Corps of Engineers for consideration and approval under the PASPGP-1 permit processing procedure. In conjunction with this notice, the Corps of Engineers has also placed this proposal on public notice under the requirements of the Clean Water Act.

## ENVIRONMENTAL HEARING BOARD

Coudersport Borough v. DEP; EHB Doc. No. 96-111-C

### Order

*And Now*, this 20th day of September, 1996, upon receipt of the Department of Environmental Protection's letter of September 17, 1996, informing the Board that the parties have agreed to settlement of the above appeal, and with the expectation that the Notice of Settlement

will be published in accordance with the requirements of 25 Pa. Code § 1021.120, it is ordered that:

1. The settlement is approved by the Board.
2. The above appeal is dismissed, subject to reinstatement if it should turn out that an appeal of the settlement has been timely filed in accordance with the provisions of 25 Pa. Code § 1021.120(b).

The Department of Environmental Protection (Department) and Coudersport Borough (Coudersport) have agreed to a settlement of the above matter. Coudersport operates a water system that has approximately 1,037 service connections in Coudersport, Potter County, Pennsylvania. Currently four water sources serve the community, specifically, North Spring, North Well, East Spring and East Well. On May 16, 1994, the Department sent a letter to Coudersport advising Coudersport that its sources had to be evaluated to determine if any of its sources were under the direct influence of surface water. On April 26, 1996, the Department sent a letter to Coudersport stating that based on the testing that was performed, the Department determined that East Spring and North Spring were determined to be influenced by surface water. On May 23, 1996, Coudersport timely appealed the April 26, 1996 letter.

The Department and Coudersport have agreed to a settlement, the major provisions of which include:

1. Coudersport can continue to use North Spring, and will perform 6 months of testing from April, 1997, through October, 1997, to again evaluate whether the spring is under the direct influence of surface water. If the results are substantially similar or better as those that were previously obtained that led to the issuance of the April 26, 1996 letter, then the Department will take no further action and impose no requirements upon Coudersport. If the results show a worsening or degradation in the water quality, then the Department may take such action as it deems appropriate.

*By the Commission:*

Tristate Household Goods Tariff Conference, Inc., (Tristate) a tariff publishing agency, representing almost 275 PUC certificated first proviso household goods carriers is petitioning this Commission to continue to implement a 2% fuel surcharge as a result of the sudden and continued escalation of fuel costs still being experienced by its members in the moving industry.

The 2% fuel surcharge approved by the Commission at SP 28200 expired on September 11, 1996; however, in light of the volatile situation in Iraq, Tristate avers the stability of fuel prices is uncertain and diesel fuel costs have not declined since June of 1996. Therefore, Tristate is petitioning the Commission to approve the 2% fuel related surcharge, in order to recoup increased fuel costs for an additional 90 days, until fuel prices stabilize and fuel cost increases can be filed under the regular rate increase procedure.

Tristate has compiled data from its members indicating that fuel prices in Pennsylvania have increased an average 15% per gallon, since June 1, 1996. The average cost at the pump in Pennsylvania is \$1.257 per gallon as of September 3, 1996. Further, the average cost of fuel to total line-haul revenue ranges from 7% to 12%; however, Tristate is only seeking permission to temporarily assess a 2% fuel related surcharge on its line-haul charges.

On interstate shipments of first proviso household goods, in use, the American Movers Conference/Household Goods Carriers' Bureau sought and received approval by the Department of Transportation to levy a 2% fuel surcharge that became effective May 7, 1996, with an expiration date of May 7, 1997.

In order to prevent financial hardships, it is imperative that these household goods carriers be afforded an opportunity to adjust rates to offset unanticipated fuel expenditures; *Therefore, It Is Ordered That:*

1. Tristate member household good carriers rendering service under authority of this Commission may establish a 2% fuel surcharge on 1 day's notice under Special Permission No. 28201, and shall be published in accordance with all other tariff rules of this Commission.

2. Upon determination by the Commission that the price of fuel has stabilized, thereby allowing Tristate carriers to seek rate relief through normal filing procedures, the Commission will issue an order to eliminate the 2% fuel surcharge.

3. The surcharge be effective for a 30-day period with carriers being permitted to file for two additional 30-day extension periods if conditions warrant it.

3. Upon approval by this Commission the Secretary shall duly certify this order and deposit same with the Legislative Reference Bureau for publication in the *Pennsylvania Bulletin*.
