Maximum Lawful Rate of Interest for Residential Mortgages for the Month of April 1997

The Department of Banking, under the authority contained in section 301 of the act of January 30, 1974 (P. L. 13, No. 6) (41 P. S. § 301), hereby determines that the maximum lawful rate of interest for residential mortgages for the month of April is 9 1/4%.

The interest rate limitations under the State's usury statute were preempted to a great extent by Federal law, the Depository Institutions Deregulation and Monetary Control Act of 1980 (Pub. L. 96-221). Further preemption was instituted with the signing of Pub. L. 96-399, which overrode State interest rate limitations on any individual who finances the sale or exchange of residential real property which such individual owns and which such individual occupies or has occupied as a principal residence.

Each month the Department of Banking is required by State law to compute and announce the ceiling rate on residential mortgages in Pennsylvania. This maximum rate is determined by adding 2.50 percentage points to the yield rate on long-term government bonds as published by the Federal Reserve Board and/or the U. S. Treasury. The latest yield rate on long-term government securities is 6.76 to which was added 2.50 percentage points for a total of 9.26 that by law is rounded off to the nearest quarter at 9 1/4%.

DISCHARGE OF CONTROLLED INDUSTRIAL WASTE AND SEWERAGE WASTEWATER

(Part I Permits)

The following parties have applied for an NPDES permit to discharge controlled wastewaters into the surface waters of this Commonwealth. Unless otherwise indicated on the basis of preliminary review and application of lawful standards and regulations the Department of Environmental Protection proposes to issue a permit to discharge, subject to certain effluent limitations and special conditions. These proposed determinations are tentative.

Where indicated, the EPA, Region III, Regional Administrator has waived the right to review or object to this proposed permit action under the waiver provision 40 CFR 123.6E.

Persons wishing to comment on the proposed permit are invited to submit a statement to the Field Office indicated as the office responsible, within 30 days from the date of this public notice. Comments received within this 30-day period will be considered in the formulation of the final determinations regarding this application. Responses should include the name, address and telephone number of the writer and a concise statement to inform the Field Office of the exact basis of a comment and the relevant facts upon which it is based. A public hearing may be held if the Field Office considers the public response significant.

Following the 30-day comment period, the Water Management Program Managers will make a final determination regarding the proposed permit. Notice of this determination will be published in the *Pennsylvania Bulletin* at which time this determination may be appealed to the Environmental Hearing Board.

The application and related documents, proposed effluent limitations and special conditions, comments received and other information are on file and may be inspected and arrangements made for copying at the Field Office indicated above the application.

PA 0027430. Sewage, **City of Jeannette Municipal Authority**, P. O. Box 168, Jeannette, PA 15644.

This amendment is of the NPDES permit to discharge treated sewage from the Jeannette Wastewater Treatment Plant in the City of Jeannette, **Westmoreland County**; subsequent to the issuance of the NPDES renewal permit on June 27, 1996, the Authority performed a chemical translator evaluation for lead. The results of that study are the basis for this amendment.

The following effluent limitations change is proposed for discharge to the receiving waters, known as Brush Creek, which are classified as a trout stocked fishery with existing and/or potential uses for aquatic life, water supply and recreation. The first downstream potable water supply intake from this facility is the Pennsylvania American Water Company Becks Run intake.

Proposed Development and Review Process: Guidelines will be developed internally by Department staff with input from the Department's Regional and Field Operation staff. Draft Title: Guidance for Road Project Right-of-Way Soil and Groundwater Screening Analyses with Alternatives for Testing. Changes to Spousal Notification Policies and Guidelines under Section 8(a) of the Ryan White CARE Reauthorization Act of 1996

Section 8(a) of the 1996 Federal Ryan White CARE Reauthorization Act (P. L. 104—146), requires that states, in order to receive funding under the act, take "administrative or legislative action to require that a good faith effort be made to notify a spouse of a known HIV-infected patient that such spouse may have been exposed to the human immunodeficiency virus and should seek testing." 42 U.S.C.A. § 300ff-27a(a). A spouse is defined by this law as, "any individual who is the marriage partner of an HIV-infected patient or who has been the marriage partner of that patient at any time within the 10-year period prior to diagnosis of HIV infection." 42 U.S.C.A. § 300ff-27a(b)(i). The Department of Health, Bureau of HIV/AIDS, has revised its existing partner notification policies and guidelines to comply with this new requirement. This policy revision will go into effect on April 1, 1997.
