DELAWARE RIVER BASIN COMMISSION

Notice of Commission Meeting and Public Hearing

The Delaware River Basin Commission will hold a public hearing on Wednesday, December 17, 1997. The hearing will be part of the Commission's regular business meeting which is open to the public and scheduled to begin at 1:30 p.m. in the Goddard Conference Room of the Commission's offices at 25 State Police Drive, West Trenton, NJ.

An informal conference among the Commissioners and staff will be held at 11 a.m. at the same location and will include discussion of proposed amendments to the Commission's Ground Water Protected Area Regulations for Southeastern Pennsylvania and response document distribution and the 1998 Commission meeting schedule.

In addition to the subjects listed which are scheduled for public hearing at the business meeting, the Commission will also address the following: Minutes of the November 19, 1997 business meeting; announcements; General Counsel's Report; report on Basin hydrologic conditions; a resolution to adopt the current expense and capital budgets for Fiscal Year 1999; a resolution to adopt a Commission vision and mission statement entitled Charting the Future and public dialogue.

The subjects of the hearing will be as follows:

Applications for Approval of the Following Projects Under Article 10.3, Article 11 and/or Section 3.8 of the Compact:

1. *Mount Holly Water Company D-95-46 CP.* An application for approval of a ground water withdrawal project to supply up to 88.7 million gallons (mg)/30 days of water to the applicant's Mansfield Water Supply Facility from new Well Nos. 1, 2, 3 and 4, and to limit the withdrawal from all Mansfield and Mount Holly water systems wells to 184 mg/30 days. The project is located in Mansfield Township, Burlington County, NJ.

2. *New Jersey Turnpike Authority D-96-55 CP.* An application for approval of a ground water withdrawal project to supply up to 3.6 mg/30 days of water to the applicant's Service Area 1N from new Well No. 1N-3, and to limit the existing withdrawal from all wells to 3.6 mg/30 days. The project is located in Oldmans Township, Salem County, NJ.

3. *Perkasie Borough Authority D-97-12 CP.* An application for approval of a ground water withdrawal project to supply up to 21.6 mg/30 days of water to the applicant's distribution system from new Well No. 12, and to retain the existing withdrawal limit from all wells of 34.2 mg/30 days. The project is located in East Rockhill Township and Perkasie Borough, Bucks County, in the Southeastern Pennsylvania Ground Water Protected Area.

4. *Horsham Water Authority D-97-16 CP.* An application for approval of a ground water withdrawal project to supply up to 14.4 mg/30 days of water to the applicant's distribution system from new Well No. 40, and to retain

the existing withdrawal limit from all wells of 83.36 mg/30 days. The project is located in Horsham Township, Montgomery County, in the Southeastern Pennsylvania Ground Water Protected Area.

5. *Milford Township Water Authority D-97-24 CP.* An application for approval of a ground water withdrawal project to supply up to 3.46 mg/30 days of water to the applicant's distribution system from new Well No. 2, and to increase the existing withdrawal limit from all wells from 5.58 mg/30 days to 9.04 mg/30 days. The project is located in Milford Township, Bucks County, in the Southeastern Pennsylvania Ground Water Protected Area.

6. *Superior Water Company D-97-26 CP.* An application to replace the withdrawal of ground water from Well No. 3 in the applicant's water supply system which has become an unreliable source of supply. The applicant requests that the withdrawal from replacement Well No. 10 be limited to 3.88 mg/30 days, and that the total withdrawal from all wells remain limited to 15 mg/30 days. The project is located in Douglass and New Hanover Townships, Montgomery County, in the Southeastern Pennsylvania Ground Water Protected Area.

7. *Borough of Delaware Water Gap D-97-32 CP.* An application for approval of a ground water withdrawal project to supply up to 9.15 mg/30 days of water to the applicant's distribution system from new Well Nos. 6 and 7, and to limit the withdrawal from all wells to 15 mg/30 days. The project is located in Delaware Water Gap Borough, Monroe County, PA.

8. *Borough of Quakertown D-97-36 CP.* An application to replace the withdrawal of water from Well No. 15 in the applicant's water supply system which has become an unreliable source of supply, with new Well No. 15A. The applicant requests that the total withdrawal from all wells remain limited to 51.1 mg/30 days. The project is located in the Borough of Quakertown, Bucks County, in the Southeastern Pennsylvania Ground Water Protected Area.

9. *Moyer Packing Company D-97-44.* An application for approval of a ground water withdrawal project to supply up to 3.0 mg/30 days of water to the applicant's beef processing facility from new Well Nos. 7 and 8, and to increase the existing withdrawal limit from all wells from 6.4 mg/30 days to 11.5 mg/30 days. The project is located in Franconia Township, Montgomery County, in the Southeastern Pennsylvania Ground Water Protected Area.

Proposed Use of Supplemental Disaster Recovery Funds Awarded to the Commonwealth by the United States Department of Housing and Urban Development to Assist in the Recovery from Hurricane Fran

The United States Department of Housing and Urban Development (HUD) has allocated funds, under its Disaster Recovery Initiative, to assist the Commonwealth of Pennsylvania to recover from damages caused by Hurricane Fran. Funds allocated are \$650,000 to Montgomery County (Abington Township) and \$287,000 to the Commonwealth for use in areas affected by Hurricane Fran.

In order to receive its allocation of \$287,000 the Commonwealth is required to follow its established citizen participation process, publish its proposed use of funds, provide citizens with the opportunity to comment

on the proposed use of funds, submit an Action Plan to HUD, describe how the funds will be administered in compliance with various laws and regulations and make certifications that it will comply with these laws and regulations and other requirements established by HUD.

After surveying various counties for damages caused by Hurricane Fran, the Department of Community and Economic Development (DCED) determined that the most severe damage to homes and infrastructure occurred in Abington Township, Montgomery County. It has also been determined that the \$650,000 HUD supplemental allocation for Montgomery County, in combination with local funds being committed to disaster recovery, falls substantially short of the funding necessary to provide relief to property owners who were affected by Hurricane Fran. Therefore, DCED proposes to commit its entire allocation of \$287,000 to Abington Township to assist in recovery efforts.

Since Montgomery County (Abington Township) has already developed an Action Plan for Disaster Recovery, DCED proposes to adopt this Action Plan as the Commonwealth's Plan for its \$287,000 allocation. This proposed use of funds is intended to give citizens and local government officials an opportunity to make known their thoughts and comments. All comments must be received in DCED by close of business (5 p.m.) Friday, December 26, 1997.

The following parties have applied for an NPDES permit to discharge controlled wastewaters into the surface waters of this Commonwealth. Unless otherwise indicated on the basis of preliminary review and application of lawful standard and regulations, the Department of Environmental Protection proposes to issue a permit to discharge, subject to certain effluent limitations and special conditions. These proposed determinations are tentative.

Where indicated, the EPA, Region III, Regional Administrator has waived the right to review or object to this proposed permit action under the waiver provision 40 CFR 123.6E.

Persons wishing to comment on the proposed permit are invited to submit a statement to the office noted above the application within 30 days from the date of this public notice. Comments received within this 30-day comment period will be considered in the formulation of the final determinations regarding this application. Responses should include the

name, address and telephone number of the writer and a concise statement to inform the Department of the exact basis of a comment and the relevant facts upon which it is based. A public hearing may be held if the responsible office considers the public response significant.

Following the 30-day comment period, the Water Management Program Manager will make a final determination regarding the proposed permit. Notice of this determination will be published in the *Pennsylvania Bulletin* at which time this determination may be appealed to the Environmental Hearing Board.

Preamble 2

Acknowledgment of Notices of Intent to Remediate submitted under the Land Recycling and Environmental Remediation Standards Act (35 P. S. §§ 6026.101—6026.908).

Sections 304 and 305 of the Land Recycling and Environmental Remediation Standards Act (act) require the Department of Environmental Protection (Department) to publish in the *Pennsylvania Bulletin* an acknowledgment noting receipt of any Notices of Intent to Remediate. An acknowledgment of the receipt of a Notice of Intent to Remediate is used to identify a site where a person proposes to, or has been required to, respond to a release of a regulated substance at a site. Persons intending to use a site-specific standard or who intend to remediate a site in a Special Industrial Area must file a Notice of Intent to Remediate with the Department. A Notice of Intent to Remediate filed with the Department provides a brief description of the location of the site, a list of known contaminants at the site, the proposed remediation measures for the site and a description of the intended future use of the site. A person who demonstrates attainment of one or a combination of the cleanup standards identified under the act will be relieved of further liability for the remediation of the site for any contamination identified in reports submitted to and approved by the Department and shall not be subject to citizen suits or other contribution actions brought by responsible persons not participating in the remediation.

Under sections 304(n)(1)(ii) and 305(c)(2) of the act, there is a 30-day public and municipal comment period for sites proposed for remediation using a site-specific cleanup standard, in whole or in part, and for sites determined to be located in Special Industrial Areas. This period begins when a summary of the Notice of Intent to Remediate is published in a newspaper of general circulation in the area by the person conducting remediation. For the sites identified, a municipality may request to be involved in the development of the remediation and reuse plans for the site if the request is made within 30 days of the date specified below. During this comment period, a municipality may request that the person identified, as the remediator of a site, develop and implement a public involvement plan. Requests to be involved, and comments, should be directed to the remediator of a site. For further information concerning the content of a Notice of

Intent to Remediate, contact the Department's Regional Office under which the notice appears. If information concerning this acknowledgment is required in an alternative form, contact the community relations coordinator at the appropriate regional office listed. The Department has completed our review of the proposed Amendments to the Act 537 Studies of both Blooming Grove Township and Dingman Township. The Amendments pertain to the portion of the Hemlock Farms Development wherein the lots are located in both municipalities. The Amendments indicate that jurisdiction over the sewage systems reside with the municipality which issued the permit for the system and where the lot is taxed. The identical Amendments, which are effective at the same time for both Townships, were transmitted to the Department via Dingman Township's August 13, 1997 letter.

The Department has found that our comments have been satisfactorily addressed and hereby approves the proposed Amendments. The approval date, for both Townships Amendments to their Act 537 Sewage Facilities Plans, is November 21, 1997.

The Department's review of the sewage facilities update revision has not identified any significant environmental impacts resulting from this proposal. The Department of Environmental Protection (Department), under the authority of the Hazardous Sites Cleanup Act (HSCA) (35 P. S. §§ 6020.101—6020.1305), has entered into multiple consent order and agreements for de minimis settlements with 66 parties regarding the Department's costs incurred for conducting response activities at the Quality Container Corporation (QCC) site. The QCC site is a parcel of land of approximately 1.25 acres located in the City of Philadelphia, Philadelphia County, at the intersection of Collins Street and E. Ontario Street. The surrounding area is zoned commercial and residential.

QCC operated a drum reconditioning facility from 1977 through June 1990. QCC stopped operations in July of 1990 and subsequently abandoned the site leaving roll-off containers, drums and wastes generated by facility operations. In addition, process equipment on the site was not cleaned of wastes at the time the facility was abandoned. The roll-off containers, drums, process equipment and abandoned wastes were not contained and were accessible to the public.

Because of the threat to human health and the environment posed by the QCC site, the site was deemed as a HSCA site on August 12, 1994 under section 502 of HSCA (35 P. S. § 6020.502). The Department subsequently implemented and completed an interim response from March 20, 1995 through February 8, 1996 to address the release or threat of release of hazardous substances. To date, the Department has incurred response costs of approximately \$1.8 million related to the release or threat of release of hazardous substances.

During the implementation of the interim response, the Department seized QCC records located in an office trailer at the site. The QCC records contained documentation regarding potentially responsible parties that were identified by the Department. Based on a review of the QCC records, the Department has determined that 94 potentially responsible parties are de minimis parties, and offered to enter into consent order and agreements with those parties for de minimis settlements under section 122(g) of CERCLA, 42 U.S.C. § 9622(g), and

section 707 of HSCA (35 P. S. § 6020.707). The Department previously published notice of settlements with 66 de minimis parties on September 27, 1997.

The Department has entered into consent order and agreements for de minimis settlements with the following two additional de minimis parties: Bronstein Container Company, Inc. (\$12,573.60) and Edward E. Goldberg & Sons (\$324.00).

Under the proposed consent order and agreements for de minimis settlements that are subject to this notice the Department will receive a total of \$12,897.60. The total response costs recovered from all de minimis settlements to date is \$227,280.68.

This notice is provided under section 1113 of HSCA (35 P. S. § 6020.1113). The proposed consent order and agreements are subject to final approval by the Department following the receipt and review of any comments submitted by the public. The proposed consent order and agreements that contain the specific terms of the settlements are available for public review and comment. Rate of Oil Company Franchise Tax for 1998

The Secretary of Revenue announces that for the calendar year 1998 there is no increase in the current rate of the oil company franchise tax which is determined to be 13.9¢ per gallon on all liquid fuels and 18.8¢ per gallon on all fuels used or sold and delivered by distributors within this Commonwealth under 75 Pa.C.S. §§ 9002 and 9004(b), definition of "cents per gallon equivalent basis."

The rate of the oil company franchise tax imposed under Chapter 95 (Taxes for Highway Maintenance and Construction) of the Vehicle Code, 75 Pa.C.S. § 9502, and collected under Chapter 90 (Liquid Fuels and Fuels Tax), 75 Pa.C.S. § 9004(b), is determined annually by the Department of Revenue (Department) and announced by each December 15 for the following calendar year. The tax rate is determined on a "cents per gallon equivalent basis," which is defined by 75 Pa.C.S. § 9002 as:

The average wholesale price per gallon multiplied by the decimal equivalent of any tax imposed by section 9502 (relating to imposition of tax), the product of which is rounded to the next highest tenth of a cent per gallon. The rate of tax shall be determined by the Department of Revenue on an annual basis beginning every January 1 and shall be published as a notice in the *Pennsylvania Bulletin* no later than the preceding December 15. In the event of a change in the rate of tax imposed by section 9502, the Department shall redetermine the rate of tax as of the effective date of such change and give notice as soon as possible.

"Average wholesale price" as used above is defined as:

The average wholesale price per gallon of all taxable liquid fuels and fuels, excluding the Federal excise tax and all liquid fuels taxes, as determined by the Department of Revenue for the 12-month period ending on the September 30 immediately prior to January 1 of the year

for which the rate is to be set. In no case shall the average wholesale price be less than 90¢ nor more than \$1.25 per gallon.

For the 12-month period ending September 30, 1997 the Department has determined that the average wholesale price of liquid fuels and fuels was less than 90¢ per gallon; accordingly, an average wholesale price of 90¢ per gallon is used to determine the rate for 1998.

Rate of Tax on Aviation Gasoline for 1998; Rate of Tax on Jet Fuels for 1998

Under 74 Pa.C.S. § 6121(b), the Secretary of Revenue announces that for the calendar year 1998 the rate of tax on aviation gasoline and all other liquid fuels used or sold and delivered by distributors within this Commonwealth for use as fuel in propeller-driven piston engine aircraft or aircraft engines will decrease from the current rate of 3-7/10¢ to 3-5/10¢* per gallon or fractional part thereof.

Under 74 Pa.C.S. § 6131(b), the Secretary of Revenue announces that for the calendar year 1998 the rate of tax on jet fuels used or sold and delivered by distributors within this Commonwealth for use as fuel in turbine-propeller jet, turbojet and jet-driven aircraft and aircraft engines will decrease from the current rate of 1-9/10¢ to 1-7/10¢ per gallon or fractional part thereof.

The rate of tax on aviation gasoline is adjusted annually beginning on January 1, 1985 and each January 1 thereafter. The rate of tax on jet fuels is adjusted annually beginning on January 1, 1986 and each January

1 thereafter. Under 74 Pa.C.S. § 6121(b) and § 6131(b) the rate of each tax increases or decreases 1/10 of a cent per gallon for each 10% increase or decrease in the producer price index for jet fuel as determined by the United States Department of Labor, Bureau of Labor Statistics, for the most recent 12-month period available as of November 1, subject to a maximum rate of 6¢ per gallon for aviation gasoline and 2¢ per gallon for jet fuels. On November 1, 1997, the most recently available 12-month period was September 1996 to September 1997, as reported in Bureau of Labor Statistics, United States Department of Labor, Producer Price Indexes, September 1997, for which the percentage change was -20.0%. Accordingly, the aviation gasoline tax rate and the jet fuel tax rate both decrease by 2/10 of a cent per gallon.
