State Grant Funds for a Family Literacy Program, Act 143 of 1986 for Program Year 1998-99

Act 143 of 1986, as approved by the General Assembly of the Commonwealth of Pennsylvania and signed into law on October 22, 1986, established the Pennsylvania Adult Literacy Education Grant Program. A portion of the appropriation has been set aside for family literacy defined in the act as: "An educational program designed to provide literacy training for adults, educational services for children and activities for parents and children together, at the same or at different sites."

The purpose of the Pennsylvania Family Literacy Program is to break the cycle of poverty and illiteracy through an intergenerational instructional program, to improve the educational opportunities for children and adults by integrating early childhood and adult education for parents into a unified family program, and to implement collaborative relationships that build on existing community resources creating a new range of services. The program shall also assist children and adults to meet challenging education performance standards.

The Secretary shall consider, but not be limited to, the following factors when evaluating proposals for adult literacy instruction programs:

- 1) Percentage of eligible adults expected to be enrolled for instruction who are receiving either State or Federal public assistance, or who are unemployed workers or displaced homemakers.
- 2) Percentage of eligible adults in any local area who do not have certificates of graduation from a secondary school and who are not currently enrolled in adult literacy education programs.
- 3) Percentage of eligible adults expected to be enrolled who are members of minority groups.
- 4) Percentage of eligible adults with less than a fifth grade reading level to be served.

Eligible applicants include literacy councils, libraries, local education agencies, community colleges, and public and private nonprofit agencies, organizations and institutions. Priority consideration will be given to applications that will conduct programs that expect to enroll high numbers of eligible adults who are receiving public assistance; do not have high school diplomas; are members of minority groups; and/or have less than a 5th grade reading level. Priority also will be given to programs that provide client outreach and referral activities that are coordinated with other adult education literacy programs and early childhood education programs, county assist-

ance offices, social service agencies, offices of employment security, Job Training Partnership Act (JTPA) programs, and other community groups or agencies that provide services and assistance to persons in need of basic literacy skills.

Program applicants are required to collaborate with other local educational agencies and community-based organizations. Applicants should seek organizations with demonstrated and documented quality in providing adult literacy, early childhood education or parenting education building on existing community services and not duplicating services available in the community. Potential partners include adult education agencies, Head Start, Family Centers, and/or school district based K-4 programs. Given the limited size of the grant and the large number of other local, State and Federal programs focused on adult literacy or early childhood education, it is critical that applicants use these funds as the link to provide a comprehensive family literacy program created from among these various sources of support. The Program requires that applicants coordinate with some organizations for service delivery and collaborate with others for program planning. Working together with other agencies and building community partnerships is essential to the program's success. Interagency relationships may develop along a continuum of restructuring and redefining philosophies, roles and expectations.

Grant awards will range from \$60,000 to \$80,000 for a unit of family literacy. Each unit must serve a minimum of 20 families in the required four components for family literacy programs. Adult services of up to 25 hours per week must be made available in order to meet welfare to work requirements for welfare recipients that are in compliance with local welfare-to-work requirements.

Application due dates: Act 143 State Family Literacy Program Grant awards: July 17, 1998.

The following parties have applied for an NPDES permit to discharge controlled wastewaters into the surface waters of this Commonwealth. Unless otherwise indicated on the basis of preliminary review and application of lawful standards and regulations the Department of Environmental Protection (Department) proposes to issue a permit to discharge, subject to certain effluent limitations and special conditions. These proposed determinations are tentative.

Where indicated, the EPA, Region III, Regional Administrator has waived his right to review or object to this proposed permit action under the waiver provision 40 CFR Section 123.6E.

Persons wishing to comment on the proposed permit are invited to submit a statement to the Field Office indicated as the office responsible, within 30 days from the date of this public notice. Comments received within this 30-day period will be considered in the formulation of the final determinations regarding this application. Responses should include the name, address and telephone number of the writer and a concise statement to inform the Field Office of the exact basis of a comment and the relevant facts upon which it is based. A public hearing may be held if the Field Office considers the public response significant.

Following the 30-day comment period, the Water Management Program Managers will make a final determination regarding the proposed permit. Notice of this determination will be published in the *Pennsylvania Bulletin* at which time this determination may be appealed to the Environmental Hearing Board.

The application and related documents, proposed effluent limitations and special conditions, comments received and other information are on file and may be inspected and arrangements made for copying at the Field Office indicated above the application.

The Department reviewed the Reasonably Available Control Technology (RACT) plans and Emission Reduction Credits (ERC) application and made a preliminary determination to approve these plans and amendments to the State Implementation Plan (SIP) for the listed facilities.

The proposed SIP revisions do not adopt any new regulations. They incorporate the provisions and requirements contained in the RACT approval for these facilities to comply with current regulations.

The preliminary RACT determinations, if finally approved, will be incorporated into Plan Approvals and/or Operating Permits for the facilities and will be submitted to the United States Environmental Protection Agency (EPA) as revisions to Pennsylvania's State Implementation Plan.

The hearing is for the Department to take testimony concerning Reasonably Available Control Technology (RACT) for the Consolidated Natural Gas Transmission Corporation's (CNGT) South Bend Compressor Station in South Bend Township, Armstrong County.

The purpose of the hearing is to issue a RACT Operating Permit for Air Quality Plan **Approval No. 03-000-180**.

CNGT has complied with RACT requirements by retrofitting six Clark HLA-8 internal combustion engines driving natural gas compressors with lean emission combustion technology. Oxides of Nitrogen (NO_x) emissions from these engines have been reduced to 3 g/bhp-hr at full load/full speed conditions.

CNGT has retarded the ignition timing by four degrees relative to standard timing on an Ingersoll Rand JVG-6 internal combustion engine used for moving natural gas through the facility's dehydration system. In addition, an operating limit of 500 hours per year has been accepted for the company's Caterpillar G3512 internal combustion engine which is used for auxiliary electric power generation. These actions satisfy the presumptive RACT requirements pursuant to 25 Pa. Code § 129.93 for these engines.

This one acre wetland restoration in Subbasin 11, (the Upper Juanita River watershed), is an integral part of a Conservation Reserve Program plan. The restoration will include blocking an existing field drain that was originally installed to divert water off the site, and the construction of a small berm to retain water. The project is located in West Township, Huntingdon County. (Franklinville, PA Quadrangle, N: 1.1 inches, W: 0.4 inch)

Project No. O20C10-001—The objectives of the 3.9 acre wetland restoration sponsored by Ron Layton in Subbasin 20, the Ohio River watershed, are to provide wildlife habitat and improve water quality in the Conoquenessing Creek by intercepting, filtering, and cleansing runoff from adjacent cultivated areas. The project is located on the Layton farm in West Township, Butler County. (Evans City, PA Quadrangle, N: 9.4 inches, W: 7.0 inches)

Project No. O16A25-001—The primary objective of the wetland restoration sponsored by Jack Pfadt is to restore 2.9 acres of prior converted cropland in Subbasin 16, the Upper Allegheny River watershed. The wetland will provide habitat for waterfowl and act as a buffer to the West Branch French Creek by trapping nutrients and sediment thereby improving water quality. The project is located on the Pfadt farm in Venango Township, Erie County. (Wattsburg, PA Quadrangle, N: 8.4 inches, W: 4.0 inches)

Project No. 16C53-001—The objective of the restoration of 5 acres of riparian floodplain depression sponsored by John Wiley farm in Subbasin 16, the Upper Allegheny River watershed, is to improve water quality in the Oswayo Creek by trapping nutrients and sediment. Addi-

Proposed Monitoring Plan Revisions; Notice of Availability

The Department of Environmental Protection, Bureau of Air Quality, is proposing to revise its ambient air pollution monitoring system and is seeking comments on this proposal.

The Environmental Protection Agency (EPA) has established new standards for fine particles (under 2.5 microns in size). States will need to measure the amount of fine particles to which their citizens are exposed. The Department of Environmental Protection (Department) is proposing to install new PM_{2.5} monitors to fulfill this need. The Department has also taken this opportunity to review the Commonwealth's entire air quality monitoring program in order to propose necessary changes that will make the program more effective. The current monitoring program exceeds minimum EPA requirements, consistently measures levels for many pollutants well below Federal health based standards, and measures for total suspended particulate (TSP) for which a Federal standard no longer exists. The Department is proposing to restructure the program to measure the pollutants most likely to violate the National Ambient Air Quality Standards (NAAQS).

Suspension of Implementation of a Certain Provision of the Coal Refuse Disposal Control Act

On April 22, 1998, the Office of Surface Mining Reclamation and Enforcement (OSM), Department of Interior published in the *Federal Register* its findings regarding a program amendment to Pennsylvania's permanent mining regulatory program submitted by the Pennsylvania De-

partment of Environmental Protection. By the act of December 7, 1994 (P.L. 792, No. 114), the General Assembly amended Pennsylvania's Coal Refuse Disposal Control Act (CRDCA). These amendments were submitted to OSM for approval as an amendment to Pennsylvania's permanent regulatory program for coal mining.

The CRDCA prohibits the disposal of coal refuse within 100 feet of the bank of a stream. However, it authorizes the Department to grant a variance to allow disposal of coal refuse within this buffer zone if the operator demonstrates to the Department that there will be "no significant adverse hydrologic or water quality impacts."

In approving the program amendment, the Secretary of the United States Department of the Interior found that the word "significant" in section 6.1(h)(5) of the CRDCA, as it pertains to granting of variances to the 100-foot stream buffer zone, was inconsistent with Federal law.

Section 15.1 of the Coal Refuse Disposal Control Act provides, in pertinent part:

"In order to maintain primary jurisdiction over surface coal mining in Pennsylvania, the department shall suspend implementation of any provision of this act found to be inconsistent with Federal law by the Secretary of the United States Department of the Interior under section 505 of the Surface Mining Control and Reclamation Act of 1977 (Public Law 95-87, 30 U.S.C. § 1201 et seq.) or the Administrator of the Environmental Protection Agency under section 402 of the Federal Water Pollution Control Act (62 Stat. 1155, 33 U.S.C. § 1251 et seq.)."

52 P. S. § 30.65a.

Consequently, on May 19, 1998, and in accordance with section 15.1 of the Coal Refuse Disposal Control Act (52 P. S. § 30.65a), the Department suspended implementation of the word "significant" found in section 6.1(h)(5) of the Coal Refuse Disposal Control Act.

Cigarette Tax

Under section 227-A of the Fiscal Code (72 P. S. § 227-A) (relating to administration powers and duties), the Department of Revenue (Department) announces the lowest cost of the stamping agent, wholesaler and retailer, respectively, effective upon publication of this notice, as follows:

	<i>Premium Brands</i>	<i>Generic Brands</i>

Cost of the Stamping Agent (for sales to wholesalers)	\$17.44	\$14.74
Cost of the Wholesaler (for sales to retailers)	\$18.14	\$15.33

The Department considers these costs as presumptive minimum costs. Cigarette stamping agents, wholesalers and retailers are prohibited from selling cigarettes at a price lower than their respective presumptive minimum costs. These costs are listed on a per carton basis, ten packs of cigarettes per carton, 20 cigarettes per pack. To determine the presumptive minimum price per pack of cigarettes, one should divide the costs listed above by ten and round to the nearest hundredth of a percent. For example, the presumptive minimum price of a pack of cigarettes sold by a retailer to a consumer is \$1.93 for premium brands (\$19.23/10), \$1.63 for generic brands (\$16.25/10).

Cigarette dealers who either sell cigarettes under a different packaging setup (that is, eight packs per carton) or sell cigarettes that do not qualify as premium or generic brands (that is, subgeneric, foreign or specialty cigarettes) as described above are prohibited from selling cigarettes at a price lower than the cost of the stamping agent, cost of the wholesaler or cost of the retailer, respectively, as further defined and explained in 61 Pa. Code Part I, Subpart B, Article III (relating to cigarette and beverage taxes).

Cigarette dealers wishing to prove a cost different from the Department's presumptive costs stated above must follow the procedures listed in 61 Pa. Code Chapter 76 (relating to unfair sales of cigarettes).

FISH AND BOAT COMMISSION

Consideration of Change to Special Regulation Designation Kettle Creek, Potter County

At its April 1998 meeting, the Fish and Boat Commission (Commission) approved guidelines with regard to encouraging public participation on possible changes to the designation of stream sections for special regulation programs. Under 58 Pa. Code Chapter 65, the Commission designates certain streams and stream sections as being subject to special trout fishing regulations. These designations are effective after Commission approval when they are posted at the site and a notice is published in the *Pennsylvania Bulletin*. Under the new guidelines, a notice concerning the proposed designation or redesignation of a stream section under special regulations ordinarily will be published in the *Pennsylvania Bulletin* before the matter is reviewed by the Commissioners.

A Commissioner has asked the staff to publish a notice and solicit public input on his concept for a possible change to special regulations on a 1.7 mile section of Kettle Creek, Potter County. Accordingly, notice is hereby given that the Fish and Boat Commission, acting under 58 Pa. Code Ch. 65, may consider the deletion of a section of Kettle Creek from 500 ft. downstream of SR0144 upstream a distance of 1.7 miles from the list of Delayed Harvest Artificial Lures Only areas designated under 58 Pa. Code § 65.6. Instead, the Commission may be asked to consider placing this section under Delayed Harvest Fly Fishing Only Regulations, (58 Pa. Code § 65.2).

This section of Kettle Creek is located on Commission property. At the July 1970 Commission meeting, the Commission voted to acquire the Thompson tract along Kettle Creek. This is the property surrounding the special regulations area. During the May 1971 Commission meeting, the Commission voted to approve a special regulation area on Kettle Creek along the entire 1.7 mile distance of the newly acquired Thompson tract. Under the so-called "fish-for-fun program," this water was stocked several times throughout the spring and summer. Regulations provided for year-round angling and the harvest of one trout per day, 20 inches in length or longer. Gear was restricted to flies only and fishing hours extended from 1 hour before sunrise to 1 hour after sunset. This regulatory option was discontinued prior to the 1981 season in favor of more resource-based program options.

Starting in 1981, this section was managed under the, then, fly-fishing-only option of the catch-and-release program. The catch-and-release program as we know it today (barbless hook, artificial lures only) went into effect for the 1984 season. At that time (1984) three of the former catch-and-release (FFO waters) were moved into the no-harvest, FFO program (Spring, Kettle, and Little Lehigh Creeks). Because it was made an exception in 1984, Kettle Creek regulations were essentially unchanged: barbless fly-fishing-only, season open year around with no harvest permitted. During the period from 1981 until 1988, this area was managed as a Class A wild trout fishery with no stocking as inventory information recorded a brown trout biomass of 84.45 kg/ha in 1981.

Biomass steadily declined from 51.77 kg/ha in 1982 to a low of 16.64 kg/ha in 1984. The 1984 estimate was conducted during the summer that followed the February 1984 St. Valentine's Day flood. Subsequent inventories

conducted during 1985 and 1986 recorded biomass Class B wild brown trout populations lower than the levels that had been observed prior to flooding. Mediocre habitat, combined with an unstable environment (flood, drought and elevated summer water temperatures) were limiting factors constraining the wild trout populations.

Management recommendations in 1987 were to propose regulation changes to artificial lures only and to stock this section as a "Class B" catch-and-release area. Therefore, from 1988 through 1997, this stream section was managed as a stocked biomass Class B water under the catch-and-release program (at the time, one of only three stocked Class B catch-and-release areas in the state). Catch-and-release regulations provided for year-round angling with no harvest. Tackle was restricted to the use of barbless flies and artificial lures only. Since 1988, fishing with artificial lures and spinning gear has been permitted on this section of Kettle Creek.

Recent inventories (1994 and 1997) confirmed that this section no longer supports the biomass Class B wild brown trout densities that were recorded during the mid-1980s. Therefore, if the provision of a recreational sport fishery is desired under special regulations, stocking is necessary and management under the Delayed Harvest, Artificial Lures Only program was deemed the most appropriate regulatory option for this biomass Class C fishery. The Commission voted to change this section to a delayed-harvest, artificial lures only area (58 Pa. Code § 65.5) starting in January 1998. This decision was confirmed after considering input from a public meeting at the site and publication of a notice inviting public input. The Commission staff continue to believe that delayed-harvest artificial lures only regulations are appropriate for this stream section in accordance with the trout management plan and resource-based regulatory options.

Delayed Harvest Artificial Lures Only regulations provide for a limited harvest period from June 15 through Labor Day and an elongated no harvest period from the day after Labor Day until the following June 15. During the harvest period, an elevated minimum length limit (9 inches) and reduced creel limit (3 trout/day) is applied to ensure that emphasis remains on recreation rather than harvest. Fishing hours extend from 1 hour before sunrise to 1 hour after sunset and tackle is restricted to the use of artificial lures only (which includes the use of flies and streamers). Under this option multiple stockings occur as this section is stocked twice during the spring and once in October to provide additional catch-and-release angling during the fall.

This stream section has been managed under an artificial lures only option (including flies and streamers) for the past 11 seasons. Few, if any, angler conflicts due to tackle have been reported. As part of the 1991 Trout Angler Telephone Survey, anglers were asked a series of questions pertaining to their attitudes and opinions of special regulations areas. When asked if all delayed harvest areas should permit spinners and artificial lures as well as flies, overall, 60.5% agreed with this concept and 33.2% disagreed.

Kettle Creek is a popular destination stream for fly fishers, and some anglers have contacted Commissioners to ask that the Commission consider changing the regulations on the delayed-harvest section to permit use of flies only. On the other hand, the Commission has received input from other anglers who generally oppose restricting trout waters to fly-fishing. There is a good deal of public interest in this subject, and, in response to a suggestion

from one of our Commissioners, we are seeking public input. Imposition of a fly-fishing only restriction on this stream section would change 11 seasons of past practice and would be contrary to the special trout fishing regulations on most other publicly-owned or controlled streams to which special restrictions apply. In recent years, the trend, consistent with resource-based considerations and research on hooking mortality, has been to expand fishing opportunities to include the use of artificial lures only.

The Fish and Boat Commission is soliciting public input concerning a possible designation that may be proposed to change a 1.7 mile section of Kettle Creek from delayed-harvest (artificial lures only) regulations to delayed-harvest (fly-fishing only) regulations. Persons with comments, objections or suggestions concerning the possible proposed change to the special regulations applicable to this stream section are invited to submit comments in writing to Executive Director, Pennsylvania Fish and Boat Commission, P. O. Box 67000, Harrisburg, PA 17106-7000 by no later than July 15, 1998.
