DCNR Recruits Applicants for Trails Board

The Department of Conservation and Natural Resources (Department) is accepting nominations through September 30, 1998, for three new appointments to the Pennsylvania Recreational Trails Advisory Board (PARTAB). The Board was created on October 29, 1992, in accordance with the provisions of the Transportation Equity Act for the 21st Century (TEA 21).

The Board consists of one member from each of the following nine recreational trail user organizations: Hiking; Cross-Country Skiing; Off-Highway Motorcycling; Snowmobiling; Horseback Riding; All-Terrain Vehicle Driving; Bicycling; Four-Wheel Driving and Water Trails. One member also represents physically challenged individuals.

The Board's main responsibilities include advising the Department on the use of Federal trails funding in this Commonwealth, reviewing and ranking trail project applications and presenting an annual report to the Secretary on the accomplishments of the preceding Federal fiscal year, including recommendations for changes.

Nominations for the three new appointees are to be made from individuals representing the following trail user organizations: Cross-Country Skiing, Four-Wheel Driving and Horseback Riding.

Nominations must be submitted to the Department by September 30, 1998. Appointments will be made by the

Secretary of the Department. Appointees will serve for 3 consecutive years.

The following parties have applied for an NPDES permit to discharge controlled wastewaters into the surface waters of this Commonwealth. Unless otherwise indicated, on the basis of preliminary review and application of lawful standards and regulations, the Department of Environmental Protection (Department) proposes to issue a permit to discharge, subject to certain effluent limitations and special conditions. These proposed determinations are tentative.

Where indicated, the EPA, Region III, Regional Administrator has waived the right to review or object to this proposed permit action under the waiver provision 40 CFR 123.6E.

Persons wishing to comment on the proposed permit are invited to submit a statement to the office noted above the application within 30 days from the date of this public notice. Comments received within this 30-day period will be considered in the formulation of the final determinations regarding this application. Responses should include the name, address and telephone number of the writer and a concise statement to inform the Department of the exact basis of a comment and the relevant facts upon which it is based. A public hearing may be held if the responsible office considers the public response significant.

Following the 30-day comment period, the Program Manager will make a final determination regarding the proposed permit. Notice of this determination will be published in the *Pennsylvania Bulletin* at which time this determination may be appealed to the Environmental Hearing Board.

The application and related documents, proposed effluent limitations and special conditions, comments received and other information are on file and may be inspected and arrangements made for copying at the office indicated above the application.

Comments should include the name, address and telephone number of the writer and a brief statement to inform the Field Office of the basis of the comment and the relevant facts upon which it is based. A public hearing may be held if the Field Office considers the public response significant.

Following the 30-day comment period, the Water Management Program Manager will make a final determination regarding the proposed permit action. Notice of this determination will be published in the *Pennsylvania Bulletin* at which time this determination may be appealed to the Environmental Hearing Board.

Proposed Revision to the State Implementation Plan for Volatile Organic Compounds (VOC); Approval of a Reasonably Available Control Technology Plan and Operating Permit; Public Hearing

Bedford County

The Department of Environmental Protection (Department) has made a preliminary determination to approve a revised Reasonably Available Control Technology (RACT) Plan and an amendment to the State Implementation Plan (SIP) for a recreational equipment production facility owned and operated by Hedstrom Corporation in Bedford Township, Bedford County.

The proposed SIP revision does not adopt any new regulations. It incorporates the provisions and requirements contained in RACT Operating Permit No. 05-02002A for the existing facility to comply with current regulations.

The preliminary RACT determination, if approved, will be incorporated into an Operating Permit for the facility and will be submitted to the United States Environmental Protection Agency (EPA) as a revision to Pennsylvania's SIP.

The sources at the recreational equipment production facility for which VOC RACT determinations are being made are the decorative coating line for rotocasting and the gym leg stencil operations. The preliminary VOC RACT determination for the decorative coating line for rotocasting is a limitation of VOCs in the coating along with an annual limit of total emissions. The preliminary VOC RACT determination for the gym leg stencil operation is utilizing improved work practice standard along with an annual limit of total emissions. Upon final approval of the company's case-by-case analysis, the operating permit will include conditions requiring recordkeeping and reporting of operational data to verify VOC emissions.

Camp Lohikan/Mount Tone, Buckingham Township, **Wayne County**. This commercial project proposes to correct existing malfunctioning onlot sewage disposal systems with a spray irrigation wastewater treatment facility consisting of an aerated lagoon and a 12.4 acre spray field. Peak wastewater flows will be 30,000 gpd.

Camp Lohikan contains 30 cabins with a capacity for 600 people. The operational season runs for the months of June, July and August. Wastewater flows for this particular facility are estimated at 1.5 million gallons per year. The Mount Tone ski area, located on the same 795 acre parcel, utilizes some of the identical facilities as the campground. The estimated wastewater flows from the ski operation are 600,000 gallons per year. In the interim between the camping and skiing seasons, the property is utilized on weekends with an estimated wastewater flow of 650,000 gallons per year. The total estimated wastewater flows for this project are 2.75 million gallons per year. Daily flows range from a peak of 30,000 gpd during the summer camping season to 400 gpd in the off-season.

The Department of Environmental Protection (Department), under the Hazardous Sites Cleanup Act (35 P. S. §§ 6020.101—6020.1304) (HSCA), initiated a Prompt Interim Response at the former FMC facility and the area immediately surrounding the facility. The FMC property is currently occupied by a retail lighting store known as Furlong Lamp and Lighting. The facility is located at 760 York Road (Route 263), Furlong, Doylestown Township, Bucks County.

As a result of previous investigations, which had shown significant, but localized, contamination of private water supply wells near FMC, as well as soil contamination on the FMC property, the Department's Hazardous Sites Cleanup Program, in April of 1997, began an investigation of the ground water in the area, in order to obtain relevant and current information on the status of the site. Several wells in the area surrounding the FMC property were sampled during this investigation, the results of which showed the continued localized presence of the plume mentioned above. The main contaminant of concern in the ground water is the common degreasing compound known as trichloroethylene (TCE).

This Prompt Interim Response Action consists of the installation and subsequent operation and maintenance of whole-house carbon filters on five impacted private residential and business water supply wells. The wells will be

monitored regularly, along with two other nearby private wells. The Department chose to conduct a prompt interim response because conditions relative to the impacted water supply wells created a reasonable basis to believe that prompt action was required to protect public health and safety under 25 Pa. Code § 3.21(b).

The Department determined that the prompt interim response chosen, under the authority of sections 501(a) and 505(b) of HSCA, was the alternative most protective of human health and the most cost effective. The Department considered two other alternatives. The first, no action, was considered and rejected because it would not address the threat to public health associated with the site. The second, extension of the existing public water line, was rejected, because the very localized nature of the contaminant plume and relatively small number of impacted wells, when taken in relation to the cost of extending the public water line over 2 miles, rendered this alternative as not cost effective at this time.

On June 18, 1997, the Independent Regulatory Review Commission (Commission) received this proposed regulation from the Insurance Department (Department). This rulemaking deletes 31 Pa. Code Chapter 41. The authority for this deletion is section 5(a)(9) of the act of November 15, 1972 (P. L. 1063, No. 271) (40 P. S. §§ 6501—6701); section 905 of the act of July 29, 1977 (P. L. 105, No. 38) (40 P. S. § 1141-905); section 701(a) of the Fraternal Benefit Societies Code (code) (40 P. S. § 1142-701(a) and sections 206 and 506 of The Administrative Code of 1929 (71 P. S. §§ 66 and 186). The proposed regulation was published in the *Pennsylvania Bulletin* on June 28, 1997, with a 30-day public comment period. The final-form regulation was submitted to the Commission on July 14, 1998.

This rulemaking will delete existing provisions for the waiver or extension of meetings of Fraternal Beneficial Societies that are obsolete. Instead, the Department applies current requirements that are more informal. Under section 106(b) of the code, relating to powers, every society shall have the power, inter alia, to adopt laws and rules for the governance of the society and the management of its affairs. This deletion will eliminate unnecessary regulations, thereby reducing the time fraternal benefit societies spend complying with obsolete provisions.

The final-form regulation contains no changes from the proposed version. The Commission did not file any comments on the proposed deletion. In addition, we did not receive any negative recommendations on the final-form regulation from the House Insurance Committee or the Senate Banking and Insurance Committee.

Therefore:

The Commission will notify the Legislative Reference Bureau that Regulation No. 11-153 from the Insurance Department, as submitted to the Commission on July 14, 1998, was deemed approved under section 5(g) of the Regulatory Review Act on August 4, 1998.

On August 12, 1997, the Independent Regulatory Review Commission (Commission) received this proposed regulation from the Environmental Quality Board (Board). It amends 25 Pa. Code Chapter 94 relating to the Municipal Wasteload Management Program (program). The authority for this rulemaking is The Clean Streams Law (35 P. S. §§ 691.1—691.1001) and section 1920-A of The Administrative Code of 1929 (71 P. S. § 510-20). The proposed regulation was published in the August 23, 1997 *Pennsylvania Bulletin*, with a 30-day public comment period. The final-form regulation was submitted to the Commission on July 1, 1998. On July 17, 1998, the Board requested the Commission toll consideration of this rulemaking in order to delete a new sentence added to § 94.15 at the final-form stage. The Commission did not object to the tolling request and the Board approved the revision on July 21, 1998. The revised final-form regulation was submitted to the Commission and the standing committees on July 21, 1998.

Chapter 94 is a pollution prevention program run by the Department of Environmental Protection (Department). The program is intended to prevent pollution by requiring appropriate management of hydraulic and organic wasteload flows from municipal treatment sewage facilities.

This rulemaking is a result of the Department's Regulatory Basics Initiative. The proposed amendments eliminate provisions that are unreasonable or obsolete. They also amend provisions that are more stringent than Federal rules without good reason. In addition, the Department anticipates that local governments with annual sewage report requirements will experience about a 50% reduction in those costs.

We have reviewed this regulation and find it to be in the public interest. The revisions will update the Chapter 94 program requirements and result in some cost savings for local governments.

Therefore, It Is Ordered That:

1. Regulation No. 7-322 from the Environmental Quality Board, as resubmitted to the Commission on July 21, 1998, is approved; and

2. The Commission will transmit a copy of this Order to the Legislative Reference Bureau.
