## DELAWARE RIVER BASIN COMMISSION

### Notice of Commission Meeting and Public Hearing

The Delaware River Basin Commission (Commission) will hold an informal conference followed by a public hearing on Wednesday, February 28, 2001. The hearing will be part of the Commission's regular business meeting. Both the conference session and business meeting are open to the public and will be held at the Commission offices at 25 State Police Drive, West Trenton, NJ.

The conference among the Commissioners and staff will begin at 10 a.m. Topics of discussion will include a progress report on the Commission's Comprehensive Plan; the status of a proposed rulemaking to amend the Comprehensive Plan with respect to water usage reporting requirements; issues relating to development of the PCB TMDL for the Delaware Estuary; a preliminary issues paper for the Flow Management Study; a proposal to institute project review upon retirement of entitlements; and creation of a Delaware Estuary Program office at the Commission. Summaries of the following meetings will be presented: the Toxics Advisory Committee meetings of January 11 and February 26 and the inaugural meeting of the Information Management Advisory Committee on February 1.

The subjects of the public hearing to be held during the 1:30 p.m. business meeting include the dockets listed as follows:

1. *SPS Technologies D-79-88 RENEWAL 3*. A ground water withdrawal renewal project to supply up to 8.7 million gallons (mg)/30 days of water to the applicant's manufacturing plant from existing Well No. 7 in the Upper Reach Frankford Creek watershed. No increase in allocation is proposed. The project is located in Abington Township, Montgomery County in the Southeastern Pennsylvania Ground Water Protected Area.

2. *Lawrenceville Water Company D-83-26 CP RENEWAL 2*. A ground water withdrawal renewal project to supply up to 21.7 mg/30 days of water to the applicant's public water distribution system from Wells Nos. 4, 5, 6 and 9 in the Stockton Formation. Commission approval on January 12, 1990, was limited to 10 years. The applicant requests that the total withdrawal from all wells remain limited to 21.7 mg/30 days. The project is located in Lawrence Township, Mercer County, NJ.

3. *Bristol Township D-90-98 CP*. A project to rerate the applicant's existing 2.25 million gallons per day (mgd) secondary level treatment Croydon Sewage Treatment Plant (STP) to 3.0 mgd and to revise the service area to allow Subdistricts 2, 3 and 4 and the Keystone Industrial Sewer District to convey their sewage directly to the Croydon STP, which currently serves Subdistrict 1. Treated effluent will continue to discharge to the Delaware River in Water Quality Zone 2. The Croydon STP is located on River Road near the Delaware River, approximately 1.3 miles upstream of the Neshaminy Creek confluence in Bristol Township, Bucks County, PA.

4. *Delaware State University D-99-76*. A ground water withdrawal project to supply up to 5 mg/30 days of water to the applicant's research facility from new North Well No. 2 and new South Well No. 1 located in the Cheswold

aquifer, and to limit the withdrawal from all wells to 5 mg/30 days. The project is located in the City of Dover, Kent County, DE.

5. *Warminster Township Municipal Authority D-2000-19 CP*. A ground water withdrawal project to supply up to 10.8 mg/30 days of water to the applicant's public water distribution system from new Well No. NATC-10 in the Stockton Formation, and to limit the withdrawal from all wells to 124.8 mg/30 days. The project is located in Warminster Township, Bucks County in the Southeastern Pennsylvania Ground Water Protected Area.

6. *East Marlborough Township D-2000-43 CP*. A project to expand the Wollaston Road 0.125 mgd STP and spray irrigation system to provide secondary treatment of 0.292 mgd. The proposed Unionville Regional STP will include the combined flows from the Baltimore Pike STP (0.15 mgd), the Wollaston Road wastewater treatment plant (0.125 mgd), and the Dolkeith Farms STP (0.015 mgd). The project is located just north of Street Road, approximately 1,500 feet west of Route 82, in East Marlborough Township, Chester County, Pennsylvania, in Water Quality Zone C-5 of the West Branch Red Clay Creek watershed. No surface water discharge is proposed and 0.15 mgd of the Baltimore Pike STP effluent that currently discharges to East Branch Red Clay Creek will be conveyed to the proposed regional plant for treatment and spray application.

7. *Borough of Quakertown D-2000-64 CP*. A project to replace the withdrawal of water from Wells Nos. 5 and 6 in the applicant's public water supply system that have become unreliable sources of supply. The applicant requests that the withdrawal from replacement Well No. 8 in the Brunswick Formation be limited to 9 mg/30 days, and that the total withdrawal from all wells remain limited to 51.1 mg/30 days. The project is located in the Tohickon Creek watershed in Quakertown Borough and Richland Township, Bucks County in the Southeastern Pennsylvania Ground Water Protected Area.

8. *Berks-Montgomery Municipal Authority D-2000-70 CP*. A project to rerate the applicant's existing 1.9 mgd tertiary level treatment Swamp Creek STP to treat a maximum monthly flow of 2.1 mgd; the annual average flow will remain 1.9 mgd. The plant is located 1/2 mile east of the intersection of Congo Road and Swamp Pike in Douglass Township, Montgomery County, Pennsylvania and will continue to serve the Boroughs of Bechtelsville and Boyertown and portions of Colebrookdale and Washington Townships in Berks County; and a portion of Douglass Township in Montgomery County. Treated effluent will continue to discharge to Swamp Creek in the Perkiomen Creek watershed.

In addition to the public hearing, the Commission will address the following at its 1:30 p.m. business meeting: minutes of the January 9, 2001, business meeting; announcements; report on hydrologic conditions in the basin; report by the Executive Director; public dialogue; and resolutions: 1) authorizing the Executive Director to issue a request for proposals for facilitation of a 2-day Watershed Advisory Council Workshop and to expend funds to conduct the workshop; 2) authorizing the Executive Director to contract with the Delaware Department of Natural Resources and Environmental Control to implement elements of the Comprehensive Conservation and Manage-

ment Plan for the Delaware Estuary; and 3) establishing a Delaware Estuary Program office at the Commission.

## PART I PERMITS

Under to the Federal Clean Water Act and the Pennsylvania Clean Streams Law, the following parties have applied for an NPDES permit or to renew their current permit to discharge controlled wastewaters into the waters of this Commonwealth or to conduct other activities required by the NPDES permit. For renewal applications listed in Section I below, the Department of Environmental Protection (Department) has made a tentative determination to reissue these permits for five years subject to effluent limitations and monitoring and reporting requirements in their current permits, with appropriate and necessary updated requirements to reflect new and changed regulations and other requirements. For all new permit applications, renewal application with major changes or applications for permits not waived by EPA, the Department, based upon preliminary reviews, also made a tentative determination of proposed effluent limitations and other terms and conditions for the permit applications listed in Section II below. These determinations are published as proposed actions for comments prior to taking final actions.

Unless indicated otherwise below, the EPA Region III Administrator has waived the right to review or object to this proposed permit action under the waiver provision 40 CFR 123.6(d).

Persons wishing to comment on the proposed permit are invited to submit a statement, to the office noted above the application within 30 days from the date of this public notice. Comments received within this 30-day comment period will be considered in the formulation of the final determinations regarding this application. The comments should include the name, address, and telephone number of the writer and a concise statement to inform the Department of the exact basis of a comment and the relevant facts upon which it is based. A public hearing may be held if the responsible office considers the public response significant. Following the comment period, the Department's Water Management Program Manager will make a final determination regarding these applications. Notice of this final determination will be published in the *Pennsylvania Bulletin* at which time this determination may be appealed to the Environmental Hearing Board.

The renewal application, including proposed effluent limitations and special conditions, is available on file. For new permit applications, information submitted with the applications is available on file. The information may be inspected and arrangements made for copying at the office indicated above the application.

#### NPDES Stormwater Individual Permit

The following parties have applied for an NPDES permit to discharge stormwater associated with a con-

**LAND RECYCLING AND ENVIRONMENTAL REMEDIATION**

**Under Act 2, 1995**

**Preamble 1**

**Acknowledgment of Notices of Intent to Remediate Submitted Under the Land Recycling and Environmental Remediation Standards Act (35 P. S. §§ 6026.101—6026.908).**

Sections 302—305 of the Land Recycling and Environmental Remediation Standards Act (Act) require the Department of Environmental Protection (Department) to public in the *Pennsylvania Bulletin* an acknowledgment noting receipt of any Notices of Intent to Remediate. An acknowledgment of the receipt of a Notice of Intent to Remediate is used to identify a site where a person proposes to, or has been required to, respond to a release of a regulated substance at a site. Persons intending to use the background standard, Statewide health standard, the site-specific standard, or who intend to remediate a site as a special industrial area, must file a Notice of Intent to Remediate with the Department. A Notice of Intent to Remediate filed with the Department provides a brief description of the location of the site, a list of known or suspected contaminants at the site, the proposed remediation measures for the site, and a description of the intended future use of the site. A person who demonstrates attainment of one, or a combination of the cleanup standards, or who receives approval of a special industrial area remediation identified under the Act, will be relieved of further liability for the remediation of the site for any contamination identified in reports submitted to and approved by the Department. Furthermore, the person shall not be subject to citizen suits or other contribution actions brought by responsible persons not participating in the remediation.

Under Sections 304(n)(1)(ii) and 305(c)(2) of the Act, there is a 30-day public and municipal comment period for sites proposed for remediation using a site-specific standard, in whole or in part, and for sites remediated as a special industrial area. This period begins when a summary of the Notice of Intent to Remediate is published in a newspaper of general circulation in the area of the site. For the site(s) identified below, proposed for remediation to a site-specific standard or as a special industrial area, the municipality, within which the site is

located, may request to be involved in the development of the remediation and reuse plans for the site if the request is made within 30 days of the date specified below. During this comment period the municipality may request that the person identified below, as the remediator of the site, develop and implement a public involvement plan. Requests to be involved, and comments, should be directed to the remediator of the site.

**NOTICE OF PROMPT INTERIM RESPONSE UNDER THE HAZARDOUS SITES CLEANUP ACT**

The Department of Environmental Protection (Department), under the authority of the Hazardous Sites Cleanup Act (HSCA) (35 P.S. §§ 6020.101—6020.1305) has initiated a prompt interim response at the Clements Landfill site. This response has been undertaken under

Section 505(b) of the HSCA (35 P. S. §§ 6020.505(b)). The site is located at: Ontelaunee and Perry Townships, Berks County, PA.

The Clements Landfill Site (Site) is located approximately one and one-half miles east of Route 61, and is bordered by Birch Hill Road to the north, Shoemakersville Road to the east, Ontelaunee Drive to the south, and Kerns Road extending from the south to west-side of the site. The entire area surrounding the Site consists of residential and agricultural lands. The Site, an inactive landfill since 1970, is 68.29 acres on which approximately 25 acres are land filled.

In June 2000, the Department sampled 13 residential wells adjacent to the Site. Three adjacent properties south of the Site, located on a geologic fracture trace running through the land filled area, have volatile organic compounds (VOC) contaminations above regulatory standards. Trichloroethylene (TCE) levels ranged from 24 micrograms per liter ( $\mu\text{g/L}$ ) to 73  $\mu\text{g/L}$ , vinyl chloride from 4  $\mu\text{g/L}$  to 27  $\mu\text{g/L}$  and cis-1, 2-Dichloroethylene (cis-1,2-DCE) from 79 to 140  $\mu\text{g/L}$ . The regulatory limits for these VOCs in groundwater are 5  $\mu\text{g/L}$ , 2  $\mu\text{g/L}$ , and 70  $\mu\text{g/L}$  respectively. Re-sampling of the impacted well water supplies confirmed these levels of VOC contamination.

The Department proposes a prompt interim response at this site to protect public health and safety or the environment. This determination is based on the continued release of VOCs to the groundwater, and the actual human exposure to hazardous substances via inhalation, ingestion and dermal contact.

The Department considered three alternatives: 1. No action, which allows the residents to have continued exposure to the VOC contamination; 2. Bottled water, which effectively removes the risk posed by ingestion, but would not remove the risk posed by inhalation and dermal contact; 3. Point-of-use water treatment systems that will treat the contaminated water to effectively remove the current human ingestion, inhalation and dermal contact threats. This alternative will be protective of human health and the environment.

The Department is providing this notice under sections 505(b) and 506(b) of HSCA (35 P. S. §§ 6020.505(b) and 6020.506(b)), and the publication of this notice starts the administrative record period under HSCA. The Administrative Record which contains information about this site and which supports the Department's decision to perform this action at the site is available for public review and comment. The Administrative Record can be examined from 8 a.m. to 4 p.m. at the Department's Southcentral Regional Office located at 909 Elmerton Avenue, Harrisburg, PA 17110, by contacting Richard Morgan at (717) 705-4844. ### Public Notice of Proposed Consent Order and Agreement

#### Former Avtex Fibers, Inc. Site, Vernon Township, Crawford County

Under Section 1113 of the Hazardous Sites Cleanup Act (35 P. S. §§ 6020.101—6020.1305) (HSCA), notice is hereby provided that the Department of Environmental Protection (Department) has agreed to a Consent Order and Agreement (Agreement) with FMC Corporation, 200 E. Randolph Drive, Chicago, Illinois 60601 (FMC) concerning the resolution of their liability for the mercury contamination at the former Avtex Fibers, Inc. facility's wastewater treatment plant (site), located in Vernon Township, Crawford County.

Between 1929 and 1986, mercury from the mercury seals leaked into the trickling filter tanks and the trickling filter media in the wastewater treatment plant at the Avtex Fibers, Inc. facility in Vernon Township, Crawford County, Pennsylvania. In 1995, certain aspects of the wastewater treatment plant, including the trickling filter media and mercury-lubricated distribution arms were dismantled. During and subsequent to this dismantling, mercury leaked into the trickling filter tanks, trickling filter media and soils near the trickling filter tanks. This leaking of mercury constituted a "release" and "threat of release" as defined by Section 103 of HSCA. Mercury is also defined in Section 103 of HSCA as a "hazardous substance".

As an owner during a period of time that hazardous substances were released at the site, FMC is a "responsible person" as defined in Section 103 of HSCA. Under the terms of the Agreement, FMC shall: 1) Collect the elemental mercury for off-site disposal or recycling to the extent possible from the trickling filter tanks; 2) Test the trickling filter media, if it fails a characteristically hazardous waste determination it will be treated to a level that allows on-site containment or disposed off-site as a hazardous waste; 3) Permanently contain all other sediments, wastes, and apparatus within a trickling filter tank, following any necessary decontamination. Following the completion of these actions, FMC shall be relieved of further liability concerning the release and threat of release of mercury from the wastewater treatment facility at the site, pursuant to Section 501(a) of the Land Recycling Act (35 P. S. § 6026.501(a)).

The specific terms of this settlement are set forth in the Agreement between the FMC and the Department. The Department will receive and consider comments relating to the Agreement for 60 days from the date of this Public Notice. The Department has the right to withdraw its consent to the Agreement if the comments concerning the Agreement disclose facts or considerations, which indicate that the Agreement is inappropriate, improper, or not in the public interest. After the public comment period, the Department's settlement with FMC shall be effective upon the date that the Department notifies FMC, in writing, that this Agreement is final and effective in its present form, and that the Department has filed a response to significant written comments to the Agreement, or that no such comments were received.

### Consent Order and Agreement Borough of Kane

### Final Order

#### Introduction

Because of the rapid depletion of area codes in this Commonwealth<sup>1</sup> the Pennsylvania Public Utility Commission (Commission) has been actively monitoring the need for area code relief while investigating and implementing various number conservation measures.<sup>2</sup> One number

<sup>1</sup> An area code becomes depleted when none of its "NXX codes" (which are the three digits following the area code in a 10-digit telephone number) are available for assignment to a carrier. Under the current infrastructure, telephone numbers are assigned to carriers by NXX code (which contains 10,000 numbers). Consequently, even if a carrier has only 10 customers, 10,000 numbers are still assigned in that area code causing 9,990 numbers to remain unused and unavailable. The result of this is that available NXX codes in an area code exhaust so that a new area code needs to be instituted to generate new NXX codes, and hence, make new numbers available for assignment.

conservation measure that the Commission has previously investigated in 1997 and 1998 is rate center consolidation (RCC).<sup>3</sup> RCC is a number conservation measure that permits the combination of existing rate centers<sup>4</sup> into a smaller number of larger rating areas. Fewer rate centers in an area code allows certain carriers to use fewer NXX codes when entering a market to provide service.<sup>5</sup> Implementation of this measure has the potential of decreasing the need for additional numbering resources in the area codes located in this Commonwealth, thereby prolonging the current area codes or numbering plan areas (NPAs).

The Federal Communications Commission (FCC) has permitted the Commission and other states to consider RCC as a number conservation measure that may reduce number usage and decrease the frequency of the need for additional area codes.<sup>6</sup> The FCC affirmed this grant of authority for states to consider RCC in its delegation order issued July 20, 2000.<sup>7</sup> Specifically, the FCC emphasized that state commissions do not require any additional delegation of authority to engage in rate center consolidation because this number conservation measure involves local calling scopes and ratings which clearly fall under a state commission's ratemaking authority.<sup>8</sup>

In its most recent order of December 29, 2000<sup>9</sup>, the FCC further discussed RCC. The FCC strongly encouraged state commissions to proceed as expeditiously as possible to consolidate rate centers located in their Numbering Plan Areas (NPA).

#### Discussion

The Commission is anxious to implement RCC in this Commonwealth as expeditiously as possible so that numbering resources can be used efficiently by all carriers operating in this Commonwealth. At the same time, the Commission realizes that the issues involved in RCC can be numerous.<sup>10</sup> However, by further investigating and implementing RCC, the Commission will better ensure that telecommunications carriers have adequate numbering resources without needing to resort to adding new area codes.

On December 20, 2000, in its Final Pooling Order, the Commission established a Number Steering Committee to

monitor the progress of the pool in the 610 and 484 NPAs and to resolve issues that may arise during implementation of that number conservation measure.<sup>11</sup> The Commission ordered that the Number Steering Committee be chaired by staff and be comprised of representatives from the pool participants, the interim pooling administrator, and the Offices of Consumer Advocate and Small Business Advocate.

The Commission now directs that a Subcommittee of the Number Steering Committee be established to investigate and propose an implementation plan to consolidate rate centers in all NPAs in this Commonwealth. The Subcommittee will also be chaired by staff and will be comprised of representatives of the telecommunications industry, the Office of Consumer Advocate, and the Office of Small Business Advocate as well as the Pennsylvania Code Administrator. The present members of the Number Steering Committee will assist in finding those individuals who handle RCC for their organizations to serve on this Subcommittee.

The Commission expects that this Subcommittee will work diligently to produce an RCC plan that can be easily implemented in a timely fashion in this Commonwealth's NPAs. Also, the Commission directs that any proposed RCC plan fully consider customer impact and education. Thus, the Commission directs that the Subcommittee meet initially no later than March 15, 2001. At that point, the Commission expects that the Subcommittee will establish a regular meeting schedule and possibly divide into additional subcommittees or working groups to address the specific technical and rate issues inherent to an RCC implementation plan.

Also, the Commission directs the RCC Subcommittee to conclude its work and file a proposed implementation plan to consolidate any and all rate centers in this Commonwealth's area codes by August 1, 2001. The plan should include maps redrawing rate center boundaries to reflect the proposed consolidation. It should also include a proposed implementation schedule to provide for sufficient network testing and customer notification. At that time, the Commission will review and approve the plan accordingly.

#### *Conclusion*

Because the Commission is concerned about the current availability and usage of numbering resources and the impact of proliferating new area codes on consumers as well as telecommunications carriers, the Commission intends to investigate rate center consolidation through a Subcommittee of the Number Steering Committee. By taking this step to investigate and implement this additional number conservation measure, the Commission will better ensure that telecommunications carriers have adequate numbering resources to operate in this Commonwealth, *Therefore,*

#### *It is Ordered That:*

1. A Subcommittee of the Number Steering Committee be established to devise and implement an RCC plan in any and all area codes in this Commonwealth.
2. The RCC Subcommittee, chaired by Commission staff, shall convene its first meeting no later than March 15, 2001, to set forth a meeting schedule and assignment of issues to internal working groups.

3. The RCC Subcommittee file with the Commission a proposed RCC implementation plan no later than August 1, 2001.
