## DELAWARE RIVER BASIN COMMISSION

### Commission Meeting and Public Hearing

The Delaware River Basin Commission (Commission) will hold an informal conference followed by a public hearing on Wednesday, July 18, 2007. The hearing will be part of the Commission's regular business meeting. Both the conference session and business meeting are open to the public and will be held at the Commission's office building, located at 25 State Police Drive in West Trenton, NJ.

The conference among the commissioners and staff will begin at 10:15 a.m. Topics include a presentation on a revised proposal for a Flexible Flow Management Program (FFMP) for the New York City Delaware Basin Reservoirs; a presentation on proposed amendments to the Commission's Special Protection Waters regulations and a presentation on proposed amendments to the Water Code relating to water accountability and source metering, recording and reporting.

The subjects of the public hearing to be held during the 2 p.m. business meeting include the dockets listed as follows:

1. *South Coatesville Borough D-74-39 CP-2*. An application for approval of the rerate of the existing South Coatesville Borough Wastewater Treatment Plant (WWTP). The permitted discharge from the applicant's WWTP will increase from an annual average daily flow of 0.365 million gallons per day (mgd) to 0.381 mgd and will continue to be discharged to the West Branch Brandywine Creek. The facility is located in South Coatesville Borough, Chester County, PA.

2. *Kent County Levy Court D-77-87 CP-2*. An application for approval of the expansion of the existing Kent County Levy Court WWTP. The permitted discharge from the applicant's WWTP will increase from a daily flow of 15.0 mgd to 16.3 mgd and will continue to be discharged to The Gut, a tributary to the Murderkill River. The facility is located in the City of Milford, Kent County, DE.

3. *Hackettstown Municipal Utilities Authority D-91-30 CP-2*. An application to expand a 3.3 mgd wastewater treatment plant to process 3.39 mgd. The plant is located in Washington Township, Morris County, NJ. The plant will continue to treat wastewater from the Town of Hackettstown, Mansfield, Independence and Allamuchy Townships, all in Warren County; and Washington and Mount Olive Townships in Morris County, NJ. The additional capacity is needed to serve the service area previously served by the former Diamond Hill Sewer Company. Treatment plant effluent will continue to be discharged to the Musconetcong River in the Musconetcong River Watershed by means of the existing outfall. The defunct Diamond Hill treatment facility and discharge to Hence's Brook will be abandoned.

4. *Aqua New Jersey, Inc. D-93-13 CP-3*. An application for the renewal of a groundwater withdrawal project to increase withdrawal from 198.5 mg/30 days to 237 mg/30 days to supply the applicant's Blackwood District public water supply distribution system from existing Wells Nos. 3, 6, 7, 13, 15, 17 and 20 located within the Delaware River Basin and eight wells located outside of the basin

in the Cohansey, Mt. Laurel and Potomac-Raritan-Magothy Formations. The increased allocation is requested to meet projected increases in service area demand. The project is located in the Big Timber Creek Watershed in Gloucester Township, Camden County, NJ.

5. *Reading Area Water Authority D-2000-59 CP-2*. An application for approval to transfer up to 1.5 mgd and up to 45 mg/30 days of potable water from the Reading Area Water Authority (RAWA) system to the Pennsylvania American Water Company (PAWC) Glen Alsace District water distribution system. Some of the water supply is also needed to serve PAWC's customers in its Douglassville District by means of an existing interconnection. RAWA proposes no increase of existing allocation of 35 mgd (1,050 mg/30 days) of water from its Lake Ontelaunee Reservoir, which is located in Ontelaunee Township, Berks County, PA. The project also includes the revision of the RAWA Operating Plan to reflect the service area modification, conservation release improvements and fisheries protection measures. The reservoir is situated on Maiden Creek in the Schuylkill River Watershed.

6. *Borough of Portland D-2003-9 CP-2*. An application to modify the proposed WWTP that was approved by DRBC Docket No. D-2003-9 CP on January 19, 2005, but not constructed due to cost considerations. The WWTP design capacity will remain 0.105 mgd, but the modified design involves treatment processes that cost less to construct and maintain than those in the approved design. The proposed membrane ultra-filtration system will eliminate the need for clarifiers and a tertiary filter, while still meeting docket and NPDES permit limitations. The WWTP will provide tertiary treatment of flow from the proposed Portland Industrial Park and from local onlot septic systems located in Portland Borough, Northampton County, PA. The WWTP will be constructed in the southeast corner of Portland Borough and the project outfall diffuser will discharge to the Delaware River. The project is located within the drainage area to a section of the nontidal Delaware River known as the Lower Delaware, which is classified as Special Protection Waters.

7. *Pennsylvania American Water Company D-2006-33 CP-2*. An application for approval of a groundwater withdrawal project to supply up to 7.34 mg/30 days of water to the applicant's public supply distribution system from new Well PW3 and to increase the existing withdrawal from all wells from 15.12 mg/30 days to 18.57 mg/30 days. The increased allocation is requested to meet projected increases in service area demand. New Well PW3 is located in the Trimmers Rock Formation in the Brodhead Creek Watershed in Stroud Township, Monroe County, PA. The site is located within the drainage area to the section of nontidal Delaware River known as the Middle Delaware, which is classified as Special Protection Waters.

8. *Wissahickon Spring Water, Inc. D-2006-29-1*. An application for approval to discharge up to 0.1008 mgd to Kaercher Creek, a tributary of the Schuylkill River, from a bottled water filtration plant. The wastewater currently discharges into sanitary drains within the building. The applicant will install three reverse osmosis units and will discharge the rinse water through new Outfall No. 001. The facility is located in the Schuylkill River Watershed in Hamburg Borough, Berks County, PA.

9. *Pocono Manor Investors Pt. 1, L.P. D-2006-43-1*. An application for approval of a groundwater withdrawal

project to supply up to 30.24 mg/30 days of water to the applicant's resort from new Wells Nos. 1—3 and to limit the existing withdrawal from all wells to 30.24 mg/30 days. The project is located in the Catskill Formation in the Brodhead/Swiftwater Creek Watershed in Pocono Township, Monroe County, PA. This withdrawal project is located within the drainage area to the section of the nontidal Delaware River known as the Middle Delaware, which is classified as Special Protection Waters.

10. *Royersford Borough D-2006-45 CP-1.* An application for approval to expand the existing Royersford Borough WWTP from a design flow of 0.54 mgd to 0.70 mgd. WWTP effluent will continue to be discharged to the Schuylkill River. The facility is located directly outside of Royersford Borough, in Upper Providence Township, Montgomery County, PA.

11. *Jackson Township Authority D-2007-4 CP-1.* An application for the approval of a new 0.5 mgd WWTP. The applicant's new WWTP will discharge to an unnamed tributary of the Tulpehocken Creek, a tributary to the Schuylkill River, at a point upstream of Blue Marsh Reservoir. The facility will be located in Jackson Township, Lebanon County, PA.

12. *Cott Beverages, Inc. D-2007-6-1.* An application for approval to expand the applicant's existing IWTP from 0.023 mgd to 0.070 mgd to serve its beverage (soft drinks and carbonated water) production facility. The IWTP will continue to discharge to the West Branch Chester Creek in the Chester Creek Watershed. The facility is located in Concord Township, Delaware County, PA.

13. *Bath Borough Authority D-2007-16 CP-1.* An application for approval of a groundwater withdrawal project to supply up to 15 mg/30 days of water to the applicant's public supply distribution system from new Wells Smith Street, Allen Street and Holiday Hill. The project is located in the Ontelaunee and Martinsburg formations in the Monacacy Creek and East Monacacy Creek watersheds in Bath Borough, Northampton County, PA. The project site is located within the drainage area to the section of the nontidal Delaware River known as the Lower Delaware, which is classified as Special Protection Waters.

14. *Altivity Packaging LLC D-2007-20-1.* An application for approval of a surface water withdrawal project to supply up to 210 mg/30 days of water to the applicant's

industrial operations from existing Intake No. 1. The project is located in the Schuylkill River Watershed in the City of Philadelphia, PA.

In addition to the public hearing on the dockets listed, the Commission's 2 p.m. business meeting will include: a public hearing and consideration of a resolution for the minutes increasing the authorized value of a contract with Princeton Hydrologics, LLC for modifications to the site of the Commission's West Trenton office building to improve stormwater management; a resolution authorizing the Executive Director to enter into an agreement for analysis of emerging contaminants in ambient waters of the tidal Delaware River; a resolution authorizing the executive director to enter into an agreement with the Susquehanna River Basin Commission for the Commission to perform tasks in connection with water conservation aspects of Pennsylvania's State Water Planning Act; and a resolution for the minutes authorizing the executive director to enter into an agreement to provide support to the Commonwealth of Pennsylvania on water resources issues.

The meeting will also include: adoption of the minutes of the Commission's May 10, 2007, business meeting; announcements of upcoming advisory committee meetings and other events; a report by the Executive Director; a report by the Commission's General Counsel and an opportunity for public dialogue.

#### Hearing

Under the Professional Educator Discipline Act (act) (24 P. S. §§ 2070.1—2070.18a), the Professional Standards and Practices Commission (Commission) has initiated hearing procedures to consider the application of Ronald Roda for reinstatement of his teaching certificate.

On or about February 26, 2007, Ronald Roda filed an application for reinstatement of his teaching certificate under section 16 of the act (24 P. S. § 2070.16), 1 Pa. Code §§ 35.1 and 35.2 (relating to applications) and the former 22 Pa. Code § 233.14 (relating to reinstatement). Under section 16 of the act, the Department of Education on June 19, 2007, recommended to the Com-

mission that the application be denied. In accordance with the act and 1 Pa. Code Part II (relating to General Rules of Administrative Practice and Procedure), the Commission will appoint a hearing examiner to serve as presiding officer to conduct the proceedings and hearings as might be necessary and to prepare a proposed report to the Commission containing findings of fact, conclusions of law and a recommended decision on the application.

Interested parties wishing to participate in these hearing procedures must file a notice of intervention or a petition to intervene in accordance with 1 Pa. Code §§ 35.27—35.32 (relating to intervention) within 30 days after publication of this notice in the *Pennsylvania Bulletin*. Any person objecting to the approval of the application may also, within 30 days after publication of this notice in the *Pennsylvania Bulletin*, file a protest in accordance with 1 Pa. Code § 35.23 (relating to protest generally).

### THE CLEAN STREAMS LAW AND THE FEDERAL CLEAN WATER ACT APPLICATIONS FOR NATIONAL POLLUTION DISCHARGE ELIMINATION SYSTEM (NPDES) PERMITS AND WATER QUALITY MANAGEMENT (WQM) PERMITS

This notice provides information about persons who have applied for a new, amended or renewed NPDES or WQM permit, a permit waiver for certain stormwater discharges or submitted a Notice of Intent (NOI) for coverage under a

general permit. The applications concern, but are not limited to, discharges related to industrial, animal or sewage waste, discharges to groundwater, discharges associated with municipal separate storm sewer systems (MS4), stormwater associated with construction activities or concentrated animal feeding operations (CAFOs). This notice is provided in accordance with 25 Pa. Code Chapters 91 and 92 and 40 CFR Part 122, implementing The Clean Streams Law (35 P. S. §§ 691.1—691.1001) and the Federal Clean Water Act.

For NPDES renewal applications in Section I, the Department of Environmental Protection (Department) has made a tentative determination to reissue these permits for 5 years subject to effluent limitations and monitoring and reporting requirements in their current permits, with appropriate and necessary updated requirements to reflect new and changed regulations and other requirements.

For applications for new NPDES permits and renewal applications with major changes in Section II, as well as applications for MS4 individual permits and individual stormwater construction permits in Sections IV and VI, the Department, based upon preliminary reviews, has made a tentative determination of proposed effluent limitations and other terms and conditions for the permit applications. These determinations are published as proposed actions for comments prior to taking final actions.

Unless indicated otherwise, the EPA Region III Administrator has waived the right to review or object to proposed NPDES permit actions under the waiver provision in 40 CFR 123.24(d).

Persons wishing to comment on an NPDES application are invited to submit a statement to the regional office noted before an application within 30 days from the date of this public notice. Persons wishing to comment on a WQM permit application are invited to submit a statement to the regional office noted before the application within 15 days from the date of this public notice. Comments received within the respective comment periods will be considered in the final determinations regarding the applications. Comments should include the name, address and telephone number of the writer and a concise statement to inform the Department of the exact basis of a comment and the relevant facts upon which it is based.

The Department will also accept requests for a public hearing on applications. A public hearing may be held if the responsible office considers the public response significant. If a hearing is scheduled, a notice of the hearing will be published in the *Pennsylvania Bulletin* and a newspaper of general circulation within the relevant geographical area. The Department will postpone its final determination until after a public hearing is held.

### LAND RECYCLING AND ENVIRONMENTAL REMEDIATION UNDER ACT 2, 1995 PREAMBLE 1

#### Acknowledgment of Notices of Intent to Remediate Submitted under the Land Recycling and Environmental Remediation Standards Act (35 P. S. §§ 6026.101—6026.908).

Sections 302—305 of the Land Recycling and Environmental Remediation Standards Act (act) require the Department of Environmental Protection (Department) to publish in the *Pennsylvania Bulletin* an acknowledgment noting receipt of Notices of Intent to Remediate. An acknowledgment of the receipt of a Notice of Intent to Remediate is used to identify a site where a person proposes to, or has been required to, respond to a release of a regulated substance at a site. Persons intending to use the Background Standard, Statewide Health Standard, the Site-Specific Standard or who intend to remediate a site as a special industrial area must file a Notice of Intent to Remediate with the Department. A Notice of Intent to Remediate filed with the Department provides a brief description of the location of the site, a list of known or suspected contaminants at the site, the proposed remediation measures for the site and a description of the intended future use of the site. A person who demonstrates attainment of one, a combination of the cleanup standards or who receives approval of a special industrial area remediation identified under the act will be relieved of further liability for the remediation of the site for any contamination identified in reports submitted to and approved by the Department. Furthermore, the person shall not be subject to citizen suits or other contribution actions brought by responsible persons not participating in the remediation.

Under sections 304(n)(1)(ii) and 305(c)(2) of the act, there is a 30-day public and municipal comment period for sites proposed for remediation using a Site-Specific Standard, in whole or in part, and for sites remediated as a special industrial area. This period begins when a summary of the Notice of Intent to Remediate is published in a newspaper of general circulation in the area of the site. For the sites identified, proposed for remediation to a Site-Specific Standard or as a special industrial area, the municipality within which the site is located may request to be involved in the development of the remediation and reuse plans for the site if the request is made within 30 days of the date specified. During this comment period, the municipality may request that the person identified as the remediator of the site develop and implement a public involvement plan. Requests to be involved and comments should be directed to the remediator of the site.

If required, a cleanup plan evaluates the abilities of potential remedies to achieve remedy requirements.

A final report provides a description of the site investigation to characterize the nature and extent of contaminants in environmental media, the basis of selecting the environmental media of concern, documentation supporting the selection of residential or nonresidential exposure factors, a description of the remediation performed and summaries of sampling methodology and analytical results which demonstrate that the remediation has attained the cleanup standard selected. Plans and reports required by provisions of the act for compliance with selection of remediation to a Site-Specific Standard, in addition to a final report, include a remedial investigation report, risk assessment report and cleanup plan. A remedial investigation report includes conclusions from the site investigation, concentration of regulated substances in environmental media, benefits of refuse of the property and, in some circumstances, a fate and transport analysis. If required, a risk assessment report describes potential adverse effects caused by the presence of regulated substances. If required, a cleanup plan evaluates the abilities of potential remedies to achieve remedy requirements. A work plan for conducting a baseline remedial investigation is required by provisions of the act for compliance with selection of a special industrial area remediation. The baseline remedial investigation, based on the work plan, is compiled into the baseline environmental report to establish a reference point to show existing contamination, describe proposed remediation to be done and include a description of existing or potential public benefits of the use or reuse of the property. The Department may approve or disapprove plans and reports submitted. This notice provides the Department's decision and, if relevant, the basis for disapproval.

If information concerning a final report is required in an alternative form, contact the Community Relations Coordinator at the appropriate regional office. *Department of Labor and Industry—General Provisions;  
Regulation No. 12-67 (#2484)*

On June 27, 2005, the Independent Regulatory Review Commission (Commission) received this proposed regulation from the Department of Labor and Industry (Department). This rulemaking amends 34 Pa. Code Chapter 121. The proposed regulation was published in the July 9, 2005 *Pennsylvania Bulletin* with a 30-day public comment period. The final-form regulation was submitted to the Commission on May 21, 2007.

This final-form rulemaking updates and clarifies administrative procedures followed by employees, employers and insurers in their transactions with the Bureau of Workers' Compensation.

We have determined this regulation is consistent with the statutory authority of the Department (77 P. S. §§ 710 and 991(a)) and the intention of the General Assembly. Having considered all of the other criteria of the Regulatory Review Act, we find promulgation of this regulation is in the public interest.

*Pennsylvania Gaming Control Board—Accounting and Internal Controls; Slot Computer Systems; Commencement of Slot Operations; Regulation No. 125-49 (#2581)*

On October 25, 2006, the Independent Regulatory Review Commission (Commission) received this proposed regulation from the Pennsylvania Gaming Control Board (Board). This rulemaking adds 58 Pa. Code Chapters 465a, 466a and 467a and amends Chapter 461a. The proposed regulation was published in the December 2, 2006 *Pennsylvania Bulletin* with a 30-day public comment period. The final-form regulation was submitted to the Commission on May 17, 2007.

This final-form regulation establishes three chapters of the Board's regulations. The chapters relate to accounting controls and audits, slot machine computer systems and the commencement of slot operations. The rulemaking also adds definitions to an existing chapter of the Board's regulations.

We have determined this regulation is consistent with the statutory authority of the Board (4 Pa.C.S.A. §§ 1202(b)(30), 1207, 1322 and 1520) and the intention of the General Assembly. Having considered all of the other criteria of the Regulatory Review Act, we find promulgation of this regulation is in the public interest.

Department of Revenue—Pennsylvania Gaming Cash Flow Management; Regulation No. 15-436 (#2596)

On February 21, 2007, the Independent Regulatory Review Commission (Commission) received this proposed regulation from the Department of Revenue. This rulemaking adds 61 Pa. Code Chapter 1001. The proposed regulation was published in the March 3, 2007 *Pennsylvania Bulletin* with a 30-day public comment period. The final-form regulation was submitted to the Commission on May 25, 2007.

This final-form rulemaking establishes the procedures for the administration and distribution of all net slot machine revenue, collection of tax and collection of other assessments under the Pennsylvania Race Horse Development and Gaming Act (4 Pa.C.S.A. §§ 1101—1904).

We have determined this regulation is consistent with the statutory authority of the Department (4 Pa.C.S.A § 1501(a)) and the intention of the General Assembly. Having considered all of the other criteria of the Regulatory Review Act, we find promulgation of this regulation is in the public interest.

**Environmental Quality Board Regulation #7-408 (IRRC #2598)**

**Permit Streamlining**

**June 25, 2007**

We submit for your consideration the following comments on the proposed rulemaking published in the March 24, 2007 *Pennsylvania Bulletin*. Our comments are based on criteria in Section 5.2 of the Regulatory Review Act (71 P. S. § 745.5b). Section 5.1(a) of the Regulatory Review Act (71 P. S. § 745.5a(a)) directs the Environmental Quality Board (EQB) to respond to all comments received from us or any other source.

**1. Adequate Public Notice—Reasonableness; Need.**

The Preamble states that the Department of Environmental Protection (Department), as part of an effort to streamline the permitting process, investigated ways to “reduce the plan approval application time, reduce unnecessary costs to industry *and continue to ensure that citizens receive adequate notice of potential plan approval/permitting actions to enable timely comment on issues of public concern.*” (Emphasis added.) We received two public comments in support of the amendments. However, a joint comment from eight organizations, dated May 25, 2007, was sent to the EQB urging rejection of the amendments. Specifically, the joint commentators cite concerns with the amendments in Sections 127.44, 127.44(b)(6) and 127.45(5), as they relate to public notice in the *Pennsylvania Bulletin*.

We recognize that, as amended, Section 127.45(5) would require “a brief description of the conditions being placed in the plan approval with reference to applicable State and Federal requirements.” We also note that proposed Section 127.44(b)(5) is essentially the same as the existing requirement under Section 127.44(a)(6). Nonetheless, the EQB should explain further why these amendments are needed and how the amended regulation will provide adequate notice to the public.

**2. Section 127.12d. Completeness Determination—Consistency with statute; Reasonableness; Clarity.**

*Adequate, Streamlined and Reasonable Procedures*

In its Preamble, the EQB cites 35 P. S. § 4006.1(b.3) which states:

The board shall by regulation establish *adequate, streamlined and reasonable procedures for expeditiously determining when applications are complete* and for expeditious review of application. . . . (Emphasis added.)

The procedures in Subsections (a) and (c) of the regulation require the Department to evaluate applications for completeness, but do not address when the Department must take action. To be consistent with 35 P. S. § 4006.1(b.3), the EQB should consider adding time limits for Department action to Subsections (a) and (c).

*Administratively Incomplete Applications*

Under Subsection (c), if the Department finds that an application is incomplete, the Department will “return the application and fees to the applicant, along with a written statement of the specific information . . . required to make the application administratively complete.” We agree with a commentator that the procedure would be less burdensome by allowing the opportunity to rectify the deficiency rather than essentially restarting the process by returning the application and fees. Why is it necessary to return the application and fees?

*Vague Language*

Subsection (b) includes vague requirements for “necessary information” and “other documents.” These subjective phrases do not give the regulated community the specific information needed to file a complete application. For clarity, we recommend that the phrases “necessary information” and “other documents” be replaced with the specific information needed to file an administratively complete application.

**3. Section 127.44. Public Notice—Reasonableness; Need; Clarity.**

*Subsection (b)*

There are three concerns. First, the EQB should explain why it needs to delete existing Paragraph (5) which requires notice for “other sources required to obtain plan approval.” What sources would this amendment affect?

Second, as amended, new Paragraph (5) discusses “other sources, including synthetic minor permit applications.” In conjunction with the deletion of the requirement for notice of “other sources required to obtain plan approval,” the EQB should provide more detail on the “other sources” that would be included.

Finally, it is not clear what the phrase “including synthetic minor permit applications” encompasses. The EQB should define this phrase.

**4. Section 127.45. Contents of Notice—Reasonableness; Need.**

As amended, Paragraph (5) would no longer require a “description of the reasons” for including conditions. Why is the description of the reasons no longer needed?

**5. Miscellaneous; Clarity.**

- There is inconsistent language in the regulation. Paragraph 127.44(a)(2) refers to the plant or facility “at which the construction, modification, reactivation or installation is proposed” but, Paragraph (a)(3) only mentions equipment “to be installed or modified.” In addition, Paragraph 127.45(2) only refers to the plant or facility at which “construction, modification or installation is proposed.” Why do the words “reactivation” and “construction” appear in some provisions, but not others?

- Paragraph 127.44(a)(4) requires “a person” to contact for additional information. This provision should specify whether the person to contact would be a representative of the applicant or would be someone from the Department’s regional office.

### Extension of the Fuel Cost Recovery Surcharge Special Permission 28209

#### Order

*By the Commission:*

The Pennsylvania Public Utility Commission (Commission) by its Fuel Cost Recovery Surcharge Order at Special Permission Number 28209, ratified June 1, 2006, authorized call or demand, paratransit, and airport transfer carriers under the jurisdiction of this Commission to adjust rates and fares to offset significant increases in the cost of fuel. The fuel surcharge became effective on July 1, 2006, and is scheduled to terminate on June 30, 2007.

In a letter dated May 29, 2007, the Pennsylvania Taxicab and Paratransit Association (PTPA), on behalf of its members, has requested that this Commission extend the fuel cost recovery surcharge for a period of one year. PTPA cites the ongoing instability of retail gasoline prices as the reason for this request.

Initially, all call or demand, paratransit, and airport transfer carriers were authorized to collect the surcharge found on the Fuel Surcharge page of the Commission's website. The average price of fuel was posted on the third Friday of each month, with the effective date of the surcharge being the first day of the subsequent month. The Commission determined the average cost of unleaded regular gasoline based upon gasoline prices in the index of the Energy Information Administration of the U.S. Department of Energy. The amount of the fuel surcharge was determined by locating the average price of gasoline

on a chart, also displayed on that page, and selecting the corresponding fuel surcharge in the column for the respective type of transportation.

Determination of the amounts to be charged was based on the cost of gasoline per trip. The constants used for calculations were those based upon statistics from the Taxicab, Limousine and Paratransit Association: The average trip length of 6.8 miles for call or demand carriers and 13.61 miles for paratransit and airport transfer carriers; the average miles per gallon per vehicle of 15.04 for call or demand carriers and 13.01 for paratransit and airport transfer carriers; and \$1.35 per gallon of unleaded regular gasoline (the average cost in 2002 according to Energy Information Administration of the Department of Energy). The cost per trip was calculated by multiplying the price of gasoline by the ratio of miles per trip to miles per gallon. The cost per trip at \$1.35 per gallon would serve as the base line. The results are tabulated in the chart below.

The Commission's intention was to create flexibility for both the carriers and the Commission. By establishing gasoline prices which would "trigger" a change in the surcharge, it would no longer be necessary to monitor the surcharge at different intervals. This flexibility would also aid in eliminating the need for emergency petitions, as was the case following Hurricane Katrina in 2005.

In the process of considering this request, the Commission has analyzed current information available from the Energy Information Administration of the U.S. Department of Energy, the American Automobile Association,

and OPIS Energy Group. Data from these groups indicate that the retail price of gasoline will continue to increase throughout the summer months and even beyond, due to increased demand and the uncertainty of supply.

Many refineries have failed to return from unplanned outages and maintenance. Should more unplanned outages occur, there will be a significant impact on the future path of prices. Several analysts expect to see refinery maintenance remain relatively high even into June. High import volumes also play a part in keeping supplies adequate. Additionally, there remain many trouble spots across the globe that could affect the crude oil supply, prices, and gasoline prices (e.g., Venezuela, Nigeria, Iran, etc.). Projections such as this indicate that the cost of gasoline will remain a problem for the transportation industry.

Based on our review, it appears that an extension of the Fuel Cost Recovery is an appropriate way to address the high costs and instability of gasoline prices at the present time. However, the industry should not continue to rely on this measure as a means of relief. Members of the industry will have the responsibility of taking appropriate measures.

After due consideration, we have determined that fuel costs are not likely to decrease. Based upon the evidence available, we are of the opinion that the passenger motor carrier industry continues to have a need for the Fuel Cost Recovery Surcharge to permit the recovery of fuel expenditures; *Therefore,*

*It Is Ordered That:*

1. The Fuel Cost Recovery Surcharge established at Special Permission No. 28209 be and is hereby extended until June 30, 2008, unless changed, cancelled, or extended by the Commission.

2. Effective Wednesday, June 27, 2007, and thereafter on the third Friday of every month, the Commission shall post on its website at [www.puc.state.pa.us/transport/motor/fuel\\_surcharge.aspx](http://www.puc.state.pa.us/transport/motor/fuel_surcharge.aspx) the average cost of unleaded regular gasoline upon which the surcharge will be determined.

3. Call or demand, paratransit, and airport transfer carriers rendering transportation service under the jurisdiction of the PA Public Utility Commission shall notify the public by placing a notice in all vehicles, which shall read: "The PA Public Utility Commission has authorized a fuel surcharge under Special Permission No. 28209. The surcharge has been extended and shall terminate on June 30, 2008. The current surcharge is (insert current charge here) per trip for each paying passenger"

4. The Fuel Cost Recovery Surcharge established at Special Permission No. 28209 be continued until midnight, June 30, 2008, at which time it will expire.

5. The Secretary of this Commission shall duly certify this order and deposit same with the Legislative Reference Bureau for publication in the *Pennsylvania Bulletin*.

On May 1, 2007, Access Point, Inc. (API or the Company) filed the proposed tariff Supplement No. 7, to the Company's Tariff Telephone-Pa. P.U.C. No. 2, issued May 2, 2007, to become effective, June 2, 2007<sup>1</sup>, for the purposes of establishing the Term Liability/Termination Charges, Account Maintenance Fee, Reconnection Charge, Carrier Cost Recovery Fee, and Credit Card Convenience Fee. Subsequently, the review period for this filing was extended for an additional thirty (30) days, or July 2, 2007.

On May 22, 2007, API was issued a data request seeking supporting information and cost justification, as required by our rules and regulations for this filing at 52 Pa. Code § 53.59, for the proposed Account Maintenance Fee and Carrier Cost Recovery Fee. API's proposed supplement contains the following descriptions and rates for these services:

Account Maintenance Fee

All Business Customers will be charged a monthly account maintenance fee on each monthly detailed invoice of \$3.95. If the customer has multiple invoices delivered to different service locations, a fee of \$1.95 will be charged for each detailed invoice. If the Customer elects to receive their monthly invoice electronically, the fee will be \$1.95 for both Single and Multi location Business Customers Invoiced. The fee for Residential Customers is \$0.95.

Carrier Cost Recovery Fee

Carrier Cost Recovery Fee will be assessed on Local Lines to Residential and Business Customers. This assessment will help recover increased network access costs due to regulatory changes.

The Company failed to meet the data request deadline of June 6, 2007. API was advised to withdraw the filing while the Company contemplated its responses or revise the filing to avoid suspension. To date, the Company has done neither.

In other proceedings, the Commission determined that an Access Recovery Charge, a charge similar to the instant Carrier Cost Recovery Fee, imposed as a separate line item was not acceptable and thus has instructed the filing company that such cost recovery is more appropriately built into the explicit rate structure.<sup>2</sup> In addition, we find API's Reconnection Charge of \$25 should be further scrutinized as a protected service under 66 Pa.C.S. § 3012.

Therefore, we shall suspend the Company's filing, consistent with § 1308 and other applicable provisions of 66 Pa.C.S. We believe it is appropriate to initially refer this matter to the Office of Administrative Law Judge (OALJ) for timely mediation in accordance with our regulations at 52 Pa. Code § 69.392(e). The OALJ Mediator should provide the Commission with a final report on the outcome of the mediation as soon as possible.

In the event that such mediation fails, this matter should be expeditiously referred to an ALJ for a full evidentiary adjudication and the issuance of a recommended decision. In view of the Commission's Office of Trial Staff (OTS) duties under 66 Pa.C.S. § 306(b)(1), a copy of the related Commission Order should be formally served on OTS. In the alternative, we will allow the Company to withdraw its filing; *Therefore*,

*It Is Ordered That:*

1. The proposed tariff Supplement No. 7 to Access Point, Inc. Tariff Telephone-Pa. PUC No. 2 is suspended for a period not to exceed six (6) months, or until January 2, 2008, pursuant to § 1308 and other applicable provisions of 66 Pa.C.S.

2. Access Point, Inc. shall file, or cause to be filed, the appropriate tariff suspension supplement.

3. The Company be, and hereby is given, within fifteen (15) days after the date of entry of this Order, the alternative to withdraw the proposed tariff Supplement No. 7 above.

4. If the Company files to withdraw Supplement No. 7, then it is further ordered that the suspension shall be terminated and the case marked closed.

5. If the Company does not file, or cause to be filed, the withdrawal in accordance with the above ordering paragraphs, then it is further ordered:

- That the related tariff modifications be referred to the Office of Administrative Law Judge for a timely mediated resolution in accordance with our regulations at 52 Pa. Code § 69.392(e), and
- That the Office of Administrative Law Judge Mediator shall file a report with the Commission on the outcome of the mediation as soon as possible, and
- That in the event that mediation fails, this matter will be expeditiously referred to an Administrative Law Judge for formal evidentiary adjudication addressing the outstanding material issued, and for the issuance of a recommended decision.

6. A copy of this Order be published in the *Pennsylvania Bulletin*.

7. The Secretary of the Commission formally serve a copy of this Order to the Commission's Office of Trial Staff, the Office of Consumer Advocate, the Office of Small Business Advocate, and the Office of Administrative Law Judge.

3. That, on August 21, 2006, respondent was sent an initial assessment of \$17. Respondent failed to pay this assessment; therefore, a balance was due in the amount of \$17.

4. That respondent has an outstanding assessment of \$17.

5. That respondent failed to file objections to the assessment, pursuant to 66 Pa.C.S. § 510(c).

6. That respondent, by failing to pay the assessment, violated the Public Utility Code at 66 Pa.C.S. § 510(c).
