Individuals with Disabilities Education Act—Part B; Application for Federal Grant

To receive a grant under the Individuals with Disabilities Education Act, the Department of Education (Department) must submit an Annual State Application to the United States Department of Education (USDE). The Annual State Application is an assurance by the Department that by June 30, 2008, policies and procedures will be adopted to ensure compliance with the Individuals with Disabilities Education Act—Part B (IDEA-B) (as amended by Pub. L. No. 108-446 and Pub. L. No. 110-161). Moreover, the Department assures that throughout the period of the grant (July 1, 2008 to June 31, 2009), the Commonwealth will operate consistent with all requirements of IDEA-2004 and applicable regulations.

The IDEA-B funds, received under 34 CFR Subpart B (relating to State Eligibility), will be used to render services and programs to children with disabilities who are eligible for services under IDEA-B as well as training and technical assistance given to professional staff who render services to children with disabilities.

The Department and the State Board of Education has completed amending special education regulations in 22 Pa. Code Chapter 14 (relating to special education services and programs) and 22 Pa. Code Chapter 711 (relating to charter school services and programs for children with disabilities) are pending final adoption through the regulatory review process. Following final adoption and publication in the *Pennsylvania Bulletin*, Spring 2008, the Department will give notice seeking public comment to Department's State Plan under the IDEA-B.

This notice is seeking public input to the Department's Annual State Application. Copies of the draft Annual State Application are available by calling Nancy Zeigler at (717) 783-6134. Alternative formats of the documents (for example, Braille, large print or cassette tape) are available upon request. Public comment is welcomed in alternative formats such as Braille, taped comments and telephone comments for the disabled. Individuals who are disabled and wish to submit comments by telephone should call Nancy Zeigler at (717) 783-6134.

In addition, opportunity for public testimony is being provided by the Department. Testimony may be scheduled by calling Nancy Zeigler (8 a.m. to 4 p.m., Monday through Friday) no later than April 18, 2008. The public hearings will be conduct as follows:

THE CLEAN STREAMS LAW AND THE FEDERAL CLEAN WATER ACT

APPLICATIONS FOR NATIONAL POLLUTION DISCHARGE ELIMINATION SYSTEM (NPDES) PERMITS AND WATER QUALITY MANAGEMENT (WQM) PERMITS

This notice provides information about persons who have applied for a new, amended or renewed NPDES or WQM permit, a permit waiver for certain stormwater discharges or submitted a Notice of Intent (NOI) for coverage under a general permit. The applications concern, but are not limited to, discharges related to industrial, animal or sewage waste, discharges to groundwater, discharges associated with municipal separate storm sewer systems (MS4), stormwater associated with construction activities or concentrated animal feeding operations (CAFOs). This notice is provided in accordance with 25 Pa. Code Chapters 91 and 92 and 40 CFR Part 122, implementing The Clean Streams Law (35 P. S. §§ 691.1—691.1001) and the Federal Clean Water Act.

For NPDES renewal applications in Section I, the Department of Environmental Protection (Department) has made a tentative determination to reissue these permits for 5 years subject to effluent limitations and monitoring and reporting requirements in their current permits, with appropriate and necessary updated requirements to reflect new and changed regulations and other requirements.

For applications for new NPDES permits and renewal applications with major changes in Section II, as well as applications for MS4 individual permits and individual stormwater construction permits in Sections IV and VI, the Department, based upon preliminary reviews, has made a tentative determination of proposed effluent limitations and other terms and conditions for the permit applications. These determinations are published as proposed actions for comments prior to taking final actions.

Unless indicated otherwise, the EPA Region III Administrator has waived the right to review or object to proposed NPDES permit actions under the waiver provision in 40 CFR 123.24(d).

Persons wishing to comment on an NPDES application are invited to submit a statement to the regional office noted before an application within 30 days from the date of this public notice. Persons wishing to comment on a WQM permit application are invited to submit a statement to the regional office noted before the application within 15 days from the date of this public notice. Comments received within the respective comment periods will be considered in the final determinations regarding the applications. Comments should include the name, address and telephone number of the writer and a concise statement to inform the Department of the exact basis of a comment and the relevant facts upon which it is based.

The Department will also accept requests for a public hearing on applications. A public hearing may be held if the responsible office considers the public response significant. If a hearing is scheduled, a notice of the hearing will be published in the *Pennsylvania Bulletin* and a newspaper of general circulation within the relevant geographical area. The Department will postpone its final determination until after a public hearing is held.

LAND RECYCLING AND ENVIRONMENTAL REMEDIATION

UNDER ACT 2, 1995

PREAMBLE 1

Acknowledgment of Notices of Intent to Remediate Submitted under the Land Recycling and Environmental Remediation Standards Act (35 P.S. §§ 6026.101–6026.908).

Sections 302–305 of the Land Recycling and Environmental Remediation Standards Act (act) require the Department of Environmental Protection (Department) to publish in the *Pennsylvania Bulletin* an acknowledgment noting receipt of Notices of Intent to Remediate. Furthermore, the person shall not be subject to citizen suits or other contribution actions brought by responsible persons not participating in the remediation.

Under sections 304(n)(1)(ii) and 305(c)(2) of the act, there is a 30-day public and municipal comment period for sites proposed for remediation using a Site-Specific Standard, in whole or in part, and for sites remediated as a special industrial area. This period begins when a summary of the Notice of Intent to Remediate is published in a newspaper of general circulation in the area of the site. For the sites identified, proposed for remediation to a Site-Specific Standard or as a special industrial area, the municipality within which the site is located may request to be involved in the development of the remediation and reuse plans for the site if the request is made within 30 days of the date specified. During this comment period, the municipality may request that the person identified as the remediator of the site develop and implement a public involvement plan. Requests to be involved and comments should be directed to the remediator of the site.

Emission Restrictions

1. The total VOC from No. 3 Press shall not exceed 12.5 tpy in a 12-month rolling sum.

2. The permittee shall meet one of the following requirements for the fountain solution used on the press:

a. Maintain the as applied VOC content of the fountain solution at or below 5.0% by weight, or

b. Maintain the as applied VOC content of the fountain solution at or below 8.5% by weight, and refrigerate the fountain solution to 60° F or less, or

c. Maintain the as applied VOC content of the fountain at or below 10.0% by weight, and refrigerate the fountain solution to 55° F or less.

3. The permittee shall meet one of the following requirements for blanket and roller cleaning solutions used on the press:

a. VOC content, as applied, is less than or equal to 30% by weight; or

b. VOC composite partial vapor pressure, as used, is less than or equal to 10mmHg at 68° F.

4. Except specialty inks, the VOC content in the inks, as applied, shall not exceed 30% by weight.

Testing Requirements

1. The permittee shall determine the VOC content of fountain solution by one of the following procedures:

a. Analysis by USEPA Method 24 of a fountain solution sample, or

b. Calculation which combines USEPA Method 24 analytical VOC content data for the concentrated materials used to prepare the press ready fountain solution and records of the proportions in which they are mixed. The calculation shall only be performed once for each press ready fountain solution and kept in the form of a batch log. The analysis of the concentrated fountain solution may be performed by the suppliers of those materials.

2. The permittee shall determine the VOC content or VOC composite partial vapor pressure of cleaning solutions by one of the following procedures:

a. Analysis by USEPA Method 24 of a cleaning solution sample for VOC content or by an appropriate method for composite partial vapor pressure; or,

b. Calculation which combines USEPA Method 24 analytical VOC content data for the concentrated materials used to prepare the press ready cleaning solution and records of the proportions in which they are mixed. The calculation shall only be performed once for each press ready cleaning solution and kept in the form of a batch log. The analysis of the concentrated cleaning solution may be performed by the suppliers of those materials; or,

c. Calculation for VOC composite partial vapor pressure which combines analytical VOC vapor pressure data for the concentrated materials used to prepare the press ready cleaning solution and records of the proportions in which they are mixed. The analysis and vapor pressure determinations of the concentrated materials may be performed by the suppliers of the materials.

Monitoring Requirements

If using an automatic blanket wash system that mixes cleaning solution at the point of application, the permittee must demonstrate compliance with the VOC limitations for the blanket cleaning solutions, and shall document that flow meters or fixed volume spray systems result in the VOC content of the mixed solution complies with the VOC content in the blanket cleaning solutions.

Recordkeeping Requirements

1. The permittee shall collect and record the applicable information specified:

a. The ink usage in pounds or gallons in a monthly basis; the percent by weight VOC and HAP content, as applied, and, an estimate of VOC and HAP emissions. Alternately, the ink with the highest VOC and HAP content may be used to represent all inks used by the press.

b. The fountain solution and additive usage in pounds or gallons in a monthly basis; the percent by weight or weight to volume ration (lbs/gal) VOC and HAP content, and, an estimate of VOC and HAP emissions.

c. The blanket and roller cleaning solution usage in pounds or gallons in a monthly basis; the percent by weight or weight to volume ration (lbs/gal) VOC and HAP content, and, an estimate of VOC and HAP emissions.

d. For each month of operation, an estimate of VOC and HAP emissions during the latest 12 months.

2. The records shall be maintained at the facility for a minimum of 5 years and shall be made available to an authorized Department representative at any time during normal work hours.

Work Practice Requirements

1. The permittee shall keep all solvent containers closed at all times unless filling, draining or performing cleanup operations.

2. The permittee shall keep all solvent laden shop towels in a closed container when not being used.

Calculating Long-Term Operation and Maintenance Cost Bonds for Water Supply Replacement-Mining Operations; Notice of Rates

The Department of Environmental Protection (Department) announces the rates to be used to calculate bond amounts for water supply replacement operation and maintenance costs for anthracite and bituminous coal and industrial mineral mining operations. The authority for bonding mining operations is found under The Clean Streams Law (35 P.S. §§ 691.1—691.1001), the Surface Mining Conservation and Reclamation Act (52 P.S. §§ 1396.1—1396.19a), the Coal Refuse Disposal Control Act (52 P.S. §§ 30.51—30.66), the Bituminous Mine Subsidence and Land Conservation Act (52 P.S. §§ 1406.1—1406.21), the Noncoal Surface Mining Conservation and Reclamation Act (52 P.S. §§ 3301—3326) and the regulations promulgated thereunder at 25 Pa. Code Chapters 77 and 86 (relating to noncoal mining; and surface and underground coal mining; general).

The rates are used in calculating the water supply operation and maintenance bond amounts for replacement water supplies affected by activities at mining operations including: surface mines, coal refuse disposal sites, coal refuse reprocessing sites, coal processing facilities, underground coal mining operations and industrial mineral surface mines. The procedures for calculating water supply operation and maintenance bonds are described in technical guidance 562-4000-102, "Increased Operation and Maintenance Costs of Replacement Water Supplies," which is available on the Department's web site (www.depweb.state.pa.us), at the Public Participation Center page.

Bureau of Driver Licensing; Implementation of Commercial Driver Licensing Test Procedures

This Notice supersedes the Notice published at 26 Pa.B. 4142 (August 24, 1996) under Act 115-96, 75 Pa.C.S. § 1607A (relating to commercial driver's license qualification standards).

Commercial Driver Licensing Testing Procedures

Overview:

Driving examination for commercial driver's license.

(a) *General.* In addition to the knowledge examination an applicant for a commercial driver's license shall submit to a driving examination. The driving examination for a commercial driver's license shall be conducted in a test vehicle of the type or class the applicant desires to be licensed to operate. The applicant shall pass the following three parts of the examination:

- (1) A vehicle safety inspection.
- (2) A basic control skills test.
- (3) An on-road driving test.

(b) *Content of driving examination.* The driving examination is composed of methods and procedures that enable the examiner to determine the ability of the applicant to drive the type or class of vehicle for which the applicant desires to be licensed.

Section 1. Administration of vehicle safety inspection.

(a) *General.* The vehicle safety inspection requires that an applicant complete a safety examination of the test vehicle.

(b) *Conduct of the inspection.*

(1) The applicant and examiner will perform a walk around safety examination of the test vehicle. The vehicle safety inspection shall consist of checking:

- (i) All exterior lighting and reflectors.
 - (ii) The tires to ensure that they are in safe operating condition.
 - (iii) The exterior mirrors.
 - (iv) For major leaks (such as, air brakes, fluid, coolant, fuel tank, and the like)
- (2) The examiner will instruct the examinee to enter the vehicle and direct the examinee to operate the following controls:

- (i) Headlights (high/low beam) and marker lights.
 - (ii) Wipers/washers.
 - (iii) Turn signals.
 - (iv) Hazard warning lights (four ways).
 - (v) Taillights.
 - (vi) Brake lights.
 - (vii) Horn/horns.
 - (viii) Emergency safety equipment.
- (3) The applicant will be required to complete an air brake check of the test vehicle, if the vehicle is so equipped. The applicant shall:
- (i) Locate and verbally identify air brake operating controls and monitoring devices.
 - (ii) Determine the motor vehicles brake system condition for proper adjustments and that air system connections between motor vehicles have been properly made and secured.
 - (iii) Inspect the low pressure warning devices to insure that they will activate in emergency situations.
 - (iv) Ascertain, with the engine running, that the system maintains an adequate supply of compressed air.
 - (v) Determine that required minimum air pressure build up time is within acceptable limits and that required alarms and emergency devices automatically deactivate at the proper pressure level.
 - (vi) Operationally check the brake system for proper performance.

(4) In addition to the items in paragraphs (1), (2) and (3), the general condition of the following items shall be inspected and described by applicants who desire to be licensed to operate school buses only:

- (i) Passenger entry.
- (ii) Tires/Emergency exits (School buses only).
- (iii) Seating.
- (iv) Eight-way light system, activation and explanation.

(5) In addition to the items in paragraphs (1), (2) and (3), the general condition of the following items shall be inspected and described by applicants who desire to be licensed to operate coaches and transit buses:

- (i) Passenger entry.
- (ii) Emergency exits.
- (iii) Seating.

Section 2. Administration of basic control skill test.

(a) *General.* In addition to the vehicle safety inspection, the basic control skills test will be administered to an

applicant for a commercial driver's license. This test evaluates the applicant's ability and judgment to safely operate a commercial motor vehicle.

(b) *Content of test.* The basic control skills test is composed of methods and procedures which enable the examiner to determine the applicant's ability to control the vehicle and judge the position of the vehicle in relationship to other objects. The test will be administered in one of the forms described in paragraphs (1)—(4). The test will be conducted on an on-road or off-road test site. The examiner will select which form to use based on the layout of the test site.

- (1) *Form 1.* Straight line backing, alley docking, sight-side parallel parking and conventional parallel park.
- (2) *Form 2.* Right turn, alley docking, conventional parallel parking and backward serpentine.
- (3) *Form 3.* Straight line backing, alley docking, conventional parallel parking and backward serpentine.
- (4) *Form 4.* Straight line backing and one of the following: alley docking, backward serpentine, conventional parallel parking or sight-side parallel parking.

Section 3. Administration of on-road-driving test.

(a) *General.* In addition to the vehicle safety inspection and the basic control skills test, an applicant for a commercial driver's license shall submit to an on-road driving test.

(b) *Contents of test.* The on-road driving test is to evaluate the applicant's ability to operate a commercial motor vehicle safely in most on-road conditions, and is administered behind the wheel over a predetermined route on which the applicant shall perform one or more of the following maneuvers:

- (1) Driving and demonstrating lane changes in traffic.
- (2) Driving and executing left and right turns.
- (3) Driving on curves and demonstrating turning.
- (4) Driving and demonstrating expressway merging, lane changes and exit.
- (5) Demonstrating driving ability at intersection or railroad crossing, or both.
- (6) Demonstrating ability to start and stop on grade.
- (7) Driving on an up grade and down grade.
- (8) Driving on a bridge or through an underpass, or both.
- (9) Demonstrating general driving behavior.

The parties shall observe the following requirements for advance filing of witness information and exhibits. The

Board may exclude witnesses or exhibits of a party that fails to comply with these requirements. In addition, the parties shall have available in the hearing room at least 20 additional copies made available for the use of nonparties attending the hearing.

1. By 4 p.m. on March 18, 2008, the petitioner shall file with the Board, in person or by mail, one original and eight copies and ensure receipt by all other parties of one copy of:

a. A list of witnesses who will testify for the petitioner, along with a statement of the subjects concerning which each witness will testify. A witness who will be offered as an expert shall be so identified, along with the witness's area or areas of proposed expertise. For expert witnesses there shall also be filed a statement of the substance of the facts and opinions to which the expert is expected to testify and a summary of the grounds for each opinion.

b. Each exhibit to be presented, including testimony to be offered in written form.

2. By 4 p.m. on March 25, 2008, each responding party shall file and serve as set forth in paragraph 1 information concerning rebuttal witnesses and copies of rebuttal exhibits.

3. By 4 p.m. on March 31, 2008, parties shall file and serve as set forth in paragraph 1 information concerning surrebuttal witnesses and copies of surrebuttal exhibits.

The Board may exclude witnesses or exhibits of a party that fails to comply with the previous requirements. In addition, the parties shall have available in the hearing room at least 20 additional copies made available for the use of nonparties attending the hearing.

Parties that wish to offer in evidence documents on file with the Board, public documents or records in other proceedings before the Board, or wish the Board to take official notice of facts, shall comply with, respectively, 1 Pa. Code § 35.164, § 35.165, § 35.167 or § 35.173. Technical Conference and Evidentiary Hearings Regarding Transportation Assessments Doc. No. I-2008-2022003

At the public meeting held November 8, 2007, the Pennsylvania Public Utility Commission (Commission) approved assessment factors for transportation utilities based on the use of three utility groups. The utility groups used were: passenger motor carriers, property motor carriers and railroads. The result of using three utility groups has lowered the assessments for property motor carriers and substantially increased the assessments for passenger carriers and railroads. Objections have been filed by passenger motor carriers and railroads challenging their increased assessments.

By order adopted February 14, 2008, the Commission directed that a "Generic Investigation Regarding Transportation Assessments" be initiated at Docket No. I-2008-2022003 and that a technical conference and evidentiary hearings be held to provide an open forum in which interested stakeholders can address issues surrounding an equitable allocation of the Commission's costs of regulating the transportation industry before the allocation is finalized for Fiscal Year 2007-2008.

Accordingly, the Commission has referred all timely filed objections to the Office of Administrative Law Judge (OALJ) for hearing and decision. In addition, the Commission has directed OALJ to convene, on March 19, 2008, an on-the-record technical conference regarding transportation assessments, at which any interested person may participate by way of comments and/or sworn testimony. The technical conference will be held in Hearing Room No. 1, Keystone Building, 400 North Street, Harrisburg, PA, commencing at 10 a.m. The Fiscal Office and interested parties must prefile their comments or sworn testimony (original and nine copies) on or before March 14, 2008, addressed to Secretary, Pennsylvania Public Utility Commission, P. O. Box 3265, Harrisburg, PA 17105-3265 and referencing the previous docket number.

At the technical conference, the participants will be organized into panels for purposes of making presentations to the Commission. Witnesses who prepared testimony will be sworn, the testimony identified for the record and the witness will be given the opportunity to provide a summary of the testimony. The witness will be subject to questions from the Commissioners.

In addition, OALJ will assign an ALJ who will hold the further evidentiary hearings as may be necessary to address and resolve any generic issues regarding transportation assessments (such as, utility groupings, computation of direct hours, and the like) raised in the technical conference and individual objections, and may assign other ALJs to address utility-specific issues (such as, intrastate revenues, timeliness of objections, and the like). Petitions to intervene in the generic issues proceeding must be filed no later March 10, 2008, and should

reference the previous docket number. The prehearing conference for this generic proceeding will be held on March 14, 2008.

The ALJ assigned to handle the technical conference and generic issues will schedule any further hearings, as necessary, and establish a briefing schedule that will enable the Commission to render a final adjudication on allocation of the transportation assessment by the public meeting scheduled for June 12, 2008.

Due to the generic nature of the allocation issues that are expected to be raised, all assessments paid by transportation utilities for Fiscal Year 2007-2008, either in full or under the installment plan permitted by Commission order, are subject to reconciliation, refund and/or reassessment as may be directed in the Commission's final order following the technical conference and generic issues hearings.
