### Agricultural Business Development Center Farm Vitality Planning Grant Program; Extension of Application Deadline

The Department of Agriculture (Department) hereby provides notice that the application submittal deadline for grant applications under the Farm Vitality Planning Grant Program (Program) is extended to 4:59 p.m. on Tuesday, June 30, 2020.

The standards and requirements for the Program were published at 50 Pa.B. 20 (January 4, 2020) and can be reviewed online through [www.pacodeandbulletin.gov](http://www.pacodeandbulletin.gov). The Department will provide paper copies of these standards and requirements upon request directed to Morgan Sheffield, (717) 787-3568, [mshffield@pa.gov](mailto:mshffield@pa.gov).

The Program is established under the authority of the Agricultural Business Development Center Act (act) (3 Pa.C.S. §§ 4801—4810). The act allows the Department to award matching funds to farmers, prospective farmers and others in furtherance of the objectives set forth in the act. These objectives relate to enhancing the long-term

vitality of farms in this Commonwealth through sound business planning, efficient transitions of farm ownership, strategic farm expansion, diversification of agricultural production and building a team of financial and technical expertise as a resource for farmers in this Commonwealth.

Interested persons should review the published standards and requirements for the Program, as published. In summary, the Program's objective is to provide matching reimbursement grants of up to \$7,500 to eligible farmers, prospective farmers and others to help these grant recipients:

a. Create or obtain business plans and management strategies to enhance the long-term economic viability of a farm.

b. Create or obtain plans for the transition of ownership and operation of a farm to new owners and operators.

c. Create or obtain plans for transfer of ownership and operation of a farm within the farmer's family.

d. Create or obtain business planning to diversify an existing agricultural operation to new or different forms of agricultural production, including on-farm value-added processing and agritourism.

e. Maintain the long-term economic viability and protect the investment of public funds in preserving farms that are subject to perpetual agricultural conservation easements acquired under the Agricultural Area Security Law (3 P.S. §§ 901—915), for agricultural production.

f. Create or obtain business planning for a farm expansion or to seek financing for farm growth.

The application process is entirely electronic and is detailed in the standards and requirements for the Program. The Department will review complete grant applications in the order they are received and will award grants on a continuous basis until available funds are exhausted.

### Substantial Amendments to the 2017—2019 and Proposed 2020 Annual Action Plans

The Commonwealth will amend the methods of distribution (MOD) for the United States Department of Housing and Urban Development (HUD)-approved 2017—2019 Annual Action Plans and proposed 2020 Annual Action Plan for the Emergency Solutions Grant (ESG) allowing for more flexibility in response to the novel Coronavirus (COVID-19). Details of the amendments are listed as follows. The changes to the MOD constitute major changes to the Annual Action Plans submitted or proposed to HUD thus requiring a substantial amendment to each year's Action Plan, an additional 30-day citizen comment period and a public hearing. This notice starts the citizen comment period which runs from Sunday, April 5, 2020, through Monday, May 4, 2020. There is no change in the allocations of any of the HUD grant contracts.

The proposed amendments for the 2017—2019 and proposed 2020 Annual Action Plans are as follows:

a. Remove the Department of Community and Economic Development's (Department) minimum allocation percentage for the rapid rehousing activity (40%) from each ESG grant MOD.

b. Add, in each program year, no more than 60% of the annual Federal allocation may be used for emergency shelter activities (including operations, essential services and street outreach).

c. Remove Department maximum of 20% of allocation for emergency shelter activities (operations, essential

services and street outreach) and remove cap of operational support as a percentage of overall operating budget.

d. Allow Balance of State (non-Federal entitlement) subgrantees to request modifications to their existing contracts for these years, based on specific and locally identified needs, to any allowable ESG activity. (Revisions may not exceed HUD threshold for emergency shelter activity at 60%.)

e. Allow Federal direct-entitlement ESG grantees to request modifications to their existing contracts or seek funding in these years for either rapid rehousing activities or homeless prevention activities. Rapid rehousing must still represent at least 40% of the overall use of ESG funds for direct entitlement communities only.

The applications concern, but are not limited to, discharges regarding industrial, animal or sewage waste, discharges to groundwater, discharges associated with municipal separate storm sewer systems (MS4), stormwater associated with construction activities or concentrated animal feeding operations (CAFO). This notice is provided in accordance with 25 Pa. Code Chapters 91 and 92a and 40 CFR Part 122, implementing The Clean Streams Law (35 P.S. §§ 691.1–691.1001) and the Federal Clean Water Act (33 U.S.C.A. §§ 1251–1376).

For NPDES renewal applications in Section I, the Department of Environmental Protection (Department) has made a tentative determination to reissue these permits for 5 years subject to effluent limitations and monitoring and reporting requirements in their current permits, with appropriate and necessary updated requirements to reflect new and changed regulations and other requirements.

For applications for new NPDES permits and renewal applications with major changes in Section II, as well as applications for MS4 Individual Permits and Individual Stormwater Construction Permits in Sections IV and VI, the Department, based upon preliminary reviews, has made tentative determinations of proposed effluent limitations and other terms and conditions for the permit applications. In accordance with 25 Pa. Code § 92a.32(d), the proposed discharge of stormwater associated with construction activities will be managed in accordance with the requirements of 25 Pa. Code Chapter 102. These determinations are published as proposed actions for comments prior to taking final actions.

Unless indicated otherwise, the United States Environmental Protection Agency (EPA) Region III Administrator has waived the right to review or object to proposed NPDES permit actions under the waiver provision in 40 CFR 123.24(d).

Persons wishing to comment on NPDES applications are invited to submit statements to the contact office noted before the application within 30-days from the date of this public notice. Persons wishing to comment on WQM permit applications are invited to submit statements to the office noted before the application within 15-days from the date of this public notice. Comments received within the respective comment periods will be considered in the final determinations regarding the applications. A comment submittal should include the name, address and telephone number of the writer and a concise statement to inform the Department of the exact basis of a comment and the relevant facts upon which it is based.

The Department will also accept requests for public hearings on applications. A public hearing may be held if the responsible office considers the public response significant. If a hearing is scheduled, a notice of the hearing will be published in the *Pennsylvania Bulletin* and a newspaper of general circulation within the relevant geographical area. The Department will postpone its final determination until after a public hearing is held.

**PLAN APPROVAL AND OPERATING PERMIT APPLICATIONS**

The Department has developed an “integrated” plan approval, State Operating Permit and Title V Operating Permit program. This integrated approach is designed to make the permitting process more efficient for the Department, the regulated community and the general public. This approach allows the owner or operator of a facility to submit permitting documents relevant to its application for all sources related to a facility or a proposed project, affords an opportunity for public input, and provides for a decision on the issuance of the necessary permits.

The Department received applications for Plan Approvals or Operating Permits from the following facilities. Copies of the application, the Department’s analysis, all pertinent documents used in the evaluation of the application and subsequently prepared proposed plan approvals/operating permits are available for public review during normal business hours at the appropriate Department Regional Office. Appointments for scheduling a review must be made by calling the appropriate Department Regional Office. The address and phone number of the Regional Office is listed before the application notices.

Persons wishing to file a written protest or provide comments or additional information, which they believe

A final report provides a description of the site investigation to characterize the nature and extent of contaminants in environmental media, the basis of selecting the environmental media of concern, documentation supporting the selection of residential or nonresidential exposure factors, a description of the remediation performed and summaries of sampling methodology and analytical results which demonstrate that the remediation has attained the cleanup standard selected. Plans and reports required by the act for compliance with selection of remediation to a site-specific standard, in addition to a final report, include a remedial investigation report, risk assessment report and cleanup plan. A remedial investigation report includes conclusions from the site investigation; concentration of regulated substances in environmental media; benefits of reuse of the property; and, in some circumstances, a fate and transport analysis. If required, a risk assessment report describes potential adverse effects caused by the presence of regulated substances. If required, a cleanup plan evaluates the abilities of potential remedies to achieve remedy requirements. A work plan for conducting a baseline remedial investigation is required by the act for compliance with selection of a special industrial area remediation. The baseline remedial investigation, based on the work plan, is compiled into the baseline environmental report to establish a reference point to show existing contamination, describe proposed remediation to be done and include a description of existing or potential

public benefits of the use or reuse of the property. The Department may approve or disapprove plans and reports submitted. This notice provides the Department's decision and, if relevant, the basis for disapproval.

D497 transmission line to the future Hill Top Energy Center Power Plant. The Project, as proposed, will require approximately 43.2 acres of earth disturbance and includes 518 linear feet of permanent impacts and 125 linear feet of temporary impacts to UNTs to Monongahela River (WWF), UNTs to Little Whiteley Creek (WWF), UNTs to Pegs Run (WWF) and a UNT to Glade Run (WWF), permanent impacts to 1.10 acre of floodway, 0.12 acre of permanent PEM wetland impacts, and 0.04 acre of temporary PEM wetland impacts. Mitigation will include restoring the disturbed area back to its original condition and elevation and stabilizing the disturbed area.

1. *Discharge Permit*—Applicant shall obtain and comply with a PADEP National Pollutant Discharge Elimination System (NPDES) permit for the discharge of water from the hydrostatic testing of the pipeline pursuant to Pennsylvania's Clean Streams Law (35 P.S. §§ 691.1—691.1001), and all applicable implementing regulations (25 Pa. Code Chapter 92a).

2. *Erosion and Sediment Control Permit*—Applicant shall obtain and comply with an Erosion and Sediment Control Permit(s) for earth disturbance associated with the Project issued pursuant to Pennsylvania's Clean Streams Law and Storm Water Management Act (32 P.S. §§ 680.1—680.17), 25 Pa. Code Chapter 102, and all other applicable implementing regulations.

3. *Water Obstruction and Encroachment Permits*—Applicant shall obtain and comply with a Water Obstruction and Encroachment Permit(s) for the construction, operation and maintenance of all stream and wetland crossings associated with the Project pursuant to Pennsylvania's Clean Streams Law, Dam Safety and Encroachments Act (32 P.S. §§ 693.1—693.27), and Flood Plain Management Act (32 P.S. §§ 679.101—679.601.), 25 Pa. Code Chapter 105, 25 Pa. Code Chapter 106, and all other applicable regulations.

6. *Inspection*—The Project, including all relevant records, are subject to inspection at reasonable hours and intervals by an authorized representative of PADEP or delegated County Conservation District to determine compliance with this SWQC, including all required permits, authorizations and approvals required by this State Water Quality Certification. The Applicant shall provide a copy of this SWQC to an authorized representative conducting an inspection of the Project.

7. *Transfer of Projects*—If Applicant intends to transfer any legal or equitable interest in the Project or any portion(s) thereof, the Applicant shall provide a copy of this SWQC and copies of any permits, authorizations or approvals obtained to comply with the SWQC upon the prospective transferee of the legal and equitable interest at least thirty (30) days prior to the contemplated transfer and shall simultaneously inform the appropriate PADEP Office of such intent. Notice to PADEP shall include a transfer agreement signed by the existing and new owners containing a specific date for transfer of responsibility, coverage, and liability under the SWQC and any permits, authorizations and approvals obtained to comply with the SWQC. The new owner shall submit to DEP a new application form for the SWQC and any permits, authorizations and approvals required to comply with the SWQC signed by the new owner.

9. *Reservation of Rights*—PADEP may modify, suspend or revoke this SWQC if (i) PADEP becomes aware of new facts about the Project that warrant such action; or (ii) PADEP determines that the Applicant has not complied with the terms and conditions of this SWQC. PADEP may require additional measures to achieve compliance with any applicable law or regulation.

10. *Other Laws*—Nothing in this SWQC shall be construed to preclude the institution of any legal action or to relieve Applicant from any responsibilities, liabilities, or penalties established pursuant to any applicable law or regulation.

11. *Severability*—The provisions of this SWQC are severable and should any provision of this SWQC be declared invalid or unenforceable, the remainder of the SWQC shall not be affected thereby.

The Department of Environmental Protection (Department) announces the continued availability of the Food Recovery Infrastructure Grant Program. This grant is an opportunity to apply for up to \$200,000 in grant funding offered through the new Food Recovery Infrastructure Grant Program. This funding is available for section 501(c)(3) nonprofit organizations in this Commonwealth (26 U.S.C.A. § 501(c)(3)) for grant assistance for the proper management and operation of food waste reduction under the Municipal Waste Planning, Recycling and Waste Reduction Act (Act 101) (53 P.S. §§ 4000.101—4000.1904). The grant application deadline has been extended to June 26, 2020.

Food recovery infrastructure grants will be awarded to nonprofit organizations for the procurement of equipment (refrigerators, freezers, refrigerant vehicles, hand fork lifts, and the like) to reduce food waste disposal from food retailers and wholesalers by repurposing and redistributing apparently safe and wholesome foods to nonprofits in this Commonwealth that provide food to segments of the public. The nonprofit must describe their current food recovery operation and explain how the food infrastructure equipment will enhance their current program. The organization must also provide a description of their proposed program and provide what food retailers or wholesalers (grocery stores, and the like) will be partners for the project. Additionally, the organization must provide a description of how the program will be operated by staff or volunteers, or both.

Grant awards are predicated on the receipt of recycling fees required by sections 701 and 702 of Act 101 (53 P.S. §§ 4000.701 and 4000.702) and the availability of moneys in the Recycling Fund.

The maximum grant to a nonprofit organization cannot exceed \$200,000 per calendar year for the procurement of food infrastructure equipment attributable exclusively to the grant project. Potential applicants are required to meet with their Department Regional Planning and Recycling Coordinator prior to submitting an application for funding consideration. A list of regional planning and recycling coordinators is provided at the end of this notice.

### Pennsylvania Bloomin' Bucks Fast Play Game 5084

Under the State Lottery Law (72 P.S. §§ 3761-101—3761-314) and 61 Pa. Code § 803.11 (relating to powers and duties of the Secretary of Revenue), the Secretary of Revenue hereby provides public notice of the rules for the following lottery game:

1. *Name:* The name of the lottery game is Pennsylvania Bloomin' Bucks (hereinafter "Bloomin' Bucks"). The game number is PA-5084.

2. *Definitions:*

(a) *Authorized retailer or retailer:* A person who is properly licensed by the Lottery pursuant to 61 Pa. Code §§ 805.1—805.17.

(b) *Bar code:* The symbology on the ticket containing certain encrypted validation and accounting data used for identifying winning and losing tickets.

(c) *Game Ticket:* A bearer instrument produced through a Lottery Terminal that is the player's record of a play for a Fast Play lottery game and sold by an authorized retailer containing the play and validation data as published in this game notice.

(d) *Lottery Central Computer System:* The computer gaming system on which all Fast Play plays are recorded.

(e) *Lottery Terminal:* A device authorized by the Lottery to function in an interactive mode with the Lottery Central Computer System for the purpose of issuing plays, executing Quick Pick selections, and entering, receiving, and processing lottery transactions, including making purchases, validating plays, transmitting reports, and performing inventory functions.

(f) *Play:* A chance to participate in a particular Fast Play lottery game.

(g) *Play Area:* The area on a ticket which contains one or more play symbols.

(h) *Play Symbol:* A number, letter, symbol, image or other character found in the play area which is used to determine whether a player wins a prize.

(i) *Prize:* A non-monetary item, money, or experience that can be won as specified in section 6 (relating to prizes available to be won and determination of prize winners) of this game notice.

(j) *PROGRESSIVE TOP PRIZE:* The top prize available for this game that begins with a minimum prize amount that grows at a pre-determined rate every time a

ticket is purchased, and then resets to the minimum prize amount whenever a top prize winning ticket is sold.

(k) *ROW:* A specific, pre-defined portion of the play area, which contains three play symbols and a prize symbol in a horizontal line, that when played according to the instructions, determine whether a player wins a prize. Each "ROW" is played separately.

(l) *WINNING SYMBOL:* The number, letter, symbol or other characters found in the play area that, when matched against the play symbols in any "ROW," determine whether a player wins a prize.

(m) *Winning ticket:* A game ticket which has been validated and qualifies for a prize.

3. *Price:* The price of a Bloomin' Bucks ticket is \$1.

4. *Description of the Bloomin' Bucks Fast Play lottery game:*

(a) The Bloomin' Bucks lottery game is an instant win game printed from a Lottery Terminal. With the exception of the "PROGRESSIVE TOP PRIZE" amount, all prizes are predetermined, and the player does not have the ability to select their own play symbols. Bloomin' Bucks tickets may be purchased from an authorized retailer or at a Lottery self-service terminal that sells terminal-based Lottery game tickets. Tickets purchased from an authorized retailer shall be printed on-demand at the time of purchase and may not be preprinted by the retailer.

(b) Bloomin' Bucks is played by matching the play symbol in the "WINNING SYMBOL" area to any of the play symbols located in each "ROW." A player matching one of the play symbols in the same "ROW" will win the prize shown to the right of that "ROW." When a Bloomin' Bucks (BLOOMIN) symbol appears in a winning "ROW," double the prize shown for that "ROW." The "PROGRESSIVE TOP PRIZE" cannot be doubled. A bet slip is not used to play this game.

(c) Players can win the prize identified in section 6 (relating to prizes available to be won and determination of prize winners).

(d) A Bloomin' Bucks game ticket cannot be canceled or voided once printed by the Lottery Terminal, even if printed in error.

(e) To purchase a ticket at an authorized retailer, a player must remit the purchase price to the retailer and verbally request a Bloomin' Bucks game ticket. The ticket shall be the only valid proof of the bet placed and the only valid receipt for claiming a prize.

(f) To purchase a ticket at a Pennsylvania Lottery self-service terminal, the player must insert into the self-service terminal a dollar amount equal to the total purchase price of a Bloomin' Bucks game ticket and select the Bloomin' Bucks option on the Lottery self-service terminal. The ticket shall be the only valid proof of the bet placed and the only valid receipt for claiming a prize.

5. *Bloomin' Bucks ticket characteristics:*

(a) A Bloomin' Bucks ticket shall contain a play area, the cost of the play, the date of sale, and a bar code. Each ticket consists of four "ROW" areas. Each "ROW" is played separately.

(b) *Play Symbols:* Each Bloomin' Bucks ticket will contain a "WINNING SYMBOL" area and four "ROW" areas. The play symbols and their captions, located in the "WINNING SYMBOL" area, are: Tulip (TULIP) symbol, Rose (ROSE) symbol, Cherry Blossom (CHERRY) symbol,

Lotus Flower (LOTUS) symbol, Lily (LILY) symbol, Sunflower (SUNFLWR) symbol, Daisy (DAISY) symbol, Waterlily (WTRLY) symbol, Four Leaf Clover (CLOVER) symbol, Orchid (ORCHID) symbol, Balloon Flower (BALLOON) symbol, Starflower (STAR) symbol, Periwinkle (PRWNKL) symbol, Aubrieta (AUBRIETA) symbol, Cosmos (COSMOS) symbol, Snowflake Flower (SNWFLK) symbol, Flower Blossom (BLOSSOM) symbol, Dandelion (DANDLN) symbol, Golden Marguerite (GOLDEN) symbol and a Plumeria (PLUMERIA) symbol. The play symbols and their captions, located in the four "ROW" areas, are: Tulip (TULIP) symbol, Rose (ROSE) symbol, Cherry Blossom (CHERRY) symbol, Lotus Flower (LOTUS) symbol, Lily (LILY) symbol, Sunflower (SUNFLWR) symbol, Daisy (DAISY) symbol, Waterlily (WTRLY) symbol, Four Leaf Clover (CLOVER) symbol, Orchid (ORCHID) symbol, Balloon Flower (BALLOON) symbol, Starflower (STAR) symbol, Periwinkle (PRWNKL) symbol, Aubrieta (AUBRIETA) symbol, Cosmos (COSMOS) symbol, Snowflake Flower (SNWFLK) symbol, Flower Blossom (BLOSSOM) symbol, Dandelion (DANDLN) symbol, Golden Marguerite (GOLDEN) symbol, Plumeria (PLUMERIA) symbol, and a Bloomin Buck (BLOOMIN) symbol.

(c) *Prize symbols:* The prize symbols and their captions located in the "ROW" areas are: \$1<sup>00</sup> (ONE DOL), \$2<sup>00</sup> (TWO DOL), \$4<sup>00</sup> (FOR DOL), \$5<sup>00</sup> (FIV DOL), \$10<sup>00</sup> (TEN DOL), \$20<sup>00</sup> (TWENTY), \$40<sup>00</sup> (FORTY), \$100 (ONE HUN) and PROG (TOP PRIZE).

(d) *Prizes:* The prizes that can be won in this game are: \$1, \$2, \$4, \$5, \$10, \$20, \$40, \$100 and the "PROGRESSIVE TOP PRIZE." The "PROGRESSIVE TOP PRIZE" amount starts at \$2,000 and increases by \$0.10 every time a Bloomin' Bucks ticket is purchased. When a "PROGRESSIVE TOP PRIZE" winning ticket is sold, the "PROGRESSIVE TOP PRIZE" resets to \$2,000. Bloomin' Bucks contains a feature that can double the prize in any "ROW" as detailed in section 4 (relating to description of the Bloomin' Bucks Fast Play lottery game). For a complete list of prizes that can be won in this game, including multiplied prizes, see section 7 (relating to number and description of prizes and approximate chances of winning). A player can win up to four times on a ticket.

(e) *Approximate number of tickets available for the game:* Approximately 2,400,000 tickets will be available for sale for the Bloomin' Bucks lottery game.

6. *Prizes available to be won and determination of prize winners:*

(a) All Bloomin' Bucks prize payments will be made as one-time, lump-sum cash payments.

(b) Holders of tickets upon which the "WINNING SYMBOL" play symbol matches one of the play symbols in the same "ROW," and a prize symbol of PROG (TOP PRIZE) appears in the "Prize" area for that "ROW," on a single ticket, shall be entitled to a prize of a "PROGRESSIVE TOP PRIZE." The amount won under this paragraph is the amount of the "PROGRESSIVE TOP PRIZE," determined by the Lottery Central Computer System, as of the time the winning ticket was purchased. The amount won will be a minimum of \$2,000.

(c) Holders of tickets upon which the "WINNING SYMBOL" play symbol matches one of the play symbols in the same "ROW," and a prize symbol of \$100 (ONE HUN) appears in the "Prize" area for that "ROW," on a single ticket, shall be entitled to a prize of \$100.

(d) Holders of tickets upon which the "WINNING SYMBOL" play symbol matches one of the play symbols in the same "ROW," and a prize symbol of \$40<sup>00</sup> (FORTY) appears in the "Prize" area for that "ROW," and in which a Bloomin Buck (BLOOMIN) play symbol appears in the same "ROW," on a single ticket, shall be entitled to a prize of \$80.

(e) Holders of tickets upon which the "WINNING SYMBOL" play symbol matches one of the play symbols in the same "ROW," and a prize symbol of \$40<sup>00</sup> (FORTY) appears in the "Prize" area for that "ROW," on a single ticket, shall be entitled to a prize of \$40.

(f) Holders of tickets upon which the "WINNING SYMBOL" play symbol matches one of the play symbols in the same "ROW," and a prize symbol of \$20<sup>00</sup> (TWENTY) appears in the "Prize" area for that "ROW," and in which a Bloomin Buck (BLOOMIN) play symbol appears in the same "ROW," on a single ticket, shall be entitled to a prize of \$40.

(g) Holders of tickets upon which the "WINNING SYMBOL" play symbol matches one of the play symbols in the same "ROW," and a prize symbol of \$20<sup>00</sup> (TWENTY) appears in the "Prize" area for that "ROW," on a single ticket, shall be entitled to a prize of \$20.

(h) Holders of tickets upon which the "WINNING SYMBOL" play symbol matches one of the play symbols in the same "ROW," and a prize symbol of \$10<sup>00</sup> (TEN DOL) appears in the "Prize" area for that "ROW," and in which a Bloomin Buck (BLOOMIN) play symbol appears in the same "ROW," on a single ticket, shall be entitled to a prize of \$20.

(k) Holders of tickets upon which the "WINNING SYMBOL" play symbol matches one of the play symbols in the same "ROW," and a prize symbol of \$4<sup>00</sup> (FOR DOL) appears in the "Prize" area for that "ROW," and in which a Bloomin Buck (BLOOMIN) play symbol appears in the same "ROW," on a single ticket, shall be entitled to a prize of \$8.

(l) Holders of tickets upon which the "WINNING SYMBOL" play symbol matches one of the play symbols in the same "ROW," and a prize symbol of \$5<sup>00</sup> (FIV DOL) appears in the "Prize" area for that "ROW," on a single ticket, shall be entitled to a prize of \$5.

(m) Holders of tickets upon which the "WINNING SYMBOL" play symbol matches one of the play symbols in the same "ROW," and a prize symbol of \$4<sup>00</sup> (FOR DOL) appears in the "Prize" area for that "ROW," on a single ticket, shall be entitled to a prize of \$4.

(n) Holders of tickets upon which the "WINNING SYMBOL" play symbol matches one of the play symbols in the same "ROW," and a prize symbol of \$2<sup>00</sup> (TWO DOL) appears in the "Prize" area for that "ROW," and in which a Bloomin Buck (BLOOMIN) play symbol appears in the same "ROW," on a single ticket, shall be entitled to a prize of \$4.

(o) Holders of tickets upon which the "WINNING SYMBOL" play symbol matches one of the play symbols in the same "ROW," and a prize symbol of \$2.00 (TWO DOL) appears in the "Prize" area for that "ROW," on a single ticket, shall be entitled to a prize of \$2.

(p) Holders of tickets upon which the "WINNING SYMBOL" play symbol matches one of the play symbols in the same "ROW," and a prize symbol of \$1.00 (ONE DOL) appears in the "Prize" area for that "ROW," and in which a Bloomin Buck (BLOOMIN) play symbol appears in the

same "ROW," on a single ticket, shall be entitled to a prize of \$2.

(q) Holders of tickets upon which the "WINNING SYMBOL" play symbol matches one of the play symbols in the same "ROW," and a prize symbol of \$1.00 (ONE DOL) appears in the "Prize" area for that "ROW," on a single ticket, shall be entitled to a prize of \$1.

\*PROGRESSIVE TOP PRIZE: The minimum value of the PROGRESSIVE TOP PRIZE is \$2,000. The PROGRESSIVE TOP PRIZE increases by \$0.10 every time a ticket is purchased, and resets to \$2,000 whenever a top prize winning ticket is sold.

Prizes, including top prizes, are subject to availability at the time of purchase.

#### 8. Ticket responsibility:

(a) A Fast Play lottery game ticket is a bearer document deemed to be owned by the person holding the game ticket, except that if a name is contained on the back of the game ticket, the person named will, for all purposes, be considered the owner of the game ticket.

(b) The holder of a Fast Play lottery game ticket has the sole responsibility for checking the accuracy and condition of the data printed on the game ticket.

(c) The Commonwealth shall not be responsible for a lost or stolen Fast Play lottery game ticket, or for a Fast Play ticket redeemed by a player in error.

#### 9. Ticket validation and requirements:

(a) *Valid Fast Play lottery game tickets.* To be a valid Fast Play lottery game ticket, the presented game ticket must meet the following requirements:

(1) The game ticket's bar code shall be present in its entirety.

(2) The game ticket must be intact.

(3) The game ticket may not be mutilated, altered, reconstituted or tampered with.

(4) The game ticket may not be counterfeit or a duplicate of a winning ticket.

(5) The game ticket must have been validly issued.

(6) The game ticket data shall have been recorded on the Lottery Central Computer System and the game ticket data shall match the computer record in every respect.

(7) The game ticket must not be defectively printed or printed or produced in error such that it cannot be processed or validated by the Lottery.

(8) The game ticket must pass other confidential security checks of the Lottery.

(b) *Invalid or defective game tickets:* A game ticket not passing the validation requirements in subsection (a) will be considered invalid and no payment will be made on account of any play recorded thereon. The determination of the Secretary in this regard is final.

#### 10. Procedures for claiming and payment of prizes:

(a) A prize may be claimed through an authorized retailer or the Lottery, as provided in this section. A prize must be claimed within 1 year of the sale date of the Fast Play lottery game ticket.

(b) An authorized retailer is authorized to pay prizes of \$2,500 or less. The holder of a game ticket evidencing a winning play representing a prize of \$2,500 or less may be paid by a participating authorized retailer if a proper validation pay ticket was issued by the retailer's Lottery Terminal.

(c) The holder of a game ticket evidencing a winning play representing a prize in excess of \$2,500 may present the game ticket to an authorized retailer, Lottery District Office, or Lottery Headquarters.

(d) The holder of a game ticket evidencing a winning play shall present the ticket, in person, to an authorized retailer, Lottery Headquarters or a Lottery District Office. The retailer or the Lottery will issue payment if:

(1) The game ticket is scanned and the play is validated through the Lottery Terminal or the Lottery Central Computer System;

(2) A claim form is properly and fully completed;

(3) The identification of the claimant is confirmed; and

(4) The winning ticket has not expired, pursuant to this section or section 12 (relating to unclaimed prizes).

(e) The Commonwealth shall not be responsible for a winning play paid in error by an authorized retailer.

(f) In the event a prize described in these rules is not available, the Lottery may either provide a substitute prize, determined by the Secretary to have an equivalent value to the prize won, or make a cash payment to the winner, in an amount determined by the Secretary to have an equivalent value to the prize won.

11. *Funding for prizes:* Moneys will be drawn from the State Lottery Fund, to the extent necessary, to fund the payment of prizes under this section. If this lottery game is terminated for any cause, prize moneys remaining undistributed will remain in the State Lottery Fund and used for purposes otherwise provided for by law.

12. *Unclaimed prizes:* Unclaimed prize money on winning Fast Play lottery game tickets will be retained by the Secretary for payment to the persons entitled thereto for 1 year from the sale date of the Fast Play lottery game ticket. If no claim is made within 1 year from the

sale date of the Fast Play lottery game ticket, the right of a ticket holder to claim the prize represented by that ticket, if any, shall expire.

13. *Purchase and prize restrictions:* A Fast Play lottery game ticket may not be purchased by, and a prize may not be paid, to an officer or employee of the Lottery, Lottery professional services contractors or subcontractors, or to a spouse, child, brother, sister or parent residing in the same household of an officer, employee, contractor or subcontractor who is involved in the production, distribution or operation of systems for the validation or accounting of Fast Play games.

14. *“PROGRESSIVE TOP PRIZE” restrictions:*

(a) An amount of \$0.10 from the sale of each Bloomin’ Bucks ticket will be accumulated in the “PROGRESSIVE TOP PRIZE” pool.

(b) *Prize Amount:* The amount of the “PROGRESSIVE TOP PRIZE” at the time a ticket is purchased can only be verified through the Lottery’s Central Computer System. Any advertisement or any materials describing the amount of the “PROGRESSIVE TOP PRIZE” are only valid as of the time they are posted. If any discrepancy exists between this notice and any material describing or advertising the Bloomin’ Bucks game, this notice and the data contained in the Lottery’s Central Computer System shall govern.

(c) The “PROGRESSIVE TOP PRIZE” and all other prizes are subject to availability at the time of purchase. The Lottery is not responsible for prizes that are not awarded due to technical issues. In the event of a “PROGRESSIVE TOP PRIZE” being reset without the actual sale of a “PROGRESSIVE TOP PRIZE” winning ticket, all prize money that had accumulated into the “PROGRESSIVE TOP PRIZE” pool (i.e. \$0.10 from the sale of each ticket) shall be awarded as part of the next “PROGRESSIVE TOP PRIZE” won.

(d) Prizes payable to “PROGRESSIVE TOP PRIZE” winners will be paid as a one-time cash payment. For the purposes of calculation of the prize to be paid to “PROGRESSIVE TOP PRIZE” winners, the “PROGRESSIVE TOP PRIZE” amount will be rounded up to the nearest \$0.50.

15. *Governing law:*

(a) By purchasing a ticket, the purchaser agrees to comply with and abide by the State Lottery Law (72 P.S. §§ 3761-101—3761-314), this notice, instructions, conditions and final decisions of the Secretary, and procedures established by the Secretary for the conduct of the Fast Play Bloomin’ Bucks lottery game.

(b) Decisions made by the Secretary, including the declaration of prizes and the payment thereof, in interpretation of this notice are final and binding on players and persons making a claim in respect thereof.

16. *Retailer compensation:*

(a) Authorized retailers may be entitled to compensation as determined by the Lottery.

(b) No authorized retailer or employee of an authorized retailer shall request, demand, or accept gratuities or any compensation other than as provided in subsection (a) in exchange for the performance of duties authorized pursuant to the Lottery retailer’s license without the Lottery’s prior written authorization.

17. *Retailer Incentive Programs:* The Lottery may conduct a separate Retailer Incentive Program for retailers who sell Pennsylvania Fast Play Bloomin’ Bucks lottery game tickets.

18. *Retailer bonus:* The Lottery may offer a retailer bonus in connection with the sale of Pennsylvania Fast Play lottery game tickets. If a retailer bonus is offered, a Lottery retailer shall be eligible for a bonus as described in this section. Lottery retailers who sell a winning ticket that entitles the ticket holder to a prize, either payable in a single installment or having a guaranteed minimum payout, of at least \$100,000 and not exceeding \$500,000 shall be paid a bonus of \$500. Lottery retailers who sell a winning ticket that entitles the ticket holder to a prize, either payable in a single installment or having a guaranteed minimum payout, of at least \$500,001 and not exceeding \$1,000,000 shall be paid a bonus of \$5,000. Lottery retailers who sell a winning ticket that entitles the ticket holder to a prize, either payable in a single installment or having a guaranteed minimum payout, of at least \$1,000,001 and not exceeding \$10,000,000 shall be paid a bonus of \$10,000. A Lottery retailer is entitled only to the largest bonus for which they qualify on a winning ticket. A bonus will be initiated for payment after the Fast Play game ticket is claimed and validated. A bonus will not be awarded to a Lottery retailer that sells a non-winning Pennsylvania Lottery Fast Play game ticket used to enter a Pennsylvania Lottery second-chance drawing or promotion that is subsequently selected to win a prize.

19. *Termination of the game:* The Secretary may announce a termination date, after which no further tickets from this game may be sold. The announcement will be disseminated through media used to advertise or promote Bloomin’ Bucks or through normal communications methods.

20. *Applicability:* This notice applies only to the Bloomin’ Bucks lottery game announced in this notice.

### Pennsylvania The Money Game Fast Play Game 5083

Under the State Lottery Law (72 P.S. §§ 3761-101—3761-314) and 61 Pa. Code § 803.11 (relating to powers and duties of the Secretary of Revenue), the Secretary of Revenue hereby provides public notice of the rules for the following lottery game:

1. *Name:* The name of the lottery game is Pennsylvania The Money Game (hereinafter “The Money Game”). The game number is PA-5083.

2. *Definitions:*

(a) *Authorized retailer or retailer:* A person who is properly licensed by the Lottery pursuant to 61 Pa. Code §§ 805.1—805.17.

(b) *Bar code:* The symbology on the ticket containing certain encrypted validation and accounting data used for identifying winning and losing tickets.

(c) *BONUS GAME PLAY SYMBOLS:* The 12 symbols, found outside of the “YOUR NUMBERS” area that, when matched according to the instructions, determine whether the player wins one of the prizes shown in the “BONUS

GAME PRIZE LEGEND.” The “BONUS GAME PLAY SYMBOLS” in this game are as follows:

- (1) Star Play Symbol:  ;
- (2) Swirl Play Symbol:  ; and
- (3) Coin Play Symbol: 

(d) *BONUS GAME PRIZE LEGEND*: The area on the game ticket that shows a player the corresponding prize that can be won by finding at least three Coin “BONUS GAME PLAY SYMBOLS,” as further described above.

(e) *Game Ticket*: A bearer instrument produced through a Lottery Terminal that is the player’s record of a play for a Fast Play lottery game and sold by an authorized retailer containing the play and validation data as published in this game notice.

(f) *Lottery Central Computer System*: The computer gaming system on which all Fast Play plays are recorded.

(g) *Lottery Terminal*: A device authorized by the Lottery to function in an interactive mode with the Lottery Central Computer System for the purpose of issuing plays, executing Quick Pick selections, and entering, receiving, and processing lottery transactions, including making purchases, validating plays, transmitting reports, and performing inventory functions.

(h) *Play*: A chance to participate in a particular Fast Play lottery game.

(i) *Play Area*: The area on a ticket which contains one or more play symbols.

(j) *Play Symbol*: A number, letter, symbol, image or other character found in the play area which is used to determine whether a player wins a prize.

(k) *Prize*: A non-monetary item, money, or experience that can be won as specified in section 6 (relating to prizes available to be won and determination of prize winners) of this game notice.

(l) *WINNING NUMBERS*: The numbers, letters, symbols or other characters found in the play area that, when matched against the play symbols in the “YOUR NUMBERS” area, determine whether a player wins a prize.

(m) *Winning ticket*: A game ticket which has been validated and qualifies for a prize.

(n) *YOUR NUMBERS*: The numbers, letters, symbols or other characters found in the play area that, when matched against the play symbols in the “WINNING NUMBERS” area, determine whether a player wins a prize.

3. *Price*: The price of a The Money Game ticket is \$5.

4. *Description of The Money Game Fast Play lottery game*:

(a) The Money Game lottery game is an instant win game printed from a Lottery Terminal. All prizes are predetermined, and the player does not have the ability to select their own play symbols. The Money Game tickets may be purchased from an authorized retailer or at a Lottery self-service terminal that sells terminal-based Lottery game tickets. Tickets purchased from an autho-

rized retailer shall be printed on-demand at the time of purchase and may not be preprinted by the retailer.

(b) The Money Game has two ways to win a prize. A bet slip is not used to play this game.

(1) *Key Number Match*: The Money Game is played by matching the play symbols located in the “YOUR NUMBERS” area to the play symbols located in the “WINNING NUMBERS” area. A player correctly matching a “YOUR NUMBERS” play symbol to a “WINNING NUMBERS” play symbol wins the prize shown to the right of the matching “YOUR NUMBERS” play symbol.

(2) *Count Up*: Players finding three or more Coin “BONUS GAME PLAY SYMBOLS” in the play area will win the corresponding prize shown in the “BONUS GAME PRIZE LEGEND.”

(c) Players can win the prize identified in section 6 (relating to prizes available to be won and determination of prize winners).

(d) The Money Game tickets cannot be canceled or voided once printed by the Lottery Terminal, even if printed in error.

(e) To purchase a ticket at an authorized retailer, a player must remit the purchase price to the retailer and verbally request a The Money Game ticket. The ticket shall be the only valid proof of the bet placed and the only valid receipt for claiming a prize.

(f) To purchase a ticket at a Pennsylvania Lottery self-service terminal, the player must insert into the self-service terminal a dollar amount equal to the total purchase price of a The Money Game ticket and select The Money Game option on the Lottery self-service terminal. The ticket shall be the only valid proof of the bet placed and the only valid receipt for claiming a prize.

#### 5. *The Money Game ticket characteristics*:

(a) The Money Game tickets shall contain a play area, the cost of the play, the date of sale, and a bar code.

(b) *Play Symbols*: The Money Game tickets will contain a “WINNING NUMBERS” area and a “YOUR NUMBERS” area. The play symbols and their captions, located in the “WINNING NUMBERS” area and the “YOUR NUMBERS” area, are: 1 (ONE), 2 (TWO), 3 (THREE), 4 (FOUR), 5 (FIVE), 6 (SIX), 7 (SEVEN), 8 (EIGHT), 9 (NINE), 10 (TEN), 11 (ELEVN), 12 (TWLV), 13 (THRTN), 14 (FORTN), 15 (FIFTN), 16 (SIXTN), 17 (SVNTN), 18 (EGHTN), 19 (NINTN), 20 (TWENT), 21 (TWYONE), 22 (TWYTWO), 23 (TWYTHR), 24 (TWYFOR), 25 (TWYFIV), 26 (TWYSIX), 27 (TWYSVN), 28 (TWYEGT), 29 (TWYNIN) and 30 (THIRT). The “BONUS GAME PLAY SYMBOLS” located in the play area are: Star symbol, Swirl symbol and Coin symbol.

(c) *Prize Symbols*: The prizes symbols and their captions located in the play area are: \$5<sup>00</sup> (FIV DOL), \$10<sup>00</sup> (TEN DOL), \$15<sup>00</sup> (FIFTEEN), \$20<sup>00</sup> (TWENTY), \$40<sup>00</sup> (FORTY), \$50<sup>00</sup> (FIFTY), \$100 (ONE HUN), \$500 (FIV HUN), \$1,000 (ONE THO), \$5,000 (FIV THO) and \$50,000 (FTY THO).

(d) *Prizes*: The prizes that can be won in this game are: \$5, \$10, \$15, \$20, \$40, \$50, \$100, \$500, \$1,000, \$5,000 and \$50,000. The prizes that can be won in the “BONUS GAME” are: \$10, \$20 and \$50.

(e) *Approximate number of tickets available for the game:* Approximately 2,400,000 tickets will be available for sale for The Money Game lottery game.

6. *Prizes available to be won and determination of prize winners:*

(a) All The Money Game prize payments will be made as one-time, lump-sum cash payments.

(b) *Determination of prize winners for Key Number Match:*

(1) Holders of tickets upon which any one of the "YOUR NUMBERS" play symbols matches any of the "WINNING NUMBERS" play symbols and a prize symbol of \$50,000 (FTY THO) appears in the "Prize" area under the matching "YOUR NUMBERS" play symbol, on a single ticket, shall be entitled to a prize of \$50,000.

(2) Holders of tickets upon which any one of the "YOUR NUMBERS" play symbols matches any of the "WINNING NUMBERS" play symbols and a prize symbol of \$5,000 (FIV THO) appears in the "Prize" area under the matching "YOUR NUMBERS" play symbol, on a single ticket, shall be entitled to a prize of \$5,000.

(3) Holders of tickets upon which any one of the "YOUR NUMBERS" play symbols matches any of the "WINNING NUMBERS" play symbols and a prize symbol of \$1,000 (ONE THO) appears in the "Prize" area under the matching "YOUR NUMBERS" play symbol, on a single ticket, shall be entitled to a prize of \$1,000.

(4) Holders of tickets upon which any one of the "YOUR NUMBERS" play symbols matches any of the "WINNING NUMBERS" play symbols and a prize symbol of \$500 (FIV HUN) appears in the "Prize" area under the matching "YOUR NUMBERS" play symbol, on a single ticket, shall be entitled to a prize of \$500.

(5) Holders of tickets upon which any one of the "YOUR NUMBERS" play symbols matches any of the "WINNING NUMBERS" play symbols and a prize symbol of \$100 (ONE HUN) appears in the "Prize" area under the matching "YOUR NUMBERS" play symbol, on a single ticket, shall be entitled to a prize of \$100.

(6) Holders of tickets upon which any one of the "YOUR NUMBERS" play symbols matches any of the "WINNING NUMBERS" play symbols and a prize symbol of \$50<sup>00</sup> (FIFTY) appears in the "Prize" area under the matching "YOUR NUMBERS" play symbol, on a single ticket, shall be entitled to a prize of \$50.

(7) Holders of tickets upon which any one of the "YOUR NUMBERS" play symbols matches any of the "WINNING NUMBERS" play symbols and a prize symbol of \$40<sup>00</sup> (FORTY) appears in the "Prize" area under the matching "YOUR NUMBERS" play symbol, on a single ticket, shall be entitled to a prize of \$40.

(8) Holders of tickets upon which any one of the "YOUR NUMBERS" play symbols matches any of the "WINNING NUMBERS" play symbols and a prize symbol of \$20<sup>00</sup> (TWENTY) appears in the "Prize" area under the matching "YOUR NUMBERS" play symbol, on a single ticket, shall be entitled to a prize of \$20.

(9) Holders of tickets upon which any one of the "YOUR NUMBERS" play symbols matches any of the "WINNING NUMBERS" play symbols and a prize symbol of \$15<sup>00</sup> (FIFTEEN) appears in the "Prize" area under the matching "YOUR NUMBERS" play symbol, on a single ticket, shall be entitled to a prize of \$15.

(10) Holders of tickets upon which any one of the "YOUR NUMBERS" play symbols matches any of the "WINNING NUMBERS" play symbols and a prize symbol of \$10<sup>00</sup> (TEN DOL) appears in the "Prize" area under the matching "YOUR NUMBERS" play symbol, on a single ticket, shall be entitled to a prize of \$10.

(11) Holders of tickets upon which any one of the "YOUR NUMBERS" play symbols matches any of the "WINNING NUMBERS" play symbols and a prize symbol of \$5<sup>00</sup> (FIV DOL) appears in the "Prize" area under the matching "YOUR NUMBERS" play symbol, on a single ticket, shall be entitled to a prize of \$5.

(c) *Determination of prize winners for Count Up:*

(1) Holders of tickets upon which five Coin symbols appear in the play area, on a single ticket, shall be entitled to a prize of \$50.

(2) Holders of tickets upon which four Coin symbols appear in the play area, on a single ticket, shall be entitled to a prize of \$20.

(3) Holders of tickets upon which three Coin symbols appear in the play area, on a single ticket, shall be entitled to a prize of \$10.

7. *Number and description of prizes and approximate chances of winning.* The following table sets forth the approximate number of winners, amounts of prizes, and approximate chances of winning:

8. *Ticket responsibility:*

(a) A Fast Play lottery game ticket is a bearer document deemed to be owned by the person holding the game ticket, except that if a name is contained on the back of the game ticket, the person named will, for all purposes, be considered the owner of the game ticket.

(b) The holder of a Fast Play lottery game ticket has the sole responsibility for checking the accuracy and condition of the data printed on the game ticket.

(c) The Commonwealth shall not be responsible for a lost or stolen Fast Play lottery game ticket, or for a Fast Play ticket redeemed by a player in error.

9. *Ticket validation and requirements:*

(a) *Valid Fast Play lottery game tickets.* To be a valid Fast Play lottery game ticket, the presented game ticket must meet the following requirements:

(1) The game ticket's bar code shall be present in its entirety.

(2) The game ticket must be intact.

(3) The game ticket may not be mutilated, altered, reconstituted or tampered with.

(4) The game ticket may not be counterfeit or a duplicate of a winning ticket.

(5) The game ticket must have been validly issued.

(6) The game ticket data shall have been recorded on the Lottery Central Computer System and the game ticket data shall match the computer record in every respect.

(7) The game ticket must not be defectively printed or printed or produced in error such that it cannot be processed or validated by the Lottery.

(8) The game ticket must pass other confidential security checks of the Lottery.

(b) *Invalid or defective game tickets:* A game ticket not passing the validation requirements in subsection (a) will be considered invalid and no payment will be made on account of any play recorded thereon. The determination of the Secretary in this regard is final.

10. *Procedures for claiming and payment of prizes:*

(a) A prize may be claimed through an authorized retailer or the Lottery, as provided in this section. A prize must be claimed within 1 year of the sale date of the Fast Play lottery game ticket.

(b) An authorized retailer is authorized to pay prizes of \$2,500 or less. The holder of a game ticket evidencing a

winning play representing a prize of \$2,500 or less may be paid by a participating authorized retailer if a proper validation pay ticket was issued by the retailer's Lottery Terminal.

(c) The holder of a game ticket evidencing a winning play representing a prize in excess of \$2,500 may present the game ticket to an authorized retailer, Lottery District Office, or Lottery Headquarters.

(d) The holder of a game ticket evidencing a winning play shall present the ticket, in person, to an authorized retailer, Lottery Headquarters or a Lottery District Office. The retailer or the Lottery will issue payment if:

(1) The game ticket is scanned and the play is validated through the Lottery Terminal or the Lottery Central Computer System;

(2) A claim form is properly and fully completed;

(3) The identification of the claimant is confirmed; and

(4) The winning ticket has not expired, pursuant to this section or section 12 (relating to unclaimed prizes).

(e) The Commonwealth shall not be responsible for a winning play paid in error by an authorized retailer.

(f) In the event a prize described in these rules is not available, the Lottery may either provide a substitute prize, determined by the Secretary to have an equivalent value to the prize won, or make a cash payment to the winner, in an amount determined by the Secretary to have an equivalent value to the prize won.

11. *Funding for prizes:* Moneys will be drawn from the State Lottery Fund, to the extent necessary, to fund the payment of prizes under this section. If this lottery game is terminated for any cause, prize moneys remaining undistributed will remain in the State Lottery Fund and used for purposes otherwise provided for by law.

12. *Unclaimed prizes:* Unclaimed prize money on winning Fast Play lottery game tickets will be retained by the Secretary for payment to the persons entitled thereto for 1 year from the sale date of the Fast Play lottery game ticket. If no claim is made within 1 year from the sale date of the Fast Play lottery game ticket, the right of a ticket holder to claim the prize represented by that ticket, if any, shall expire.

13. *Purchase and prize restrictions:* A Fast Play lottery game ticket may not be purchased by, and a prize may not be paid, to an officer or employee of the Lottery, Lottery professional services contractors or subcontractors, or to a spouse, child, brother, sister or parent residing in the same household of an officer, employee, contractor or subcontractor who is involved in the production, distribution or operation of systems for the validation or accounting of Fast Play games.

#### 14. *Governing law:*

(a) By purchasing a ticket, the purchaser agrees to comply with and abide by the State Lottery Law (72 P.S. §§ 3761-101—3761-314), this notice, instructions, conditions and final decisions of the Secretary, and procedures established by the Secretary for the conduct of the Fast Play The Money Game lottery game.

(b) Decisions made by the Secretary, including the declaration of prizes and the payment thereof, in interpretation of this notice are final and binding on players and persons making a claim in respect thereof.

#### 15. *Retailer compensation:*

(a) Authorized retailers may be entitled to compensation as determined by the Lottery.

(b) No authorized retailer or employee of an authorized retailer shall request, demand, or accept gratuities or any compensation other than as provided in subsection (a) in exchange for the performance of duties authorized pursuant to the Lottery retailer's license without the Lottery's prior written authorization.

16. *Retailer Incentive Programs:* The Lottery may conduct a separate Retailer Incentive Program for retailers who sell Pennsylvania Fast Play The Money Game lottery game tickets.

17. *Retailer bonus:* The Lottery may offer a retailer bonus in connection with the sale of Pennsylvania Fast Play lottery game tickets. If a retailer bonus is offered, a Lottery retailer shall be eligible for a bonus as described in this section. Lottery retailers who sell a winning ticket that entitles the ticket holder to a prize, either payable in a single installment or having a guaranteed minimum payout, of at least \$100,000 and not exceeding \$500,000 shall be paid a bonus of \$500. Lottery retailers who sell a winning ticket that entitles the ticket holder to a prize, either payable in a single installment or having a guaranteed minimum payout, of at least \$500,001 and not exceeding \$1,000,000 shall be paid a bonus of \$5,000. Lottery retailers who sell a winning ticket that entitles the ticket holder to a prize, either payable in a single installment or having a guaranteed minimum payout, of at least \$1,000,001 and not exceeding \$10,000,000 shall be paid a bonus of \$10,000. A Lottery retailer is entitled only to the largest bonus for which they qualify on a winning ticket. A bonus will be initiated for payment after the Fast Play game ticket is claimed and validated. A bonus will not be awarded to a Lottery retailer that sells a non-winning Pennsylvania Lottery Fast Play game ticket used to enter a Pennsylvania Lottery second-chance drawing or promotion that is subsequently selected to win a prize.

18. *Termination of the game:* The Secretary may announce a termination date, after which no further tickets from this game may be sold. The announcement will be disseminated through media used to advertise or promote The Money Game or through normal communications methods.

19. *Applicability:* This notice applies only to The Money Game lottery game announced in this notice.

### Pennsylvania Towering 10\$ Fast Play Game 5082

Under the State Lottery Law (72 P.S. §§ 3761-101—3761-314) and 61 Pa. Code § 803.11 (relating to powers and duties of the Secretary of Revenue), the Secretary of Revenue hereby provides public notice of the rules for the following lottery game:

1. *Name*: The name of the lottery game is Pennsylvania Towering 10\$ (hereinafter "Towering 10\$"). The game number is PA-5082.

2. *Definitions*:

(a) *Authorized retailer or retailer*: A person who is properly licensed by the Lottery pursuant to 61 Pa. Code §§ 805.1—805.17.

(b) *Bar code*: The symbology on the ticket containing certain encrypted validation and accounting data used for identifying winning and losing tickets.

(c) *Game Ticket*: A bearer instrument produced through a Lottery Terminal that is the player's record of a play for a Fast Play lottery game and sold by an authorized retailer containing the play and validation data as published in this game notice.

(d) *Lottery Central Computer System*: The computer gaming system on which all Fast Play plays are recorded.

(e) *Lottery Terminal*: A device authorized by the Lottery to function in an interactive mode with the Lottery Central Computer System for the purpose of issuing plays, executing Quick Pick selections, and entering, receiving, and processing lottery transactions, including making purchases, validating plays, transmitting reports, and performing inventory functions.

(f) *Play*: A chance to participate in a particular Fast Play lottery game.

(g) *Play Area*: The area on a ticket which contains one or more play symbols.

(h) *Play Symbol*: A number, letter, symbol, image or other character found in the play area which is used to determine whether a player wins a prize.

(i) *Prize*: A non-monetary item, money, or experience that can be won as specified in section 6 (relating to prizes available to be won and determination of prize winners) of this game notice.

(j) *TOWER*: A specific, pre-defined portion of the play area, which contains two, three or four play symbols and a prize symbol in a vertical line, that when played according to the instructions, determine whether a player wins a prize. Each "TOWER" is played separately.

(k) *TOWER NUMBERS*: The numbers, letters, symbols or other characters found in each "TOWER" that, when matched against the "WINNING NUMBERS" play symbols, determine whether a player wins a prize.

(l) *WINNING NUMBERS*: The numbers, letters, symbols or other characters found in the play area that, when matched against the play symbols in any "TOWER," determine whether a player wins a prize.

(m) *Winning ticket*: A game ticket which has been validated and qualifies for a prize.

3. *Price*: The price of a Towering 10\$ ticket is \$10.

4. *Description of the Towering 10\$ Fast Play lottery game*:

(a) The Towering 10\$ lottery game is an instant win game printed from a Lottery Terminal. All prizes are predetermined, and the player does not have the ability

to select their own play symbols. Towering 10\$ tickets may be purchased from an authorized retailer or at a Lottery self-service terminal that sells terminal-based Lottery game tickets. Tickets purchased from an authorized retailer shall be printed on-demand at the time of purchase and may not be preprinted by the retailer.

(b) Towering 10\$ is played by matching all of the play symbols located in any "TOWER," to any of the play symbols in the "WINNING NUMBERS" area. A player who correctly matches all of the play symbols in the same "TOWER" wins the prize shown for that "TOWER." When a player correctly matches all of the play symbols in this manner, and a "10" (TEN) play symbol also appears in that same winning "TOWER," the player adds \$10 to the prize shown within that "TOWER." A bet slip is not used to play this game.

(c) Players can win the prize identified in section 6 (relating to prizes available to be won and determination of prize winners).

(d) A Towering 10\$ game ticket cannot be canceled or voided once printed by the Lottery Terminal, even if printed in error.

(e) To purchase a ticket at an authorized retailer, a player must remit the purchase price to the retailer and verbally request a Towering 10\$ game ticket. The ticket shall be the only valid proof of the bet placed and the only valid receipt for claiming a prize.

(f) To purchase a ticket at a Pennsylvania Lottery self-service terminal, the player must insert into the self-service terminal a dollar amount equal to the total purchase price of a Towering 10\$ game ticket and select the Towering 10\$ option on the Lottery self-service terminal. The ticket shall be the only valid proof of the bet placed and the only valid receipt for claiming a prize.

5. *Towering 10\$ ticket characteristics*:

(a) A Towering 10\$ ticket shall contain a play area, the cost of the play, the date of sale, and a bar code. Each ticket consists of ten "TOWER" areas. Each "TOWER" is played separately.

(b) *Play Symbols*: Each Towering 10\$ ticket will contain a "WINNING NUMBERS" area and ten "TOWER" areas. The play symbols and their captions, located in the "WINNING NUMBERS" area and the ten "TOWER" areas, are: 1 (ONE), 2 (TWO), 3 (THREE), 4 (FOUR), 5 (FIVE), 6 (SIX), 7 (SEVEN), 8 (EIGHT), 9 (NINE), 10 (TEN), 11 (ELEVN), 12 (TWLV), 13 (THRTN), 14 (FORTN), 15 (FIFTN), 16 (SIXTN), 17 (SVNTN), 18 (EGHTN), 19 (NINTN), 20 (TWENT), 21 (TWYONE), 22 (TWYTWO), 23 (TWYTHR), 24 (TWYFOR), 25 (TWYFIV), 26 (TWYSIX), 27 (TWYSVN), 28 (TWYEGT), 29 (TWYNIN), 30 (THIRT), 31 (THYONE), 32 (THY TWO), 33 (THYTHR), 34 (THYFOR) and 35 (THYFIV).

(c) *Prize Symbols*: The prizes symbols and their captions located in the "TOWER" areas are: \$10<sup>00</sup> (TEN DOL), \$15<sup>00</sup> (FIFTEEN), \$20<sup>00</sup> (TWENTY), \$30<sup>00</sup> (THIRTY), \$50<sup>00</sup> (FIFTY), \$100 (ONE HUN), \$500 (FIV HUN), \$1K (ONE THO), \$5K (FIV THO), \$10K (TEN THO) and \$100K (ONEHUNTHO).

(d) *Prizes*: The prizes that can be won in this game are: \$10, \$15, \$20, \$30, \$50, \$100, \$500, \$1,000, \$5,000, \$10,000 and \$100,000. Towering 10\$ contains a feature

that can increase the prize shown in a "TOWER" by \$10 as detailed in section 4 (related to description of the Towering 10\$ Fast Play lottery game). For a complete list of all prizes that can be won in this game, see section 7 (relating to number and description of prizes and approximate chances of winning). A player can win up to ten times on a ticket.

(e) *Approximate number of tickets available for the game:* Approximately 2,400,000 tickets will be available for sale for the Towering 10\$ lottery game.

6. *Prizes available to be won and determination of prize winners:*

(a) All Towering 10\$ prize payments will be made as one-time, lump-sum cash payments.

(b) Holders of tickets upon which any of the "WINNING NUMBERS" play symbols match all of the play symbols in the same "TOWER," and a prize symbol of \$100K (ONEHUNTHO) appears in the "Prize" area for that "TOWER," on a single ticket, shall be entitled to a prize of \$100,000.

(c) Holders of tickets upon which any of the "WINNING NUMBERS" play symbols match all of the play symbols in the same "TOWER," and a prize symbol of \$10K (TEN THO) appears in the "Prize" area for that "TOWER," on a single ticket, shall be entitled to a prize of \$10,000.

(d) Holders of tickets upon which any of the "WINNING NUMBERS" play symbols match all of the play symbols in the same "TOWER," a prize symbol of \$5K (FIV THO) appears in the "Prize" area for that "TOWER," on a single ticket, shall be entitled to a prize of \$5,000.

(e) Holders of tickets upon which any of the "WINNING NUMBERS" play symbols match all of the play symbols in the same "TOWER," and a prize symbol of \$1K (ONE THO) appears in the "Prize" area for that "TOWER," on a single ticket, shall be entitled to a prize of \$1,000.

(f) Holders of tickets upon which any of the "WINNING NUMBERS" play symbols match all of the play symbols in the same "TOWER," and a prize symbol of \$500 (FIV HUN) appears in the "Prize" area for that "TOWER," and in which a 10 (TEN) play symbol appears in that "TOWER," on a single ticket, shall be entitled to a prize of \$510.

(g) Holders of tickets upon which any of the "WINNING NUMBERS" play symbols match all of the play symbols in the same "TOWER," and a prize symbol of \$500 (FIV HUN) appears in the "Prize" area for that "TOWER," on a single ticket, shall be entitled to a prize of \$500.

(h) Holders of tickets upon which any of the "WINNING NUMBERS" play symbols match all of the play symbols in the same "TOWER," and a prize symbol of \$100 (ONE HUN) appears in the "Prize" area for that "TOWER," and in which a 10 (TEN) play symbol appears in that "TOWER," on a single ticket, shall be entitled to a prize of \$110.

(i) Holders of tickets upon which any of the "WINNING NUMBERS" play symbols match all of the play symbols in the same "TOWER," and a prize symbol of \$100 (ONE HUN) appears in the "Prize" area for that "TOWER," on a single ticket, shall be entitled to a prize of \$100.

(p) Holders of tickets upon which any of the "WINNING NUMBERS" play symbols match all of the play symbols in the same "TOWER," and a prize symbol of \$20<sup>00</sup> (TWENTY) appears in the "Prize" area for that "TOWER," on a single ticket, shall be entitled to a prize of \$20.

(q) Holders of tickets upon which any of the "WINNING NUMBERS" play symbols match all of the play symbols in the same "TOWER," and a prize symbol of \$10<sup>00</sup> (TEN DOL) appears in the "Prize" area for that "TOWER," and in which a 10 (TEN) play symbol appears in that "TOWER," on a single ticket, shall be entitled to a prize of \$20.

(r) Holders of tickets upon which any of the "WINNING NUMBERS" play symbols match all of the play symbols in the same "TOWER," and a prize symbol of \$15<sup>00</sup> (FIFTEEN) appears in the "Prize" area for that "TOWER," on a single ticket, shall be entitled to a prize of \$15.

(s) Holders of tickets upon which any of the "WINNING NUMBERS" play symbols match all of the play symbols in the same "TOWER," and a prize symbol of \$10<sup>00</sup> (TEN DOL) appears in the "Prize" area for that "TOWER," on a single ticket, shall be entitled to a prize of \$10.

(d) The holder of a game ticket evidencing a winning play shall present the ticket, in person, to an authorized retailer, Lottery Headquarters or a Lottery District Office. The retailer or the Lottery will issue payment if:

(1) The game ticket is scanned and the play is validated through the Lottery Terminal or the Lottery Central Computer System;

(2) A claim form is properly and fully completed;

(3) The identification of the claimant is confirmed; and

(4) The winning ticket has not expired, pursuant to this section or section 12 (relating to unclaimed prizes).

(e) The Commonwealth shall not be responsible for a winning play paid in error by an authorized retailer.

(f) In the event a prize described in these rules is not available, the Lottery may either provide a substitute prize, determined by the Secretary to have an equivalent value to the prize won, or make a cash payment to the winner, in an amount determined by the Secretary to have an equivalent value to the prize won.

11. *Funding for prizes:* Moneys will be drawn from the State Lottery Fund, to the extent necessary, to fund the payment of prizes under this section. If this lottery game is terminated for any cause, prize moneys remaining undistributed will remain in the State Lottery Fund and used for purposes otherwise provided for by law.

12. *Unclaimed prizes:* Unclaimed prize money on winning Fast Play lottery game tickets will be retained by the Secretary for payment to the persons entitled thereto for 1 year from the sale date of the Fast Play lottery game ticket. If no claim is made within 1 year from the sale date of the Fast Play lottery game ticket, the right of a ticket holder to claim the prize represented by that ticket, if any, shall expire.

13. *Purchase and prize restrictions:* A Fast Play lottery game ticket may not be purchased by, and a prize may not be paid, to an officer or employee of the Lottery, Lottery professional services contractors or subcontractors, or to a spouse, child, brother, sister or parent residing in the same household of an officer, employee, contractor or subcontractor who is involved in the production, distribution or operation of systems for the validation or accounting of Fast Play games.

14. *Governing law:*

(a) By purchasing a ticket, the purchaser agrees to comply with and abide by the State Lottery Law (72 P.S. §§ 3761-101—3761-314), this notice, instructions, conditions and final decisions of the Secretary, and procedures established by the Secretary for the conduct of the Fast Play Towering 10\$ lottery game.

(b) Decisions made by the Secretary, including the declaration of prizes and the payment thereof, in interpretation of this notice are final and binding on any player or person making a claim in respect thereof.

15. *Retailer compensation:*

(a) Authorized retailers may be entitled to compensation as determined by the Lottery.

(b) No authorized retailer or employee of an authorized retailer shall request, demand, or accept gratuities or any compensation other than as provided in subsection (a) in exchange for the performance of duties authorized pursuant to the Lottery retailer's license without the Lottery's prior written authorization.

16. *Retailer Incentive Programs:* The Lottery may conduct a separate Retailer Incentive Program for retailers who sell Pennsylvania Fast Play Towering 10\$ lottery game tickets.

17. *Retailer bonus:* The Lottery may offer a retailer bonus in connection with the sale of Pennsylvania Fast Play lottery game tickets. If a retailer bonus is offered, a Lottery retailer shall be eligible for a bonus as described in this section. Lottery retailers who sell a winning ticket that entitles the ticket holder to a prize, either payable in a single installment or having a guaranteed minimum payout, of at least \$100,000 and not exceeding \$500,000 shall be paid a bonus of \$500. Lottery retailers who sell a winning ticket that entitles the ticket holder to a prize, either payable in a single installment or having a guaranteed minimum payout, of at least \$500,001 and not exceeding \$1,000,000 shall be paid a bonus of \$5,000. Lottery retailers who sell a winning ticket that entitles the ticket holder to a prize, either payable in a single installment or having a guaranteed minimum payout, of at least \$1,000,001 and not exceeding \$10,000,000 shall be paid a bonus of \$10,000. A Lottery retailer is entitled only to the largest bonus for which they qualify on a winning ticket. A bonus will be initiated for payment after the Fast Play game ticket is claimed and validated. A bonus will not be awarded to a Lottery retailer that sells a non-winning Pennsylvania Lottery Fast Play game ticket used to enter a Pennsylvania Lottery second-chance drawing or promotion that is subsequently selected to win a prize.

18. *Termination of the game:* The Secretary may announce a termination date, after which no further tickets from this game may be sold. The announcement will be disseminated through media used to advertise or promote Towering 10\$ or through normal communications methods.

19. *Applicability:* This notice applies only to the Towering 10\$ lottery game announced in this notice.
