#### Maximum Lawful Rate of Interest for Residential Mortgages for the Month of April, 1998

The Department of Banking of the Commonwealth of Pennsylvania, under the authority contained in section 301 of the act of January 30, 1974 (P. L. 13, No. 6) (41 P. S. § 301), hereby determines that the maximum lawful rate of interest for residential mortgages for the month of April, 1998, is 8 1/2%.

The interest rate limitations under the State's usury statute were preempted to a great extent by Federal law, the Depository Institutions Deregulation and Monetary Control Act of 1980 (Pub. L. 96-221). Further preemption was instituted with the signing of Pub. L. 96-399, which overrode State interest rate limitations on an individual who finances the sale or exchange of residential real property which the individual owns and which the individual occupies or has occupied as the principal residence.

Each month the Department of Banking is required by State law to compute and announce the ceiling rate on residential mortgages in this Commonwealth. This maximum rate is determined by adding 2.50 percentage points to the yield rate on long-term government bonds as published by the Federal Reserve Board and/or the United States Treasury. The latest yield rate on long-term government securities is 5.94 to which was added 2.50 percentage points for a total of 8.44% that by law is rounded off to the nearest quarter at 8 1/2%.

• The only solvents to be used in the wash off area and surface coating cleanup operations shall be acetone or other materials which contain no volatile organic compounds or hazardous air pollutants.

• Pennsylvania House shall develop and implement a coating transfer equipment leak inspection and maintenance plan and an operator training program.

• All containers of volatile organic compoundcontaining materials shall be kept closed when not in actual use.

• The combined volatile organic compound emissions from the facility's combustion sources shall not exceed 14.4 tons in any 12 consecutive month period.

• The volatile organic compound emissions from the lumber drying operation shall not exceed 3 pounds per hour, 15 pounds per day or 2.7 tons in any 12 consecutive month period.

Where any of the mining activities listed will have discharges of wastewater to streams, the Department will incorporate NPDES permits into the mining activity permits issued in response to these applications. The NPDES permits will contain, at a minimum, technologybased effluent limitations (as described in the Department's regulations—25 Pa. Code §§ 77.522, 87.102, 88.92, 88.187, 88.242, 89.52 and 90.102) for iron, manganese, suspended solids, settleable solids, alkalinity and pH. In addition to the above, more restrictive effluent limitations, restrictions on discharge volume or restrictions on the extent of mining which may occur will be incorporated into a mining activity permit when necessary for compliance with water quality standards (in accordance with 25 Pa. Code Chapters 93 and 95). Persons or agencies which have requested review of the NPDES permit requirements for a particular mining activity within the above-mentioned public comment period will be provided with a 30-day period to review and submit comments on those requirements.

Written comments or objections should contain the name, address and telephone number of persons submitting comments or objections; application number; and a statement of sufficient detail to inform the Department on the basis of comment or objection and relevant facts upon which it is based. Requests for an informal conference must contain the name, address and telephone number of requestor; application number; a brief summary of the issues to be raised by the requestor at the conference; and a statement whether the requestor desires to have the conference conducted in the locality of the proposed mining activities.

#### **Bureau of Deep Mine Safety**

#### **Request for Variance**

The Bureau of Deep Mine Safety has approved a request for variance from **Cyprus Emerald Resources Corporation**. The following notification contains a summary of this request. Complete copies of the variance request may be obtained from Matthew A. Bertovich by calling (724) 439-7469.

*Summary of the Request*: Cyprus Emerald Resources Corporation requested an increase in shelter hole distances to 150-foot centers for all mains development at the Emerald Mine.

The basis for the Bureau's approval can be summarized in the following statements:

1. Pedestrians will have the right-of-way. All vehicle operators must stop until workers are able to enter shelter hole.

2. Locomotives used to transport supplies or equipment must be of sufficient size (tonnage) to be able to stop their loads within a safe distance.

3. All vehicles will be operated at speeds that will allow controlled stops under prevailing track conditions.

4. Signs shall be posted stating the shelter hole spacing distance.

5. A means of identifying shelter hole locations shall be provided using a reflective indicator/marker which will be visible from along the track haulage travelway. Markers will be of standardized color and design.

6. Crosscuts which are used as shelter holes shall be maintained free of obstructions and debris, other than normal roof-to-ground supports. Clearance will be maintained for a depth of at least 15 feet and the entire width except for roof support.

7. Shelter holes will be maintained at all switch throws and doors.

8. Supply cars and equipment will be pulled by a locomotive in the direction of travel. When it is necessary to push nonpropelled (supply cars, and the like) track haulage equipment, it shall be done only from the last track switch. Trip lights shall be used on the end that does not have locomotive coupled.

9. Workers performing tasks, that is track repair, block repair, and the like, along track haulage roads shall be provided with flashing warning lights. These devices shall be placed in clear view of approaching haulage equipment, but as close as practicable to the work site.

10. All employes and persons entering the mine shall be trained concerning shelter hole procedure and safety precautions.

This approval is limited to a variance from the distance requirements for shelter holes contained in section 268(b) of the Bituminous Coal Mine Act. All other terms and requirements of section 268 shall remain in effect. Continued authorization for operation under the approval is contingent upon compliance with the measures described in the approved plan.

The Department of Environmental Protection (Department) has completed its review of the Airport Road Act 537 Special Study (Special Study), dated July, 1997 and revised January, 1998 (received by the Department on January 13, 1998), with additional documentation dated October 13, 1997 (received by the Department on October 16, 1997), as prepared by Schumacher Engineering Inc., on behalf of Hazle Township.

The Department's review has found that the Special Study is now acceptable and hereby grants planning approval.

The Hazle Township Municipal Authority (Authority), on behalf of Hazle Township, proposes to implement Alternative No. 1 of the Special Study. Alternative No. 1 proposes the construction of a new wastewater collection and conveyance system to serve limited, specific portions of Hazle Township. The areas to be served by the proposed system are limited to those shown on Drawing No. 1 of the Special Study: the Village of Hollywood including the Woodcrest Estates Subdivision and Holly-Lynn Mobile Home Park, properties adjacent to a portion of the Airport Beltway (SR3026) from SR0309 west to the area of the Wal-Mart Super Center, properties adjacent to Old Airport Road (T-470) and Hess Road (T-499) and the Hazleton Municipal Airport. Construction of the proposed system will occur in two phases. Phase 1 will include all areas except for the Old Airport Road and Hazleton Municipal Airport Areas. Phase 2 will include only the Old Airport Road and Hazleton Municipal Airport Areas.

The wastewater collection and conveyance systems proposed will consist of approximately 13,300 lineal feet of gravity sewer lines and force main along with associated appurtenances. The conveyance system will also include the construction of a 460 gpm wastewater pumping station. The pump station's equipment will be housed in a 45 foot by 25 foot aboveground structure to be constructed along the Airport Beltway. The proposed pump station's force main will discharge its wastewater to an existing manhole located on Liberty Avenue in the Park Crest Subdivision located within Hazle Township. conveyance system lines to the Greater Hazleton Joint Sewer Authority's Wastewater Treatment Facility for treatment and discharge.

Due to the project's construction, the Authority will abandon the existing Hollywood Pump Station. Wastewater from the Hollywood Collection System will be conveyed to the proposed pump station to be constructed adjacent to the Airport Beltway. The project's construction will also allow for the abandonment of the Holly-Lynn Mobile Home Park's Wastewater Treatment Facility. Several commercial establishments, including Lagana's Corporate Center, Affordable Dentures Inc., Rex TV and Appliance Inc, and the Hazleton Municipal Airport, which currently utilize holding tank facilities as their method of wastewater disposal, will be required to properly abandon their holding tanks and connect to the proposed wastewater collection system.

The proposed project will be financed through commercial and residential tapping fees, a capital contribution from the Authority's Capital Improvement Fund and a commercial bank loan obtained by the Authority.

In accordance with the provisions of the Pennsylvania Sewage Facilities Act, 35 P. S. §§ 750.1—750.20(a) (Act 537), and 25 Pa. Code Ch. 71, the Department will hold Hazle Township responsible for the complete and timely implementation of the Special Study's chosen wastewater disposal alternative. Implementation of the Special Study's chosen wastewater disposal alternative must be performed within the time frames indicated in the Special Study's Schedule of Implementation.

Any additional wastewater-related improvements, additions, deletions or changes outside of those explicitly described in the Special Study must be in compliance with the Department's regulations and be submitted to and approved by the Department in writing.

#### **1998 Sunset Review Schedule**

This schedule includes the Department of Environmental Protection's (Department) regulations, by chapter, which will undergo a sunset review in 1998. The Department will publish an annual sunset schedule which will contain the *Pennsylvania Code* chapters which will be reviewed by the Department. Each regulation will be reviewed to determine whether the regulation effectively fulfills the goals for which it was intended and remains consistent with the following principles contained in Executive Order 1996-1 (regarding Regulatory Review and Promulgation):

1. Regulations shall address a compelling public interest.

2. Costs of regulations shall not outweigh their benefits.

3. Regulations shall be written in clear, concise and, when possible, nontechnical language.

4. Regulations shall address definable public health, safety or environmental risks.

5. Where Federal regulations exist, Pennsylvania's regulations shall not exceed Federal standards unless justified by a compelling and articulable Pennsylvania interest or required by State law.

6. Compliance shall be the goal of all regulations.

7. Where viable nonregulatory alternatives exist, they shall be preferred over regulations.

8. Regulations shall be drafted and promulgated with early and meaningful input from the regulated community.

9. Regulations shall not hamper Pennsylvania's ability to compete effectively with other states.

10. All agency heads shall be held directly accountable for regulations promulgated by their respective agencies.

The chapters listed were reviewed as part of the Department's Regulatory Basics Initiative. These chapters were reviewed to identify regulations which contain standards or requirements more stringent than Federal law; impose disproportionate economic costs; have a history of significant noncompliance; are prescriptive or technology specific; inhibit the application of new green technologies; do not support a pollution prevention approach; are obsolete or redundant; or lack clarity. This initiative will result in proposed and final rulemakings which will be listed on the Department's Regulatory Agenda, which is published semiannually in February and July.

#### Health Care Services Review Division: Availability of Applications for Designation as an Impairment Rating Evaluation Physician

The Department of Labor and Industry (Department), Bureau of Workers Compensation announces that the application for designation as an Impairment Rating Evaluation (IRE) Physician is available to any physician who desires to be placed on the list of IRE physicians established in accordance with section 306(a.2) of the Workers Compensation Act (act). Qualified physicians who are placed on the Department's list will be eligible for designation by the Bureau to perform IREs.

The amendments to the Workers Compensation Act of Act 57 of 1996, established the use of the AMA Guides to the Evaluation of Permanent Impairment (Guides) to determine an employe's percentage of whole body impairment due to a compensable work-related injury after the receipt of 104 weeks of total disability benefits.

In accordance with the provisions of section 306(a.2) of the act, IRE physicians must be licensed in the Commonwealth of Pennsylvania; certified by an American Board of Medical Specialties approved board or its osteopathic equivalent; and be active in clinical practice for at least 20 hours per week. Under the Department's regulations "active in clinical practice" means the act of providing preventive care and the evaluation, treatment and management of medical conditions of patients on an ongoing basis. In addition, in order to qualify as a physician on the Department's list, the physician must have completed a Departmentally approved course on the use the AMA Guides or be certified by a Departmentally approved examining organization.

Code Chapter 69, Subchapter E (relating to tagged fish contests in boundary lakes) to conduct a tagged fish contest in Lake Pymatuning. Fishing in America has applied to conduct a 60-day tagged fish contest for crappie on Lake Pymatuning during the period from May 2 through June 30, 1998. The applicant estimates that 3,500 persons will participate in this contest. The State of Ohio has issued a permit for this contest on its portion of Lake Pymatuning.

In addition to conducting the tagged fish contest described above, Fishing in America has also applied for a permit to conduct a 1-day fishing tournament on Lake Pymatuning on April 26, 1998 for the purpose of gathering crappie to be captured, tagged and released for use in the tagged fish contest.

Under the provisions of 58 Pa. Code § 69.44(b), the Commission is hereby giving the public the opportunity to offer comments, objections, protests or interventions with respect to the proposed tagged-fish contest. The Commission has established a 15-day public comment period for this application. Persons with comments, suggestions, protests or objections to the proposed tagged fish contest or who wish to intervene in the permit application process are invited to submit them to the Executive Director, Fish and Boat Commission, P.O. #### Lake Erie Commercial Fishing—1998

The Executive Director of the Fish and Boat Commission (Commission), acting under the authority of 58 Pa. ## HEALTH CARE COST CONTAINMENT COUNCIL

#### **Mandated Benefits**

Section 9 of Act 34 of 1993 requires that the Health Care Cost Containment Council (Council) review existing or proposed mandated health benefits on request of the executive and legislative branches of government. The Council has been requested by Senator F. Joseph Loeper, Chairperson of the Senate Rules Committee to review Senate Bill 39, the proposed Cancer Prevention and Early Detection Services Act which would require insurance coverage of certain cancer-related services, as well as a proposed amendment that would exclude the following from affected health insurance policies: "accident only, fixed indemnity, limited benefit, credit, dental, vision, specified disease, Medicare supplement, Civilian Health and Medical Program of the Uniform Service (CHAMPUS) supplement, long-term care or disability income, workers' compensation or automobile medical payment insurance." The amendment would also add coverage of annual digital rectal exams and PSA tests for men 40-years old and older with certain prostate cancer risk factors and would specify that the benefits be subject to the same copayment and coinsurance provisions of an insurance policy as other medical services, but shall be exempt from any deductible or dollar limit provisions.

The Council is requesting that anyone supporting or opposing these mandated insurance benefits provide six copies of documentation to the Council no later than May 29, 1998. (v) Where the proposed benefit would mandate coverage of a particular therapy, the results of at least one professionally accepted, controlled trial comparing the medical consequences of the proposed therapy, alternative therapies and no therapy.

(vi) Where the proposed benefit would mandate coverage of an additional class of practitioners, the result of at least one professionally accepted, controlled trial comparing the medical results achieved by the additional class of practitioners and those practitioners already covered by benefits.

(vii) The results of any other relevant research.

(viii) Evidence of the financial impact of the proposed legislation, including at least:

(A) The extent to which the proposed benefit would increase or decrease cost for treatment or service.

(B) The extent to which similar mandated benefits in other states have affected charges, costs and payments for services.

(C) The extent to which the proposed benefit would increase the appropriate use of the treatment or service.

(D) The impact of the proposed benefit on administrative expenses of health care insurers.

(E) The impact of the proposed benefits on benefits costs of purchasers.

(F) The impact of the proposed benefits on the total cost of health care within this Commonwealth.

#### Order

On September 24, 1997, the Independent Regulatory Review Commission (Commission) received this proposed regulation from the Department of Corrections (Department). This rulemaking amends 37 Pa. Code Chapter 93. The authority for this regulation is the Prison Medical Services Act of 1996 (61 P. S. § 1014) and Act 53 of 1996 (71 P. S. § 310-3). The proposed regulation was published in the October 4, 1997 *Pennsylvania Bulletin* with a 30-day public comment period. The final-form regulation was submitted to the Commission on January 29, 1998.

The regulation establishes a program requiring inmates in State correctional institutions and facilities to pay a fee to cover a portion of the actual costs of the medical services provided. Additionally, Act 53 of 1996 requires the Department to implement a system whereby inmates who are covered by medical insurance are to pay for their own medical needs through their insurance, consistent with the terms of the policy.

We have reviewed this regulation and find it to be in the public interest. The Department estimates that implementation of the program will save the Commonwealth approximately \$180,000 to \$202,000 per year in the provision of medical services. In addition, the Department estimates that \$380,000 per year will be generated from the copayments. This regulation is consistent with the Prison Medical Services Act of 1996 and Act 53 of 1996.

#### Therefore, It Is Ordered That:

1. Regulation No. 19-1 from the Department of Corrections, as submitted to the Commission on January 29, 1998, is approved; and

2. The Commission will transmit a copy of this Order to the Legislative Reference Bureau.

## PENNSYLVANIA ECONOMIC DEVELOPMENT FINANCING AUTHORITY

#### Pennsylvania Community Development Bank; Capacity Building Grant Guidelines and Workshop

The 1997-98 Appropriation Act (Act 4A of 1997), as amended, includes \$15 million for the Pennsylvania Community Development (PCD) Bank program. The program does not constitute an institution chartered by the Department of Banking or any Federal agency. The Pennsylvania Economic Development Financing Authority (Authority) will administer the PCD Bank.

The PCD Bank will provide grant and loan assistance to Community Development Financial Institutions (CDFIs) and other community-based organizations. The PCD Bank, through CDFIs it assists, will make capital available for community and economic development to revitalize disadvantaged areas and provide economic opportunities for low-income people. The PCD Bank is a key component of Governor Ridge's Project for Community Building.

The PEDFA Board approved the PCD Bank's Capacity Building Grant Guidelines governing the distribution of grants to nonprofit CDFIs and certain other nonprofit organizations. These grants are available in the following categories:

Track 1. Startup Grants: These grants are to assist nonprofit organizations to attain accreditation standards defined by the PCD Bank and for Accredited CDFIs to startup operations in a new geographic service area.

Track 2. Expansion Grants: These grants are to expand the operation and programs of Accredited CDFIs that are also nonprofit organizations.

Track 3.
