DELAWARE RIVER BASIN COMMISSION

Meeting and Public Hearing

The Delaware River Basin Commission (Commission) will hold an informal conference followed by a public hearing on Wednesday, October 27, 2004. The hearing will be part of the Commission's regular business meeting. Both the conference session and business meeting are open to the public and will be held at the National Constitution Center, Kirby Auditorium, 525 Arch Street, Independence Mall, Philadelphia, PA.

The conference among the commissioners and staff will begin at 9:30 a.m. Topics of discussion will include: an update on the Water Resources Plan for the Delaware River Basin (Basin Plan) including a summary of the Watershed Summit of September 13-15 and the transition from planning to implementation; a summary and report on informational meetings on a proposed resolution to amend the Water Quality Regulations, Water Code and Comprehensive Plan to designate the Lower Delaware River as Special Protection Waters; a proposal to amend the Commission's fee schedule for the review of projects under Section 3.8 and Article 10 of the Delaware River Basin Compact by the addition of a late application fee; and a presentation on the structural reorganization of the Delaware Estuary Program.

The business meeting will begin at 11 a.m. The portion of the meeting running from 11 a.m. until 12:15 p.m. will consist of the public hearing on a proposal to amend the Water Quality Regulations, Water Code and Comprehensive Plan by establishing pollutant minimization plan requirements for point and nonpoint source discharges following issuance of a TMDL or assimilative capacity determination.

The business meeting will resume at 1:30 p.m. Public hearings on the following project review applications will be held during this afternoon portion of the meeting:

1. Cabot Corporation D-70-72-2. An application to upgrade an industrial wastewater treatment plant (IWTP) and implement manufacturing operation improvements necessary to meet water quality objectives in Swamp Creek, a tributary of Perkiomen Creek in the Schuylkill River Watershed. The applicant produces primary nonferrous metals and alloys plus inorganic chemicals at its Boyertown Facility, which is located off Swamp Creek Road and straddles the borders of Douglass Township, Montgomery County and Colebrookdale Township, Berks County. No expansion of the 0.222 million gallon per day (mgd) IWTP is proposed. The plant effluent, along with stormwater, cooling water and water supply treatment wastewater, will continue to be discharged to Swamp Creek by way of the existing outfall. (This was NAR'd as Cabot Supermetals D-70-72 (Revision).)

2. New Jersey-American Water Company D-90-89 CP-3. An application for the renewal of a groundwater withdrawal project to increase withdrawal from 15 million gallons per 30 days (mg/30 days) to 28.5 mg/30 days to supply the applicant's public water supply system from existing Wells 1 and 2 in the Kittatinny Limestone formation. The project is located in the Pophandusing Brook Watershed, White Township, Warren County, NJ. (This was NAR'd as D-90-89 CP Renewal 2.) 3. Waltz Golf Farm, Inc. D-92-49-2. An application for the renewal of a surface water withdrawal project to continue withdrawal of 9.0 mg/30 days to supply the applicant's golf course from an existing manmade pond on Landis Creek in the Lodal Creek Watershed. The project is located in Limerick Township, Montgomery County, in the Southeastern Pennsylvania Ground Water Protected Area.

4. Air Products and Chemicals D-93-48-2. An application for the renewal of a groundwater withdrawal project to continue withdrawal of 8.7 mg/30 days to supply the applicant's manufacturing facility from existing Wells 2 and 4 in the Lehigh River Watershed. The project is located in Glendon Borough, Northampton County. (This was NAR'd as D-93-48 Renewal.)

5. *Blue Ridge Real Estate Company D-93-57-2.* An application for the renewal of a surface water withdrawal project to continue withdrawal of 100 mg/30 days from an existing intake in Tobyhanna Creek to supply the applicant's snowmaking operations at the Jack Frost Ski Area. The project is located in Kidder Township, Carbon County.

6. Buckingham Township D-2003-13 CP-1. An application for approval of a groundwater withdrawal project to supply up to 5.18 mg/30 days to the applicant's public water supply distribution system from new Wells F-4 and F-5 and to increase the combined withdrawal from all wells from 33.2 mg/30 days to 37.5 mg/30 days. New Wells F-4 and F-5 are located in the Brunswick Formation. The project is located in the Mill Creek Watershed in Buckingham Township, Bucks County, in the Southeastern Pennsylvania Ground Water Protected Area. (This was NAR'd as D-2003-13 CP.)

7. Buckingham Township D-2004-15 CP-1. An application to expand the Township's Furlong Sewage Treatment Plant (STP) from 116,825 gallons per day (gpd) to treat an average flow of 257,312 gpd by means of additional lagoon treatment systems. The project will continue to provide secondary treatment of flow from residential and commercial development in Buckingham Township, Bucks County. The STP is located just east of State Route 263 in Buckingham Township. Additional effluent spray fields and drip irrigation zones are proposed. The project will continue to provide long-term effluent storage and utilize Mill Creek in the Neshaminy Creek Watershed as an alternate discharge point. (This was NAR'd as D-2004-15 CP.)

8. City of New York Department of Environmental Protection D-2004-28 CP-1. An application to modify an STP located at 4 Neversink Drive, Port Jervis, Orange County, NY. The STP has a capacity of 5 mgd and serves the City of Port Jervis. The existing plant provides secondary treatment and discharges to the Neversink River, upstream from Commission Special Protection Waters and the Delaware Water Gap National Recreation Area. The proposed modification, which constitutes Phase I of a multiphase improvement project, involves the demolition of three Imhoff tanks and construction of two sedimentation basins, plus minor facility upgrades. No increase in STP capacity is proposed.

9. Exelon Generation Company, LLC D-69-210 CP Final (Revision 12). An application for temporary approval to modify the Operating Plan of the Limerick Generating Station (LGS), a nuclear-powered electric generating station located in Limerick Township, Montgomery County, regarding surface water withdrawal restrictions related to ambient water temperature in the Schuylkill River. The applicant proposes to demonstrate under controlled conditions that the withdrawal of Schuylkill River water can continue without adverse impact when the background water temperature exceeds 59°F, the maximum temperature at which withdrawals can be made under the current docket. In July 2004, an amended application and draft operating and monitoring plan were submitted after discussion with the Commission staff, the Commowealth and stakeholders. A revised draft operating and monitoring plan was submitted on October 1, 2004, and is attached to the draft docket. The amended application provides for the following:

• A multiyear demonstration period during the remainder of the 2004 season through the 2007 season associated with flow and temperature restrictions in accordance with an approved operating and monitoring plan.

• Withdrawals not to exceed 24 mgd of LGS' consumptive cooling water needs during times when the Schuylkill River 24-hour average river ambient water temperature exceeds $59^{\circ}F$ and when the 24-hour average river flow is at or below 1,791 cubic feet per second (cfs) (but above 560 cfs) at the gaging station at Pottstown.

• Withdrawals of LGS' entire consumptive cooling water needs during times when the Schuylkill River 24-hour average river ambient water temperature exceeds 59° F and when the 24-hour average river flow exceeds 1,791 cfs.

• Maintenance of minimum flow of at least 10 cfs in the East Branch Perkiomen Creek at all times in accordance with the draft Demonstration Operation and Monitoring Plan for the Joint Limerick Generating Station Water Supply Modification Demonstration and Wadesville Mine Pool Withdrawal & Stream Flow Augmentation Project that was submitted by Exelon.

• Development of recreational flow management plans to increase flows in the East Branch Perkiomen Creek above 10 cfs to support specific short-term recreational events.

• Establishment of a restoration and monitoring fund based on \$0.06/1,000 gallons of makeup water that is not required for LGS consumptive cooling water needs due to lifting the 59°F temperature requirement. Flows pumped to the EBPC during periods when the 59°F restriction would have been in effect, but not used for consumptive cooling water needs at the LGS, will be credited against this fund.

• Working with stakeholders regarding the design and implementation of the demonstration and restoration projects during 2005 and future years.

• Test periods with no augmentation/makeup waters supplied for LGS consumptive cooling water needs (beyond the minimum 10 cfs flows in the East Branch Perkiomen Creek).

• The continuation of the Wadesville Mine Pool withdrawal and Stream Flow Augmentation Demonstration Project that was approved under Doc. No. D-69-210 CP (Final) (Revision 11) and extended for 1 year by Commission Resolution No. 2003-25 adopted December 3, 2003.

In addition to the previously listed items, the afternoon portion of the Commission's business meeting will include the public hearing on a resolution to amend the Water Quality Regulations, Water Code and Comprehensive Plan to designate the Lower Delaware River as Special Protection Waters. In addition, the meeting will include: adoption of the minutes of the September 1, 2004, business meeting; announcements; a report on Basin hydrologic conditions; a report by the executive director; a report by the Commission's general counsel; and an opportunity for public dialogue.

DEPARTMENT OF AGRICULTURE

Partial Revocation of Plum Pox Virus Quarantine

Recitals

1. The Plant Pest Act (act) (3 P. S. §§ 258.1—258.27) empowers the Department of Agriculture (Department) to take various measures to detect, contain and eradicate plant pests in this Commonwealth.

2. The powers granted the Department under section 21 of the act (3 P. S. § 258.21) include the power to establish quarantines to prevent the dissemination of plant pests within this Commonwealth.

3. Plum Pox Virus (PPV) is a serious non-native plant pest that injures and damages stone fruits such as peaches, nectarines, plums and apricots by drastically reducing the fruit yields from these stone fruit trees and by disfiguring the fruit to the point it is unmarketable and has been detected in certain areas of this Commonwealth.

4. The Department has exercised its authority under the act and issued several Orders of Quarantine affecting portions of Adams, Cumberland, Franklin and York Counties in an effort to contain, identify and eradicate PPV.

5. The Department is satisfied it is appropriate to rescind the Order of Quarantine applicable to Quincy Township and Mont Alto Borough, Franklin County and the Order of Quarantine applicable to Southampton Township, Cumberland County, since 3 consecutive years of extensive testing have failed to detect the presence of PPV among stone fruit trees in those areas. Order

Under authority of section 21 of the act, the Department hereby enters the following order:

The Order of Quarantine dated August 27, 2001, and published at 31 Pa.B. 5117 (September 8, 2001) and the Order of Quarantine dated June 26, 2001, and published at 31 Pa.B. 3559 (July 7, 2001) are hereby rescinded. Those orders had imposed a guarantine on all properties in Quincy Township and Mont Alto Borough, Franklin County and on all properties in Southampton Township, Cumberland County, respectively, to facilitate the containment and eradication of PPV and to make the affected stone fruit tree owners eligible for reimbursement of certain costs related to the destruction of stone fruit trees, herbicide applications, insect control measures and other PPV eradication activities under the Department's Commercial Orchard and Fruit Tree Indemnity Program and the Department's Plum Pox Noncommercial Prunus Tree and Landscape Nursery Prunus Tree Indemnity Program. All PPV-infected stone fruit trees and all stone fruit trees within 500 meters of the infected trees have since been removed from the quarantined locations, and the owners of those trees compensated for the losses attendant to this removal. Three consecutive years of intensive sampling and testing stone fruit leaves in the three municipalities have not yielded any additional positive detections of PPV. Therefore, the locations covered by the referenced August 27, 2001, and June 26, 2001, Orders of Quarantine are no longer considered a potential reservoir of the PPV virus and as a result can be considered free of PPV. The locations hereby released from quarantine are as follows:

All properties and land located in Quincy Township, Franklin County.

All properties and land located in Mont Alto Borough, Franklin County.

All properties and land located in Southampton Township, Cumberland County.

The Department will consult with the United States Department of Agriculture, European experts and scientific authorities with respect to the most efficacious measures by which to contain and eliminate this serious plant pest. The Department will issue further restrictions under authority of this Quarantine Order, as is required under the section 21(a) of the act. These restrictions may address aphid control, elimination or reduction of aphid habitat, destruction of PPV-infected stone fruit trees and budwood, destruction of endangered or exposed stone fruit trees or budwood and any other measures necessary to the containment and elimination of the PPV in this Commonwealth.

This quarantine is effective as of September 30, 2004, and shall remain in effect until terminated by subsequent order.

The applications concern, but are not limited to, discharges related to industrial, animal or sewage waste, discharges to groundwater, discharges associated with municipal separate storm sewer systems (MS4), stormwater associated with construction activities or concentrated animal feeding operations (CAFOs). This notice is provided in accordance with 25 Pa. Code Chapters 91 and 92 and 40 CFR Part 122, implementing The Clean Streams Law (35 P. S. §§ 691.1—691.1001) and the Federal Clean Water Act.

For NPDES renewal applications in Section I, the Department of Environmental Protection (Department) has made a tentative determination to reissue these permits for 5 years subject to effluent limitations and monitoring and reporting requirements in their current permits, with appropriate and necessary updated requirements to reflect new and changed regulations and other requirements.

For applications for new NPDES permits and renewal applications with major changes in Section II, as well as applications for MS4 individual permits and individual stormwater construction permits in Sections IV and VI, the Department, based upon preliminary reviews, has made a tentative determination of proposed effluent limitations and other terms and conditions for the permit applications. These determinations are published as proposed actions for comments prior to taking final actions.

Unless indicated otherwise, the EPA Region III Administrator has waived the right to review or object to proposed NPDES permit actions under the waiver provision in 40 CFR 123.24(d).

Persons wishing to comment on an NPDES application are invited to submit a statement to the regional office noted before an application within 30 days from the date of this public notice. Persons wishing to comment on a WQM permit application are invited to submit a statement to the regional office noted before the application within 15 days from the date of this public notice. Comments received within the respective comment periods will be considered in the final determinations regarding the applications. Comments should include the name, address and telephone number of the writer and a concise statement to inform the Department of the exact basis of a comment and the relevant facts upon which it is based.

The Department will also accept requests for a public hearing on applications. A public hearing may be held if the responsible office considers the public response significant. If a hearing is scheduled, a notice of the hearing will be published in the *Pennsylvania Bulletin* and a newspaper of general circulation within the relevant geographical area. The Department will postpone its final determination until after a public hearing is held.

LAND RECYCLING AND ENVIRONMENTAL REMEDIATION

UNDER ACT 2, 1995

PREAMBLE 1

Acknowledgment of Notices of Intent to Remediate Submitted under the Land Recycling and Environmental Remediation Standards Act (35 P. S. §§ 6026.101-6026.908).

Sections 302-305 of the Land Recycling and Environmental Remediation Standards Act (act) require the Department of Environmental Protection (Department) to publish in the Pennsylvania Bulletin an acknowledgment noting receipt of Notices of Intent to Remediate. An acknowledgment of the receipt of a Notice of Intent to Remediate is used to identify a site where a person proposes to, or has been required to, respond to a release of a regulated substance at a site. Persons intending to use the Background Standard, Statewide Health Standard, the Site-Specific Standard or who intend to remediate a site as a special industrial area must file a Notice of Intent to Remediate with the Department. A Notice of Intent to Remediate filed with the Department provides a brief description of the location of the site, a list of known or suspected contaminants at the site, the proposed remediation measures for the site and a description of the intended future use of the site. A person who demonstrates attainment of one, a combination of the cleanup standards or who receives approval of a special industrial area remediation identified under the act will be relieved of further liability for the remediation of the site for any contamination identified in reports submitted to and approved by the Department. Furthermore, the person shall not be subject to citizen suits or other contribution actions brought by responsible persons not participating in the remediation.

Under sections 304(n)(1)(ii) and 305(c)(2) of the act, there is a 30-day public and municipal comment period for sites proposed for remediation using a Site-Specific Standard, in whole or in part, and for sites remediated as a special industrial area. This period begins when a summary of the Notice of Intent to Remediate is published in a newspaper of general circulation in the area of the site. For the sites identified, proposed for remediation to a Site-Specific Standard or as a special industrial area, the municipality within which the site is located may request to be involved in the development of the remediation and reuse plans for the site if the request is made within 30 days of the date specified. During this comment period, the municipality may request that the person identified as the remediator of the site develop and implement a public involvement plan. Requests to be involved and comments should be directed to the remediator of the site.

For further information concerning the content of a Notice of Intent to Remediate, contact the environmental cleanup program manager in the Department regional office before which the notice appears. If information concerning this acknowledgment is required in an alternative form, contact the community relations coordinator at the appropriate regional office. Proposed Consent Order and Agreement

Bo-Rit Asbestos Site, Borough of Ambler, Montgomery County

The Department of Environmental Protection (Department), under of section 707 of the Hazardous Sites Cleanup Act (HSCA) (35 P. S. § 6020.707), has entered into a De Minimis Consent Order and Agreement with DEAP, Inc. (DEAP) for reimbursement of certain response costs incurred to remediate hazardous substances released and threatened to be released at the Bo-Rit Asbestos Site (Site), 6 South Maple Street, Borough of Ambler, Montgomery County.

This Site was the former location of asbestos-containing materials manufacturing operations. The EPA conducted an investigation of the Site and documented a release or threatened release of asbestos at the Site. Since 1987, the Department has performed interim response actions at this Site, including a field investigation of the Site, and has concluded that asbestos and asbestos containing materials exist as contaminants at the Site. The Department has not conducted a full investigation to determine the extent of the known contamination, the risk to human health or the environment from the release or threatened release of the known contamination, or to identify whether any additional hazardous wastes, hazardous substances or contaminants exist on the Site.

DEAP purchased the Site with the intent to remediate and develop the Site for residential purposes but has opted to sell it to a buyer for commercial development. The Site is currently under an agreement of sale. DEAP has represented to the Department that it is has not caused or contributed to the release or threatened release of any hazardous substances or contaminants at the Site. DEAP wishes to resolve its potential liability to the Department for reimbursement of certain response costs incurred to investigate the asbestos and asbestos containing materials on the Site. The Department has determined that it is in the public interest to resolve its claim against DEAP. Therefore, DEAP has agreed to reimburse the Department for certain response costs in the amount of \$2,000 and shall receive contribution protection from claims regarding asbestos and asbestos containing materials related to its ownership of this property.

This notice is provided under section 1113 of the HSCA (35 P. S. § 6020.1113), which states that "settlement shall become final upon the filing of the Department's response to the significant written comments." The Department may approve or disapprove plans and reports submitted. This notice provides the Department's decision and, if relevant, the basis for disapproval.

Public Meeting for Source Water Assessment; Mountain Water Association

The Safe Drinking Water Reauthorization of 1996 required states to develop a SWAP to assess drinking water sources that serve public water systems for their susceptibility to pollution and to use this information as a basis for building voluntary, community-based remedies to drinking water contamination. The SWAP assessments are of raw water quality, not of finished water quality and are not intended as a measure of water supplier compliance with the Safe Drinking Water Act. These source water assessment public meetings will assist the Department in gaining vital information about the watershed in the vicinity of groundwater sources and in gaining public support for the assessments. The ultimate goal of the assessments is to support and promote the development of voluntary, local source water protection programs and to reduce the threat of contamination of public drinking water.

In accordance with the requirements of section 303(d) of the Clean Water Act, several stream segments in the watershed have been identified as impaired due to high levels of metals, from acid mine drainage.

The primary pollutant source for the watershed is abandoned mine workings. This watershed was mined for coal throughout the 19th and 20th centuries. The affects of this are still present. All on the allocations made in the TMDL are load allocations, which are made to nonpoint sources of pollution.

The TMDL was developed using Monte Carlo Simulation (MCS) to determine long-term average concentrations that each stream segment could accept and still meet water quality criteria 99% of the time. MCS allows for the expansion of a data set based on its statistical makeup. Since there was no critical flow condition where criteria were exceeded, the Department used the average flow to express the loading values in the TMDL.

The TMDL sets allowable loading rates for metals and acidity at specified points in the watershed. The basis of information used in the establishment of this TMDL is, SRBC collected, 604(b) report data collected during 2002 and 2003.

Pennsylvania Public Utility Commission Law Bureau Prosecutory Staff v. Promise—Net Intl., Inc. (2003.0264.00); C-20031940; A-310789

Default Order

By the Commission:

On October 17, 2003, Law Bureau Prosecutory Staff filed a Complaint against Promise—Net Intl., Inc. (Respondent), an interexchange reseller certificated at A-310789. In the Complaint, Prosecutory Staff alleged that the Commission sent by certified mail a notice to the Respondent that its 2002 Annual Report was overdue. The Complaint charged that the Respondent's failure to file its 2002 Annual Report violated 66 Pa.C.S. § 504. The Complaint sought an order from the Commission canceling the Respondent's certificate of public convenience for failure to file its 2002 Annual Report.

The Complaint was mailed by the Secretary's Bureau to Respondent's last known business address, but proof of service has not been confirmed because the Commission has on file no record of a return receipt. To date, no answer has been filed to the Complaint, and the 2002 Annual Report has never been filed. In addition, we are not aware that Respondent has any current customers in Pennsylvania, and Respondent was never assigned any NXX codes.

Since filing the Complaint, an Assessment Report form seeking a statement of operating revenues for the calendar year 2003 for use in calculating the General Assessment was sent by first class mail on February 23, 2004, to Respondent at its last known business address, and was returned as undeliverable. Telephone calls to the last known telephone number for Respondent were answered by a nonjurisdictional "800" service provider operating in the same building under a different name. A knowledgeable source with this other provider advised that Respondent is no longer in business. At this point, there is no reasonable means to reach the Respondent, and it has failed in its responsibility to notify the Commission of any address or telephone number changes.

Based on Respondent's failure to file its 2002 Annual Report and its failure to file the Assessment Report for 2003, and upon our inability to serve the Complaint and other documents upon Respondent, we conclude that revocation of Respondent's certificate of public convenience is in the public interest. The Commission puts the industry on notice that we will not hesitate to invoke our authority under the Public Utility Code to ensure timely compliance with our regulations and orders including the ordering of such other remedy as the Commission may deem appropriate. 66 Pa.C.S. §§ 504, 505, 506 and 3301. Furthermore, we may take other appropriate action, including the imposition of penalties under section 3301, in lieu of cancellation, if Respondent seeks relief from this Default Order; *Therefore*,

It Is Ordered That:

1. The allegations in the Law Bureau Prosecutory Staff's Complaint are deemed admitted and the Complaint is thereby sustained.

2. The Secretary serve a copy of this Default Order upon the Office of Consumer Advocate, the Office of Small Business Advocate, the Office of Trial Staff and the Attorney General's Bureau of Consumer Protection, and also cause a copy of this Default Order to be published in the *Pennsylvania Bulletin* with a 30-day comment period.

3. Absent the filing of adverse public comment, 30 days after publication in the *Pennsylvania Bulletin* and without further action by the Commission, the certificate of public convenience held by Promise—Net Intl. Inc. at A-310789 shall be revoked, and the company's name stricken from all active utility lists maintained by the Tariff and Annual Report Section of the Commission's Bureau of Fixed Utility Services and the Assessment Section of the Bureau of Administrative Services.
