#### **Triennial Review of Water Quality Standards**

An error occurred in the document proposing to amend 25 Pa. Code Chapter 93 (relating to water quality standards), which appeared at 38 Pa.B. 236, 248 (January 12, 2008).

The Human Health Criteria for 1,3-Dichloro-Propylene (PP NO 18V) should be .34 not 34. The Criteria Continuous Concentrations for Methylene Chloride (PP NO 22V) should be 2400 not 200.

The correct version of the criteria for these chemicals is as follows, with ellipses referring to the text of Table 5 (relating to water quality criteria for toxic substances), which appeared at 38 Pa.B. 248.

## STATE EMPLOYEES' RETIREMENT BOARD

[ 4 PA. CODE CH. 247 ] Death Benefits

The State Employees' Retirement Board (Board) proposes to amend 4 Pa. Code § 247.7 (relating to death benefits) by adding subsection (c). This new subsection states what information should be contained on a State Employees' Retirement System (SERS) nomination of beneficiary form for it to be considered valid by SERS.

The proposed amendment will go into effect upon publication in the *Pennsylvania Bulletin* as a final-form rulemaking.

#### **CHAPTER 247. BENEFITS**

§ 247.7. Death benefits.

(c) Beneficiary nomination. To be considered

valid, any nomination of beneficiary form filed by a member after \_(*Editor's Note:* The blank refers to the effective date of adoption of this proposed rulemaking.) should contain the following information, all of which should be current as of the date of the member's execution thereof:

- (1) If a natural person is designated by the member as the member's beneficiary, included with that designation should be the name of the person along with the person's date of birth and address. (A designation solely by relationship is not a valid nomination.)
- (2) If a trust is designated by the member as the member's beneficiary, included with that designation should be the name of the trust along with the names of the trustees, the date the trust was established and the addresses of the trustees.
- (3) If the member's estate is designated by the member as the member's beneficiary, included with that designation should be the names of the executors of the estate and the addresses of the executors.
- (4) If a corporation, partnership, limited liability company, business trust, other association, governmental entity (other than the Commonwealth) or foundation is designated by the member as the member's beneficiary, included with that designation should be the full name of the corporation, partnership, limited liability company, business trust, other association, governmental entity or foundation along with the full name and address of the individual at the entity who should be contacted upon the death of the member.

#### **CHAPTER 241. PRELIMINARY PROVISIONS**

#### § 241.1. Definitions.

The following words and terms, when used in this part, have the following meanings, unless the context clearly indicates otherwise:

Beneficiary—The person or persons, as defined in 1 Pa.C.S. § 1991 (relating to definitions), last designated in writing to the Board by a member to receive [his] the member's accumulated deductions or a lump sum benefit upon the death of [such] the member. [If one is not designated, the recipient shall be the estate of the member or next of kin under 20 Pa.C.S. § 3101 (relating to payments to family and funeral directors), to the extent applicable.]

## Electronic Submission of Documents and Electronic Transactions

The proposed new section authorizes the State Employees' Retirement System (SERS) to the extent authorized by a policy adopted by the Board, to allow members to submit documents or conduct benefit transactions using electronic media. The submission of documents and the

conduct of benefit transactions using electronic media must be in accordance with the act and other applicable laws of the Commonwealth.

#### E. Benefits, Costs and Compliance

**Benefits** 

The proposed rulemaking is intended to permit the Board to establish a policy whereby members of SERS may submit documents to and conduct electronic benefit transactions with SERS using electronic media. This proposed rulemaking, once it is implemented, may save both time and cost to SERS' members.

Costs

There are no costs to the Commonwealth, its citizens or State employees associated with this proposal.

Compliance Costs

The proposed rulemaking is not expected to impose any additional compliance costs.

#### **CHAPTER 241. PRELIMINARY PROVISIONS**

## § 241.2. Electronic submission of documents and electronic transactions.

- (a) The System may, in accordance with the Electronic Transactions Act (73 P. S. §§ 2260.101—2260.903), and other applicable laws of the Commonwealth, and to the extent authorized by a policy adopted by the Board, allow members to submit documents or conduct benefit transactions using electronic media.
- (b) A policy adopted by the Board may include provisions requiring a member using electronic media to:
- (1) Acknowledge that SERS will not be held responsible in the event the document submitted using electronic media is not accurately received by SERS.
- (2) Agree to hold SERS harmless in the event of any fraud, mistake or negligence, whether intentional or unintentional, in connection with filings made or transactions conducted using electronic media.
- (3) Agree to indemnify the System for any losses that may result directly or indirectly from filings made or transactions conducted using electronic media.

## TITLE 4. ADMINISTRATION PART X. STATE EMPLOYEES' RETIREMENT BOARD

#### **CHAPTER 247. BENEFITS**

#### § 247.6. Termination of annuities.

- [(a) Return to service and multiple service election. An annuity payable under the code shall be automatically discontinued if the annuitant returns to State service except as otherwise provided in section 5706 of the code (relating to termination of annuities). An annuity payable under the code shall also cease if the annuitant enters school service and elects multiple service membership within 30 days thereafter and for all periods of State and school service until there is a subsequent discontinuance thereof. No annuitant entering school service, who has failed to elect multiple service membership within 30 days thereafter, shall be eligible to elect multiple service membership.
- **(b)** *Disability annuitant.* The requirement that the subsequent annuity of a member who returns to active service, having once been on retirement, be reduced on the basis of benefits received prior to superannuation age, **[shall] does** not **[be applicable] apply** to a member who returns to active State service from a disability annuity.
